PARKS DEPARTMENT ANNOUNCES BACK BAY TREE REMOVAL HEARING

In accordance with Massachusetts General Laws Chapter 87, the Boston Parks and Recreation Department will hold a public hearing on Thursday, December 5, at 10 a.m. on a request to remove five public shade trees in Back Bay.

The hearing will be held by the City of Boston's Tree Warden (or designee) in the 3rd floor Conference Room of the Boston Parks and Recreation Department at 1010 Massachusetts Avenue, Roxbury.

The request is for the removal of five honey locust trees each measuring from 5 to 7 inches dbh (diameter at breast height) as part of the proposed Parcel 12 air rights project over the Massachusetts Turnpike and MBTA rail lines comprising most of a city block bounded by Boylston Street, Massachusetts Avenue, and Newbury Street.
