The Boston City Council's Committee on Public Safety & Criminal Justice will hold a public hearing on Thursday, June 4, 2020 at 10:00 AM. This hearing will be held virtually via Zoom.

The subjects of the hearing are:

Docket #0192, message and order authorizing the City of Boston to accept and expend the amount of One Million Seven Hundred Ninety-Four Dollars Six Hundred Eighty-Three Dollars and Forty-Seven Cents (\$1,794,683.47) in the form of a grant, for the FY20 Senator Charles E. Shannon Jr. Community Safety Initiative grant, awarded by the MA Executive Office of Public Safety and Security, to be administered by the Boston Police Department.

Docket #0408, message and order authorizing the City of Boston to accept and expend the amount of Eight Hundred Fifty Thousand Dollars (\$850,000.00) in the form of a grant for the FY20 Boston Regional Intelligence Center Earmark, awarded by the MA Executive Office of Public Safety and Security, to be administered by the Police Department.

Docket #0710, message and order authorizing the City of Boston to accept and expend the amount of Thirty Thousand Seven Hundred Twenty-Two Dollars and Ninety-One Cents (\$30,722.91) in the form of a grant for the Federal FY16 Innovations in Community Based Crime Reduction (formerly the Byrne Criminal Justice), passed through the Boston Public Health Commission, to be administered by the Police Department.

These matters were sponsored by Mayor Martin J. Walsh, and were referred to the Committee on January 29, 2020, February 26, 2020, and May 20, 2020, respectively.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

Attendance In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry
