The Boston City Council's Committee on Education will hold a public hearing on Thursday, July 30, 2020 at 10:00 AM.

The subject of the hearing is:

**Docket #0765, Order for hearing identifying restorative justice practices and the role of police in our schools.** This matter was sponsored by Councilor Mejia and was referred to the Committee on June 10, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
