### **BRJP Highlights and Concerns:**

- The project as a whole is not meeting the employment standards relative to Boston resident and female workforce participation.
- For the top 5 trades of work hours performed, none are meeting the employment standards relative to Boston resident and female workforce participation.
- 17 Boston residents have been reported so far. 6 of the 17 reported resident's residency remain unverified.
- The project's average payroll submission time is currently at an average of 12 days.

#### **RECOMMENDATIONS:**

- Subcontractors should be engaged, and a plan should be implemented as to how the Boston resident and female workforce percentages can improve.
- Workers residency should be verified as soon as they arrive on site. A 90% Boston Resident verification rate is the standard.
- Payroll submissions need to be submitted within 7 business days in order to accurately monitor subcontractor's workforce percentages.
