**Docket #0817, Order for a hearing regarding the City of Boston to accept and expend the FY20 Emergency Solutions Grant- COVID-19 supplement funds, awarded by the United States Department of Housing & Urban Development.** This matter was sponsored by Mayor Martin J. Walsh was referred to the Committee on June 24, 2020.
