The Boston City Council's Committee on Public Health will hold a public hearing on **Tuesday, December 8, 2020** at **2:00 PM**. This hearing will be held virtually.

Docket #0737, message and order for the confirmation of the appointment of Guale Valdez, as a member of the Boston Public Health Commission's Board of Health for a term expiring on January 15, 2022.

These matters were sponsored by Mayor Martin J. Walsh, and were referred to the Committee on June 3, 2020.

This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
