The Boston City Council's Committee on Government Operations will hold a public hearing on Monday, September 20, 2021 at 10:00 AM. This hearing will be held virtually via Zoom. The subjects of this hearing are: *Docket #0859*, *petition for a special law re: An Act Directing the City of Boston Police Department to Waive the Maximum Age Requirement for Police Officers for Daniel Flores*, referred to Committee on July 21, 2021; and *Docket #0562*, *petition for a special law re: An Act Providing Certain Benefits for the Widow of a Former Firefighter of the City of Boston*, referred to Committee on April 14, 2021. These matters were sponsored by Councilor Ricardo Arroyo.

NOTICE: The Boston City Council may have a quorum participating due to standing committees of the City Council consisting of both voting and non-voting members. However, members participating in this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
