The subjects of the hearing are:

Docket #0192, order for a hearing regarding using planning and land-use tools for public good.

Docket #0314, an order beginning the process of sunseting urban renewal in the City of Boston until December 31, 2022.

Docket #0192 was sponsored by Councilor Kenzie Bok and Docket #0314 was sponsored by Mayor Michelle Wu. These matters were referred to the Committee on January 26, 2022 and March 2, 2022 respectively.
