Dear friend,

The Open Space and Recreation Plan (OSRP) is an important tool for Boston to maintain and improve an open space system that promotes the health and well-being of our people, civic ideals, and environment. It is a wide-ranging document, updated every seven years, that provides a comprehensive overview and analysis of Boston's park system as well as a set of goals and a Seven-Year Action Plan that will guide the City's parks-related work heading towards 2030.

As Boston plans for and anticipates growth over the next decade, we will need to consistently work to address these needs and identify emerging needs in areas of projected growth. This version of the OSRP incorporates work that specifically focuses on expansion of the open space system through land protection and acquisition. With the wholehearted support of my administration and the public, I look forward to continued success in maintaining Boston's leadership role in preserving, improving, and maintaining open space, parks, and recreation. The OSRP will be the foundation of many forthcoming planning efforts to make Boston the greenest, most family-friendly city for all residents in the years to come.
