The Bonds will be issued to provide for the financing and/or refinancing of, and the reimbursement of funds advanced by BC Leefort Terrace LLC (the "Borrower," which term includes for purposes of this Notice any parent, subsidiary or other affiliate thereof) with respect to certain facilities owned or to be owned and operated by the Borrower (including without limitation such financing, refinancing or reimbursement of bond reserves, capitalized interest, issuance costs and associated working capital expenditures), generally consisting of the following development of affordable residential rental housing facilities: (i) the demolition of an existing eight building fifty unit "Chapter 667" state public housing development located at 1 and 2 Lee Fort Terrace, Salem, MA 01970 (the "Site"), and (ii) the construction, furnishing and equipping on the Site of a new 3 and 4 story building containing 124 units of affordable rental housing.
