**5:00PM**: Commissioner Kathleen Connor called the public hearing to order. She explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. She also briefly explained how to participate in the online hearing.

Applicant: Demetri Tsolakis Proposed Work: At front facade installation of temporary vestibule enclosure.

Project Representative: Demetri Tsolakis was the project representative.


The Commissioners reviewed a presentation consisting of photos of existing conditions, plans, and details for the proposed work.


Applicant: Keenan Brinn Proposed Work: At public sidewalk at Arlington Street replace existing city street light with DAS node.

Commissioner D Sampson left the meeting.



The Commissioners reviewed a presentation consisting of photos of the existing conditions and plans and drawings for the proposed work.

**Commissioner comments and questions:** The Commissioners discussed the history of alterations to the building as well as precedents set by alterations to surrounding buildings.

Laurie Thomas, neighbor, spoke in opposition to the proposed work. BLC Staff received one letter in opposition to the proposed work from Peter Manuelian, a neighbor at 348 Marlborough.






