#### **Background: Overdose Burden**

• 2,331 people passed away in MA in 2022 from opioid overdose, the most ever.

• 353 people died from opioid overdoses in Boston in 2022, the most ever.

Naloxone distribution is crucial for reversing overdoses.

• Fentanyl was involved in <u>93% of opioid overdoses</u> in MA in 2022 (highlighted need for fentanyl test strips).



#### **Boston OD2A Overview**

- >\$1.3M per year for 5 years
- ➤ Boston OD2A components
  - Funding substance use navigators in community health centers
  - Increasing naloxone distribution and OD rescue training
  - Expanding professional training
  - Boosting City data operations
- Prioritize individuals at increased risk of overdose:
  - Black, Latinx, experiencing homelessness, re-entry population
- Emphasis on data and community feedback. Smarter and more equitable public health



#### **Boston OD2A Goals**

- Reduce overdose burden
- Improve outcomes for Substance Use Disorder (SUD) and Opioid Use Disorder (OUD) patients
- Increase number of Persons Who Use Drug (PWUD) engaged in care and harm reduction services
- Increase capacity related to overdose prevention and access to naloxone



Expand use of data to drive prevention actions

## **OD2A Substance Use Navigators**

- 3 Community Health Centers (CHC) in the City of Boston
- Navigators will connect people to services and evidence-based medicine.
- Provide compassionate, patient-centered, and culturally competent care to engage and expand care for OD2A <u>priority populations</u>
- Partner with community and public safety settings



# **Funding Opportunity and Technical Support**

- Applicants may request up to \$150,000 per year to fund a navigator.
- Initial period of performance will be April 1, 2024, through August 31,
   2024. \*Funding extended for 4 more years, based on performance.
- Monthly learning community, where navigators and CHC admin can attend for technical support, training, and resources
- Grayken Center will provide technical assistance to CHC OBATs practice (CHCs not applying to RFP would still be eligible)
- BPHC OD2A team will support CHCs to establish referral partnerships, connect with CDC OD2A resources, data collection and evaluation, understanding and responding to emerging trends for priority populations



## **Navigator Responsibilities**

- Partner with BPHC and community agencies to set up referral pathways and market navigation
- Engage and screen patients, focusing on priority populations to identify needs
- Link patients to medical, behavioral health, and social services
- Refer patients to MOUD services
- Help address barriers to care, leveraging transportation resources
- Provide ongoing follow up to clients
- Distribute overdose prevention supplies and education
- Track and report OD2A required evaluation data with BPHC and the CDC
- Participate in required Boston OD2A onboarding activities and trainings
- BPHC urges health centers to hire bilingual and/or bicultural navigators



## **Agency Responsibilities**

- Attend monthly learning community
- (As needed) Collaborate with BPHC and Grayken Center to enhance OBAT programs
- Comply with all BPHC and CDC OD2A Fiscal and Grant conditions
- Ensure Substance Use Navigator voices are heard in organizational decisionmaking
- Evaluation
  - EHR data-sharing agreement for OD2A navigator clients
  - Participate in annual interviews for program feedback
  - Work with BPHC to monitor, adapt, and track implementation



## **Minimum Qualifications**

- ✓ Applicants must be Community Health Centers (CHCs) that reside in at least one of the following Boston neighborhoods: Dorchester, Roxbury, South End, East Boston, and Mattapan.
- ✓ BPHC will accept only one application per community health center.
- ✓ See RFP for more details on qualifications and scoring.

- Proposal narrative (questions 6-10 and 12) is a 10-page limit

\*Budgets, budget narrative, resumes and other required forms do not count towards page limit



## **Budgeting**

- > Please note the total amount of funding requested. Applicants may request up to \$150,000.
- > Submit a detailed, itemized budget for period of performance, including costs specific to activities and deliverables within the scope of service.
- In addition to the line-item breakdown, please provide a narrative budget justification for each budget line. (keep to about 500 words)
- The maximum allowable Indirect Costs Rate, or overhead costs rate, is 10% of Modified Total Direct Costs unless your organization has a Federally Negotiated Rate Agreement. If your organization has one, please submit it with your application.
