#### LICENSE AGREEMENT/LEASE/MEMORANDUM OF AGREEMENT/EASEMENT

- 2. Request authorization to amend the Lease Agreement with Droplette, Inc., remove Suite #503 from the Lease Premise at 12 Channel Street in the Raymond L. Flynn Marine Park, extend the lease term to March 31, 2028, and settle outstanding debt.
- 3. Request authorization to execute a Memorandum of Agreement with the City of Boston, acting by and through its Department of Public Works, authorizing the use and payment for fuel and services provided by the Fleet Maintenance Unit for the period from July 1, 2024, through June 30, 2025, at a total cost not to exceed \$250,000.
