PH 1. On a joint petition by the City of Boston Public Works Department and the Massachusetts Bay Transportation Authority for the **Discontinuance** of any and all rights to travel the public may have had within the entirety of **Jones Avenue Footway** (public way), Dorchester, located between Ballou Avenue and Norfolk Street.

 - Walter Street generally at Bussey Street;
 - South Street generally at Bussey Street.
