HM 1. At the request of the Public Improvement Commission staff, the **Acceptance of the Minutes** of the PIC hearing held on **April 25, 2024**.

Public Hearing

PH 1. On a petition by FPG LaGrange Owner One LLC for the acceptance of a **Pedestrian Easement** adjacent to the following public ways in Boston Proper:

- **La Grange Street** – on its northerly side generally at address nos. 47-55, east of Tamworth Street;
- **Tamworth Street** – on its easterly side between La Grange Street and Lowell Court.

PH 2. On a petition by FPG LaGrange Owner One LLC for the making of **Specific Repairs** within the following public ways in Boston Proper:

- **La Grange Street** – generally at address nos. 47-55, from Tremont Street to a point east of Tamworth Street;
- **Tamworth Street** – generally between La Grange Street and Boylston Street;
- **Tremont Street** – at La Grange Street;
- **Boylston Street** – at Tamworth Street.

PH 3. On a petition by Rina Enterprises Inc. for the making of **Specific Repairs** within **Dudley Street** (public way), Roxbury, located on its northerly side at address no. 190, generally west of Winslow Street.

PH 4. On a petition by Holocaust Legacy Foundation for the **Vertical Discontinuance** of portions of **Tremont Street** (public way), Boston Proper, located on its southeasterly side at address no. 125 southwest of Hamilton Place, vertically above the grade of the sidewalk.
