The Boston City Council's Committee on Post-Audit: Government Accountability, Transparency and Accessibility will hold a hearing on **Wednesday, May 29, 2024 at 10:00 am**. This hearing will be held virtually.

The subject of the hearing is:

***Docket #0556, Order for a hearing on government accountability, transparency, and accessibility of decision making protocols in city government.***

This matter was sponsored by Councilor Julia Mejia, and referred to the Committee on January 24, 2024.

**Attendance** In accordance with Chapter 2 of the Acts of 2023, modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually.
