





Priority Setting Ground Rules

- Rank all categories in numerical order from most important to least important (for paper version). So, designating a "1" ranking means you think that category is the most important; a "28" is the least important.
- USE YOUR RESOURCES: Utilize the best available, accurate, and detailed information
 to identify service gaps/emerging needs and determine how to best use Part A funds
 to fill gaps in care. The responsibility of the Council is to make recommendations as to
 Part A resources can be used, and incompleteness of data should not be used as a
 justification for not deciding.
- If you have any questions throughout this exercise, PCS will be here to assist you.
- This is NOT group work and rankings will be determined by you.
- Your responses should be confidential so please do not share your responses with anyone else and do not put your name on your ballot.
- Results are final and no changes can be made once submitted.

Once all ballots are turned in, PCS will take the average of all members' votes and present the results for a final vote on April 11th.

- Yvette Perron, NH DHHS
 - o The New Hampshire Prevention and CARE Program's Integrated HIV Plan includes developing four new sub-workgroups under the HIV Planning Group. The workgroups are Diagnose, Prevent, Treat, and Respond. Recruitment for these workgroups have begun. There will be a social media campaign starting March 18th. Flyers went out to all NH CARE clients who approve to receive mail. As of March 15, there were 28 people have filled out the interest form.
- Tegan Evans, BPHC RWSD
 - O Sarah Kuruvilla will be transitioning from full-time to casual status in her role as Senior Program Manager of CQM at the end of the month. She will be moving on to a quality role at another HIV program in NYC.
 - The CQM team is also happy to welcome Tzuria Falkenberg. Tzuria started this Monday, March 11th as their new Senior Program Coordinator of Quality Improvement. They also have an accepted offer for a Senior Program Coordinator of Performance Measurement role, aiming for a late April start date.

- PCS updated us on the current response rate to the AAM. They will send out 2 more reminders and it is due March 28th.
- We voted on the final service standard edit: 3.7 Refusal of Services Policies and Procedures to add "Provider has policies and procedures in place for clients who have been or who refused a service along with appropriate documentation thereof", with 15 approvals and 1 opposition.
- We reviewed all of the service categories by playing a trivia game. PCS put us in breakout groups and then we answered trivia questions about different service categories.
- We did a final overview of the priority setting process and continued to answer any questions.
