Utility Pole Hearing Continued

UPC 1. On a petition by Eversource Energy for a **Utility Pole Installation** to install one new private utility anchor guy within **Carolina Avenue**, West Roxbury, to be located on its southerly side at address no. 111, west of Carolina Place. (*UP 5/23/2024*)

UPC 2. On a petition by Verizon New England Inc. for a **Utility Pole Installation** to install three new private utility poles within the following public ways in Roxbury: (UP 5/23/2024)

- Schuyler Street on its northeasterly side at address nos. 9-11; as well as on its southwesterly side at address nos. 16-18;
- Hartwell Street on its southeasterly side at address nos. 42.
