He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing.

Following this brief introduction he called the first design review application.

Proposed work: Remove the old deck and rubber roof and install a new rubber roof and deck. Previously reviewed at the July 5, 2023 hearing.
