Location Sullivan Square

- We are seeking Charlestown Cannabis to be located at 31 Cambridge Street Unit 1, directly in the Sullivan Square area of Boston/Charlestown. We will provide 8 parking spots to customers on site. The store will occupy the ground floor of the existing building. As a longtime homeowner and resident of Charlestown, and as an active member of the community soliciting feedback from residents, this particular section of Charlestown seemed best suited for a cannabis establishment.
- This particular space is vacant and was once occupied as a restaurant bistro called R Wesley's. It meets standards for a cannabis establishment, and is not close in any manner, to schools, recovery centers or mental health facilities. Additionally, this particular area in Sullivan Square is not a dense residential area and is prime for a retail cannabis dispensary and will meet an unserved need for the community of Charlestown.
- Charlestown Cannabis will not impact the community as a result of its location.
- community has overwhelmingly voiced their consistent support for a cannabis store/Charlestown Cannabis to be located at 31 Cambridge street.
- This location is on the door-step of the Sullivan Square Orange line stop. We see this location as an important opportunity to have retail stores accessible by public transportation and as part of the long-term goals for: PLANNED Charlestown.
- Sullivan Square is an area rich in transportation options including the MBTA aforementioned Orange Line, MBTA bus routes, local bike facilities including bike share and bike lanes, robust pedestrian infrastructure with sidewalks and signalized crossings surrounding the site, and publicly accessible, paid parking.
- The abutting City of Somerville is located to the Northwest; the City of Everett is just across the nearby Mystic River; and most of the area is accessible by the MBTA Orange Line, only 600 feet from the Project Site.

SAFETY, AND SECURITY

- Charlestown native Stephen Fabiano as its Director of Security. Stephen is a veteran and retired Boston Police Officer. He is a Charlestown /City of Boston homeowner that resides in Charlestown with his family. As part of his duties, he will help institute staffing for security and implement our security measures. At all times, we will have at least one person on the premises for security personnel.
- We will have a door interlock system that consists of an exterior and interior door at entry and exit points of the dispensary; from a vestibule which will be configured similar to a mantrap to ensure authorized persons entering or exiting cannot allow an unauthorized person into the dispensary Sales Floor. The interlocked doors are controlled such that only one vestibule door can be opened at a given time. Doors are logically controlled by a controller located in the Security Room. Door release buttons are provided at the reception desk for the entry doors to allow authorized persons to enter the Entry Vestibule, and once verified, will be allowed to enter the Sales Floor.
- Our plan for transportation and delivery of products is as follows: Charlestown Cannabis will only accept deliveries from production facilities at pre-arranged days and times and only when a proper shipping manifest has been sent from the production facility to Charlestown Cannabis at least 24 hours before the delivery.
- Only scheduled deliveries will be allowed. When a scheduled delivery vehicle arrives, the driver will contact dispensary and security personnel to meet them at the entrance. The security team will assess the area to determine if there are any security concerns. The driver will remain secure in the vehicle until security and dispensary personnel arrive. Finished products will be secured in locked cases until they are secured in the LAA. Security personnel will monitor the delivery and activity in the surrounding area and street.
- Charlestown Cannabis will ensure that underage and our youth and kids in school are protected. As part of our partnership with Turn It Around, we will employ youth of the community to help prevent misuse and best practices for reporting misuse of our products. Additionally, we will regularly meet with staff at all of our community schools, both public and private to prevent any potential harm. Specifically, we will use best practices and collaborate with Boston Public Schools such as Warren Prescott and Harvard Kent to help us educate kids and parents on potential misuse of our cannabis products.
- Jack Kelly as owner, commits to direct communication with aforementioned stakeholders to uphold the highest safety practices on a consistent basis. Charlestown Cannabis will share our security plan and procedures with the Boston Police and Boston Fire Department. We will periodically update them as needed if the plans or procedures are modified in a material way.

LANDLORD INFORMATION

- The owner of our building is Rize Construction. We have a Letter of Intent form our landlord that has a ten year lease term. The lease will begin conditional upon opening. We will pay \$4,000 monthly in rent.
