COMMITTEE HEARING NOTICE

October 15, 2024

The Boston City Council's Committee on Housing and Community Development will hold a public hearing on Friday, October 18, 2024 at 10:00am. This hearing will be held virtually.

The subject of the hearing is:

Docket #1165, Message and order authorizing the City of Boston to accept and expend the amount of Seventy-Five Million Dollars (\$75,000,000.00) in the form of a grant, for the Commonwealth Builder Program, awarded by the Massachusetts Housing Finance Agency to be administered by the Mayor's Office of Housing. The grant will fund the creation of workforce homeownership housing units and the long-term availability of those units to eligible moderate-income households.

This matter was sponsored by Mayor Michelle Wu and referred to the Committee on August 7, 2024.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
