REVISED COMMITTEE HEARING NOTICE

November 27, 2024

The Boston City Council's Committee on Ways and Means will hold a hearing on **Tuesday, December 3, 2024 at 10:00 am** in the **Iannella Chamber, 5th Floor, Boston City Hall.** This hearing was previously on Dockets #0479 and #0999; it will now be on Dockets #0999, #1211, and #1715.

The subjects of the hearing are:

Docket #0999, Order for a hearing to discuss ways to diversify the City of Boston's revenue.

Docket #1211, Order for a hearing for the Boston City Council to address next steps after the Failed Property Tax Reclassification Home Rule Petition Through Audit.

Docket #1715, Order relative to the adoption of Tax Classification in the City of Boston in FY 2025.
