Docket #0414, Order for a hearing to audit the implementation and effectiveness of the 2014 Boston Trust Act.

This matter was sponsored by Councilors Julia Mejia, Ruthzee Louijeune, and Enrique Pepén, and was referred to the Committee on February 5, 2025.

Docket #0128, Communication was received from the Police Commissioner Michael A. Cox in accordance with Section 3 of the Boston Trust Act regarding civil immigration detainer results for calendar year 2024.

This matter was a Report of a Public Officer, and was referred to the Committee on January 8, 2025.
