Enclosed is the PILOT community benefits report for Longwood Collective (formerly MASCO) which details the programs and services carried out in service to the Longwood Medical and Academic Area (LMA) during the Fiscal Year 2023 period of July 1, 2022 through June 30, 2023.

These programs and services support the area's world-renowned organizations and the people who live, work, study, or receive care in the LMA. Institutions in the LMA are drivers of the local economy, employing 68,000 people, educating 27,000 students, and treating 2.8 million patients each year. In fact, one out of every 10 people who work in the City of Boston works in the LMA.

Altogether, these services and activities total \$546,097 and all dollar amounts detailed in the report are for actual expenses. The report includes supplemental information on the work Longwood Collective staff performed as an in-kind service to the district.

In addition, Longwood Collective has historically made contributions to community organizations for which we receive credit against our PILOT payment. In FY23 Longwood Collective donated \$25,000 to the Fenway CDC.

Transportation Management Association (Longwood Collective TMA)	Purpose: Reducing Congestion, Greenhouse Gases, Supporting the MBTA, walking, biking, and carpooling FY23 saw continued lower than usual commuting levels due to the pandemic. As employees are increasingly moving back to the workplace, participation in these programs has seen a steady increase. These programs support the City's goals of reducing Vehicle Miles Traveled (VMT) and Greenhouse Gas Emissions and include:  • GoMassCommute: Registered 968 employees in our GoMassCommute online commuting network.  Employees have recorded 24,000 alternative trips and resulted in 95,000 miles taken in an alternative to a drive-alone car commute.  • Emergency Ride Home: Registered 350 new people in our Emergency Ride Home program and provided 39 rides from work to home in the event of illness/ emergency for program participants.  • Free Bicycle Tune Ups: Sponsored 15 bicycle tune up events serving 500 commuters from across the district. Hosted two Electric Bike Demo events and engaged 60 commuters  • DEP Reporting: Assisted in completing 9-member institution DEP rideshare reports; summarizing area-wide commuter program participation and transportation projects.  • CommuteFit: Registered 385 new participants in the alternative commute program, CommuteFit.  • Walk/Bike Challenge: Ran a special National Bike Month challenge in May that resulted in 2,800 walking and biking miles as part of trips to work.	\$49,322	Both (A)	Ongoing	LMA/Boston commuters	Longwood Collective	City-wide, Fenway/Longwood	Built Environment

Fenway Transportation Action Plan  Improving Transportation Action Plan  Improving Transportation Infrastructure  • Longwood Avenue Bridge Biking Improvements: Longwood Collective developed a concept plan to restripe the Longwood Avenue bridge to add bicycle infrastructure and close a critical gap in the regional bicycle network serving the Longwood district and surrounding neighborhoods. The proposal maintains the existing number of vehicular travel lanes on both sides of Longwood Avenue, while adding a continuous bicycle lane along the eastbound curb (i.e., the direction heading towards Longwood) and a bicycle lane/sharrow combination in the westbound direction (i.e., the direction heading towards Tomyon of Brookline). The bridge is a critical pinch point in the busiest bike corridor in Longwood carrying +1,000 cyclists daily, but still lacks any bicycle infrastructure. Area Planning and Development staff are currently working closely with the Town of Brookline, MassDOT, Department of Conservation, and City of Boston to finalize the plan and bring it to fruition.  • Oscar Tugo Circle Pedestrian Improvements: Evaluating power source alternatives for the rectangular rapid flashing beacons (RRFBs) located at the intersection of Avenue Louis Pasteur and Longwood Avenue. Open Space/Beautification Programs	Coustaide/ Is an annual six-month summer placemaking partnership between the Longwood Collective and four major hospitals (BCH, BWH, BIDMC, DFCT), who permit their plazas to be used as public spaces with programs accessible to patients, visitors, employees, and the public. Longwood Collective provides outdoor furniture and other assets and manages a hospitality contract with vendor Block by Block. The Longwood Collective also plans, implements, and organizes programs including live music, games, public art, dog adoption, filtense classes, and a monthly music restival to foster community, improve quality of filter for essential workers, students, and visitors; and create a unique neighborhood identity for the Longwood area.
