
Proposed Work: Construct a new building and park. Continued from the 6/27/2024 HPACDC Hearing.

**Project Representative:** Nick Landry, Mary Kate Campbell, Tony Barros, and Rob DiPierro were the project representatives.


**Documents Presented:** The Commissioners reviewed a presentation consisting of photos of existing conditions, plans, and preliminary drawings for the proposed work.
