Utility Pole Hearing

UP 1. On a petition by Verizon for a **Utility Pole Installation** to install one new private utility pole with a guy wire attachment within **Nazing Street**, Roxbury, to be located on its northeasterly side at address no. 35, generally between Blue Hill Avenue and Maple Street.
