The Boston City Council's Committee on Ways and Means will hold a hearing on Thursday, October 2, 2025, at 2:00 pm in the Iannella Chamber, 5th Floor, Boston City Hall.

The subject of the hearing is:

Docket #1690, Message and order for your approval an Order authorizing the City of Boston to appropriate the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000.00) for the purpose of paying the cost of a feasibility study and schematic design associated with a project for the Ruth Batson Academy, formerly known as the John W. McCormick School, located at 315 Mount Vernon Street, Dorchester, MA 02125. This includes the payment of all costs incidental or related thereto, and for which the City of Boston may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the Public Facilities Department on behalf of the Boston Public Schools.

This matter was sponsored by Mayor Michelle Wu, and was referred to the Committee on September 24, 2025.
