- Disability-owned (DOBE)
- Lesbian Gay Bisexual Transgender-owned (LGBTBE)
- Non-Profit

The following table details the type of NPO certification you may pursue, based on the makeup of the NPO's Board of Directors and Voting Membership.

If the majority of your Board and Voting Membership is:	You may apply for:
Minority Only (Minority Women and Men Combined)	M/NPO
Women Only (Non-Minority and Minority Women Combined)	W/NPO
Minority Women Only	M/W/NPO
Veterans Only (Veteran Women and Men Combined)	V/NPO
Veteran Minority Only (Veteran Minority Women and Minority Men Combined)	V/M/W/NPO
Veteran Women Only (Veteran Non-Minority and Minority Women Combined)	V/W/NPO
