
Introduction and Meeting Minutes

Chair Anthony Fugate opened the public session to approve the public session minutes from the IAOP meeting held on June 17, 2025. The panel unanimously approved the draft public session minutes as official minutes.

Executive Director's Report

Executive Director Evandro C. Carvalho provided an overview of OPAT operations, including the following:

Director Carvalho also gave a high-level summary of the Civilian Review Board's [September 11th letter to Commissioner Cox](#) and the procedural workflow associated with communications to the BPD Commissioner.

Director Carvalho then yielded the floor to the Chair for policy discussion.

Policy Discussion

The board discussed the following policy items:

- Updates regarding the CRB and CRB Policy Subcommittee
- Review of the CRB Letter concerning communication cadence, response timelines, and procedural expectations between BPD and OPAT
- Considerations for strengthening policy mechanisms under the ordinance

Director Carvalho addressed the BPD Commissioner's recent response patterns and the board discussed appropriate processes and regulations to ensure timely correspondence moving forward.

Additional discussion addressed potential adjustments to the automatic or random appeals process and opportunities to improve execution of ordinance requirements.

The Board voted unanimously to send a letter to BPD Commissioner Cox requesting that per ordinance Section 12-16.15(a)(i), BPD begin referring all categories of automatic case referrals to the Board, including the following:

- a. In-custody death or serious bodily injury while in Boston Police Department custody;
- b. Use of force cases resulting in death or serious bodily injury;
- c. Allegations of excessive use of force;
- d. Allegations of unlawful arrest or stop;
- e. Allegations of perjury;
- f. Allegations of theft;
- g. Allegations of abuse of authority;
- h. Allegations that the conduct of an officer violated BPD policies regarding the respectful treatment of people, including the Bias Free Policing policy, and/or that was motivated by discriminatory intent, including, but not limited to, slurs relating to race, expression, sexual orientation, and disability,”

The board entered the Executive Session.


