The Boston City Council's Committee on Ways and Means will hold a public hearing on Tuesday, June 27, 2017 at 10:00AM in the Iannella Chamber, 5th floor, Boston City Hall.

The subject of the hearing is:

- 0908 Message and order for Annual Appropriation and Tax Order for FY2018.
- 0909 Message and order for Annual Appropriation for the School Department for FY2018.
- 0910 Message and order approving an appropriation of Forty Million Dollars (\$40,000,000.00) to the Other Post-Employment Benefits (OPEB) Liability Trust Fund established under Section 20 of Massachusetts General Law Chapter 32B.
- 0911 Message and order authorizing the City of Boston to appropriate the amount of One Million Dollars (\$1,000,000.00) from the City's Capital Grant Fund in order to increase Boston's Vision Zero capital program investment in Fiscal Year 2018 (FY18) to \$4.1 million. This funding which will expand our Neighborhood Slow Streets program is part of the City's comprehensive investment in street safety.

These matters were sponsored by the Mayor, and referred to the Committee on June 21, 2017.
