THE ASSESSING DEPARTMENT IS RESPONSIBLE FOR DETERMINING THE TAXABLE VALUE FOR ALL REAL ESTATE IN THE ECONOMY.

CHALLENGES THE DEPARTMENT IS FACING IS KEEPING UP WITH AN ACC

OUESTIONS.

AT THIS TIME REAL ESTATE MARKET. THIS IS NEEDED FOR US TO ACHIEVE DEPARTMENT OF REVENUE CERTIFICATIONS AND MIDDLE OUT THE THIRD QUARTER BILLS THAT GO OUT IN JANUARY.

THE DEPARTMENT IS IN THE PROCESS OF A CAMA CONVERSION SYSTEM. THAT HELPS US DETERMINE PROPERTY VALUES.

THE DEPARTMENT CONTINUES TO WORK ON IMPROVING THE ACCURACY OF OUR ASSESSMENTS, THE FY-18 ABATEMENTS ARE AT AN ALL-TIME LOW.

IT CARRIES OVER TO APPEALS NUMBERS, WHICH IS HELPFUL FOR FREEING MONEY FOR THE OVERLAY ACCOUNT.

I THINK THE LAST REPORT THAT WE REFERENCED IN PREPARING FOR TODAY'S HEARING REFERENCED 2007 VALUES FOR MOST OF THE COLLEGES AND THE UNIVERSITIES.
2007 VALUE WAS \$7 FOR COLLEGES AND UNIVERSITIES AND FOR HOSPITALS IT WAS ABOUT \$6 BILLION.

IN THE 2017 PILOT ANALYSIS, THE DOLLAR AMOUNTS ARE BASICALLY THE SAME

MY LAST QUESTION IS ON SHORT TERM RENTALS.

WE HAVE -- THAT'S A CONVERSATION

THAT CONTINUES HERE.

THE MAYOR CONTINUES TO TALK

ABOUT POLICY.

WE HAVE A LOT OF UNITS ACROSS THE CITY THAT ARE NOT OWNER OCCUPIED THAT ARE USE AS SHORT TERM RENTAL OPPORTUNITIES.

DO WE EVER LOOK TO TAX THEM AT A COMMERCIAL RATE AS OPPOSED TO A RESIDENTIAL RATE?

>> I HAVE SAT IN ON MEETINGS WITH THE MAYOR'S OFFICE ABOUT THAT.

LEGALLY WE COULDN'T DO THAT RIGHT NOW.

THOSE ARE RESIDENTIAL PROPERTIES.

IT'S DIFFICULT FOR US TO TRACK HOW OFTEN SOMEONE IS RENTING SOMETHING, HOW MUCH THEY ARE RENTING SOMETHING.

I KNOW WHEN I HAVE DONE SOME PRELIMINARY LOOKINGS, A LOT OF TIMES THE ADDRESSES ARE NOT LISTED.

SOMETIMES WE FIND THEM BY NEIGHBORS COMPLAINTS, WHICH I'M SURE YOU'VE HEARD ALSO.

- I WAS WONDERING IF YOU COULD TELL ME WHAT THE CITY ALREADY OFFERS IN TERMS OF TAX FOR OUR SENIORS.
- >> I CAN.
- SO WE HAVE THE 41 C, WHICH IS ONE OF THE PERSONAL EXEMPTIONS FOR SENIORS.
- THIS IS FOR SENIORS THAT REACH THE AGE OF 65.
- THIS IS INCOME AND AN ASSET REQUIREMENT.

WE ALSO HAVE --

- >> WHAT IS THAT INCOME?
- >> ON THIS GROSS INCOME, NOT EXCEEDING \$24,523.
- A SINGLE INCOME NOT EXCEEDING \$36,785.
- IF MARRIED, WHOLE STATE, NOT --THIS IS EXCLUDING THE VALUE OF THE PROPERTY NOT TO EXCEED \$40,000 IF SINGLE OR \$55,000 IF MARRIED.
- AND FOR THE COUPLE, WHAT WAS THE GROSS AGAIN?

>> \$36,785.

>> IS THERE ANY THOUGHT TO UPPING THAT AMOUNT SO THAT MORE FOLKS COULD QUALIFY FOR THE RELIEF?

>> SO THAT'S SOMETHING THAT IS SET BY THE STATE.

SOMETHING THAT WE WOULD HAVE TO GO TO THE LEGISLATURE TO LOOK TO HAVE CHANGED.

I KNOW LAST YEAR IN REVIEWING THE TAPES, WE TALK ABOUT TAKING INTO CONSIDERATION INFLATION, WHICH IS A GREAT ARGUMENT AND CERTAINLY A WAY THAT THAT CAN BE MOVED.

SO SOMETHING THAT I WANT TO LOOK INTO BASED ON THE CONVERSATION FROM LAST YEAR.

- THE AVERAGE SINGLE FAMILY PROPERTY TAX BILL REMAINS LOW AT \$3,324.
- CERTAINLY COMPETITIVE WITH THE SURROUNDING TOWNS TO BOSTON.
- >> I THINK WE'RE PROBABLY IN THE LOWER END, LIKE LOWER 6/10, TENTH PERCENTILE OR SOMETHING. >> YEAH.

THAT IS THE ENTITIES THAT ARE

>> OKAY.

GREAT.

MAKE ANNUAL APPROPRIATIONS FROM THE FUND AND WILL DEEM AS NECESSARY FROM THE COMMUNITY PRESERVATION COMMITTEE. THESE APPROPRIATIONS WILL NOT EXCEED 5% OF THE FUNDS ANNUAL REVENUE.

TODAY WE'RE ASKING THAT YOU REVIEW AN ORDER WITH TWO COMPONENTS.

ONE IS FOR THE ADMINISTRATIVE BUDGET AND THE SECOND IS FOR THE APPROPRIATED RESERVE.

THE APPROPRIATED RESERVE WILL PUT FUNDING INTO THE COMMUNITY PRESERVATION FUND SO THAT WHEN PROJECTS ARE APPROACHED WHO WILL RETURN TO THE COUNCIL AND ASK THAT THE COUNCIL VOTES TO APPROVE THOSE PROJECTS.

AND AS I MENTIONED, TALK ABOUT WHERE WE ARE IN THE PROCESS AND THE FIRST ROUND OF FUNDING THAT WE ANTICIPATE, WHICH WE ANTICIPATE THE CPCC WILL VOTE ON IN JUNE AND RETURN TO ACTUAL A PRONITION OF INDIVIDUAL PROJECTS, THIS IS TO FEED THE RESERVES SO THE FUNDING IS AVAILABLE FOR FY-19.

WITH THAT, I'LL TURN IT OVER TO CHRISTINE AND TALK ABOUT THE BUDGET.

I'VE WORKED WITH ALL OF YOU.
FROM THE FORUMS AND LETTING
PEOPLE KNOW ACROSS THE CITY AND

AND HOW TO APPLY.

WE'VE BEEN SUPPORTING ORGANIZATIONS AND GROUPS AND THE APPLICATION PROCESS.

WHAT WE'RE DOING, SORT OF HOW IT'S ROLLING OUT AND HOW WE INITIATED.

THE COMMITTEE DECIDED TO DO A PILOT PROGRAM THIS SPRING.
A SMALL BUCKET OF FUNDING THAT WILL GO OUT TO PROJECTS THAT ARE SHOVEL-READY, READY TO GO INTO THE GROUND THIS SUMMER AND REQUIRE \$500,000 OR LESS TO

GET -- TO FINISH A PROJECT.

WE HAVE -- THE DEADLINE IS THIS COMING FRIDAY.

WE TALKED TO WELL OVER 50 GROUPS AND PROJECTS.

WE DON'T KNOW IF THEY'RE ALL COME FRIDAY.

AND IF ALL OF THEM ARE QUITE READY.

BUT IT'S EXCITING TO THINK THAT WE COULD HAVE SOME RIBBON CUTTINGS AS EARLY AS SEPTEMBER. I THINK THAT'S -- SHOULD I -- I COULD WALK THROUGH THE BUDGET IS.

THAT HELPFUL?

>> NO.

THAT'S OKAY.

WE'LL OPEN IT UP TO QUESTIONS. THANK YOU.

THE MATCH PART, I THINK WE ALL ANTICIPATED THAT IT WASN'T GOING TO BE AS ROBUST AS IN YEARS PASSED.

IF I RECALL CORRECTLY, WE KIND OF ALWAYS ESTIMATED THAT WE WOULD BE GETTING \$20 MILLION. BUT IT SEEMED TO BE MORE IN THE REALM OF LIKE, YOU KNOW, \$50 MILLION FROM THE CITY AND \$5 MILLION.

LOOKS LIKE WE'RE BARELY GETTING HALF OF THAT FOR A MATCH.

>> YEAH, IF YOU WANT ME TO -I'VE BEEN FOLLOWING THE STATE
MATCH OBVIOUSLY CLOSELY.

WHAT HAS HAPPENED IS MORE AND MORE -- 174 CITIES AND TOWNS ACROSS THE STATE HAVE PASSED CPA IN THEIR CITY OR TOWN.

BOSTON AND SPRINGFIELD PASSED IT AT THE SAME TIME.

ADDING TWO BIG CITIES LIKE THAT MEANS THAT THE MATCH IS A STATIC AMOUNT.

IT DOESN'T CHANGE.

THERE'S NO -- DOESN'T GO UP EVERY YEAR BASED ON INFLATION OR COST OF LIVING OR ANY OF THOSE THINGS. IT'S -- THE \$20 FILED EVERY TIME PROPERTY CHANGES HANDS IN THE STATE.

BECAUSE THAT HAS NOT CHANGED, THE STATIC AMOUNT OF MONEY GOES DOWN AS MORE AND MORE TOWNS AND CITIES ARE ASKING FOR THE MATCH. A LOT OF LEGISLATIVE WORK TO INCREASE THE \$20 FEE THAT IS PAID.

AND IT HAS NOT HAPPENED YET. THERE WAS AN AMENDMENT IN THE BUDGET THAT WAS PROPOSED BY ONE OF THE BOSTON DELEGATES THIS TIME AROUND.

I THINK IT WAS WITHDRAWN. SO YOU KNOW, WE HOPE AT SOME POINT THAT THAT WILL CHANGE. THE GOAL IS TO GET EVERYBODY'S MATCH UP TO 30% FROM 11.5. >> OKAY.

>> WE ASK THAT OBVIOUSLY HAVING THE CPA FUNDED ON THE CITY SIDE AS A SURCHARGE RELATED TO PROPERTY TAXES GIVES US MORE INSIGHT AND CERTAINTY AROUND WHAT THE CITY PORTION IS. GIVEN THE FACT THAT, YOU KNOW, OVER RECENT HISTORY, STATE FUNDING HAS COME FROM CONSOLIDATION AND HAS CREATED UNCERTAINTY WHAT THE MATCH WILL

>> TO SPEAK TO THE LEGISLATION THAT CHRISTINE IS TALKING ABOUT. THERE'S AN EFFORT BY, I BELIEVE, COUNCILLOR EDWARDS TO HELP SUPPORT THAT EFFORT, TO INCREASE WHAT CHANGED THE FORMULA BY WHICH WE ADD TO THE CPA FUNDING. SO WITH THAT, LET ME RECOGNIZE COUNCILLOR ESSAIBI-GEORGE. >> I'M OKAY WITH QUESTIONS.

>> WELL, LET ME JUST SAY, THIS HAS BEEN A REALLY GOOD MONTH PREPARING FOR THE FIRST ROUND OF APPLICATIONS.

I'M HAPPEN TO BE HERE.

TO MY NEIGHBOR, CONGRATULATIONS ON A GREAT JOB YOU'VE DONE WITH YOUR TIME.

OBVIOUSLY DELIGHTED THAT WE'RE AT THIS POINT AND KUDOS TO THE COUNCIL PRESIDENT AND COUNCILLOR FLAHERTY FOR THEIR GREAT EFFORTS IN GETTING THIS ON THE BALLOT AND PASSED.

SO ARE YOU FULLY STAFFED AS OF NOW, CHRISTINE?

- >> WE ARE FOR THE PRESENT.
- >> HOW BIG IS YOUR STAFF?
- >> THREE PEOPLE.
- >> AND THE OTHER POSITIONS?
- >> ONE IS OPERATIONS MANAGER.

WE HOPE THE COMMUNITY WILL BE HAPPY BECAUSE THEY'LL START TO SEE SOME PROJECTS.

IN THE BUDGET THERE'S ROOM NOR ADDITIONAL STAFF IF NEEDED.

>> GOOD.

YOU ALSO HAVE -- YOU'RE CONTRACTED SERVICES HAVE INCREASED.

WHICH SERVICES DO YOU CONTRACT? >> WE HAD ANTICIPATED THAT WE MAY NEED TO CONTRACT FOR LANGUAGE INTERPRETATION, COMMUNITY WORK.

>> ALL FOR THESE MEETINGS.

>> RIGHT.

FOR FORUMS AND ENGAGEMENT AND SUPPORT OF GROUPS APPLYING FOR PROJECTS.

THAT WAS ONE OF THE CONTRACTED PIECES.

AND THEN THE OTHER PIECE WAS A LOT OF COMMUNITY GROUPS HAVE COME TO US WITH IDEAS, BUT

REALLY DON'T KNOW HOW TO IMPLEMENT.

WE HAVE MONEY FOR A LANDSCAPE ARCHITECT, FOR AFFORDABLE HOUSING DEVELOPER CONSULTANT THAT CAN WORK WITH A GROUP TO HELP THEM PUT TOGETHER A PACKAGE AND IDENTIFY WHO THEY SHOULD BE WORKING WITH TO MAKE THAT HAPPEN, IF A PARKS -- IF IT'S CITY LAND, COULD BE THE PARKS DEPARTMENT, ET CETERA. VOLUNTEERS.

>> ALL VOLUNTEERS.

THANK YOU.

IT SAYS IN THESE -- IN THIS PACKET THAT THE BUDGET WAS 3%, 3.46% OF TOTAL REVENUE. IS THAT ON PAR WITH OTHER MUNICIPALITIES?

>> MOST MUNICIPALITIES USE THE FULL 5%.

>> REALLY?

>> BUT THEY HAVE A SMALLER AMOUNT OF MONEY THAT THEY TAKE IN.

AND THEY NEED SOME COMPARABLE STAFFING.

BOSTON IS MUCH BIGGER THAN ANYWHERE ELSE, INCLUDING SPRINGFIELD.

>> DO YOU ANY CITIES OR TOWNS HAVE STAFFS BIGGER THAN THREE?

>> FINALLY JUST WANT TO ECHO THE POINT.

WITH 174 CITIES AND TOWNS NOW PARTICIPATING IN CPA, THAT'S

LOOKS TO ME UNLESS WE HAVE SOME REFORM AT THE STATE LEVEL, WE'RE AT TIPPING POINT WHERE IT'S NO LONGER AS AN EFFECTIVE TOOL FOR CITIES AND TOWNS THE USE.

>> RIGHT.

I MEAN, NO ONE WILL SNEEZE AT

\$20 MILLION FOR THESE IMPORTANT PROJECTS.

IT'S INCREDIBLY MEANINGFUL. IT'S HARD TO SAY IT'S -- THE MATCH MAKING NO SO EFFECTIVE. >> YEAH.

>> BUT THE FUND IS GOING TO MAKE A HUGE DIFFERENCE IN BOSTON.

>> I AGREE.

I TEMPER MY REMARKS.

THIS PASSED SO OVERWHELMINGLY WHEN 17 OR 16 YEARS EARLIER IT FAILED AT THE BALLOT BOX IS A --IS A SUCCESSFUL CAMPAIGN TO EXPLAIN WHY THIS WORKS AND THE FACT THAT WE WERE SENDING MONEY TO THE STATE THAT WE WEREN'T SEEING.

I'D ASSOCIATE MYSELF WITH REMARKS FROM OTHERS TO DO WHAT WE CAN TO FIX IT AT THE STATE LEVEL TO MAKE SURE THAT WE HAVE MORE MONEY COMING TO CITIES AND TOWNS.

I ENJOY WORKING WITH YOU. YOU'RE PROFESSIONAL AND DEDICATED.

IN CHINATOWN, IT HAS VERY FEW PARKS.
