SORRY ABOUT THAT.

THANK YOU.

THANK YOU, CHAIRMAN CIOMMO, AND MEMBERS OF THE CITY COUNCIL. AS WE PRESENT OUR BPD'S

PRIORITIES AND THEY RELATE TO THE FY'19 BUDGET.

WE WANT TO RECOGNIZE MAYOR WALSH'S COMMITMENT TO PUBLIC SAFETY HERE IN THE CITY.

SAFETY HERE IN THE CITY.
IN THIS BUDGET HE PROPOSES TO
INCREASE OUR STRENGTH AS THE
CITY GROWS, GETTING TO PUT ON
130 NEW OFFICERS IN THE FALL.
WHERE OUR NUMBERS WILL GET UP TO
2,010 COME THE END OF THE FALL.

WE'RE PUTTING IN FOR 130

OFFICERS WITH THE HOPE THAT WE AT LEAST GET 100 OUT OF THAT CLASS.

AND OBVIOUSLY WHAT MAYOR WALSH AND OUR DEPARTMENT, OUR TOP PRIORITY AGAIN WILL BE TO MAKE GUN VIOLENCE A TOP PRIORITY COMING INTO THE NEXT YEAR. I ALSO WANT TO THANK THE MAYOR FOR HIS COMMITMENT TO SOCIAL JUSTICE, AND DIVERSITY. YOU KNOW, WE'RE LOOKING FORWARD TO PUTTING ON A NEW CADET CLASS. HOPEFULLY THEY'LL BE ON IN JUNE. THERE WILL BE 33 NEW OFFICES, AND THAT HAS HELPED US IN OUR EFFORTS TO PROMOTE DIVERSITY IN THE DEPARTMENT, AS THE LAST CLASS WAS OVERWHELMINGLY AFRICAN-AMERICAN. SO WE HOPE TO CONTINUE THAT TREND TO DIVERSIFY OUR

DEPARTMENT.

ALSO, WE ALSO HIRED A DIVERSITY OFFICER, MIKE GASKINS WHO IS DOING A TREMENDOUS JOB. HE'S OUT THERE RECRUITING MINORITY VETERANS.

HE'S OUT THERE IN THE HIGH SCHOOLS, HE'S AT JOB FAIRS, HE'S ALL AROUND THE CITY TO TRY TO INCREASE THE DIVERSITY SO THAT'S BEEN GREAT.

WE ALSO HAVE BEGUN THE IMPLEMENTATION IN THIS BUDGET TO IMPLEMENT BODY CAMERAS. YOU KNOW, THE STUDY'S NOT COMPLETELY OUT YET, BUT I THINK THE MAYOR HAS PUT \$2 MILLION OUT THERE FOR THE IMPLEMENTATION OF THE START OF THAT PROGRAM. WE'VE HAD OUR CHALLENGES THROUGH THE YEAR BUT WE'VE COME OUT STRONGER, AND MORE UNIFIED AS A CITY.

IN 2017, PART ONE CRIME WAS DOWN 6%, AND AGAIN OUR ARRESTS WERE DOWN 4%.

AND OVER THE LAST FOUR YEARS, WITH MAYOR WALSH, I BELIEVE OUR CRIME IS DOWN ALMOST 20% TO 25% IN THAT RANGE, AS WELL AS THE ARRESTS HAVE GONE DOWN ALMOST 30%.

WHAT THE MAYOR ALWAYS SAYS, AND WHAT I MODEL, WE'RE NOT ABOUT LOCKING KIDS UP, WE'RE ALL ABOUT LIFTING KIDS UP.

I THINK THAT'S OUR MODEL AND THAT'S WHAT WE STRIVE TO REALLY HELP THESE KIDS AS OPPOSED TO LOCKING THEM UP.

YOU KNOW, IN 2017, WE TOOK 807 GUNS OFF THE STREET, ALONG WITH 164 GUNS.

THIS YEAR FOR FOLLOW-UP, 300 GUNS ALREADY.

I MEAN JUST YESTERDAY WE TOOK TWO OFF A SHOOTING ON ADAMS AND PARK, AND LATER IN THE NIGHT WE HAD ONE TAKEN OFF THE STREET IN LEVANT.

SO THE GUYS CONTINUE TO WORK HARD TO DRIVE THE GUNS OFF THE STREET.

WE CONTINUE TO WORK GREAT WITH OUR PARTNERS, THE CLERGY AND EVERYONE ELSE TO MAKE PROGRESS WITH OUR COMMUNITY, AND WITH THE YOUTH OF OUR COMMUNITY.

THE DEVELOPMENT OF YOUTH DEVELOPMENT GRANTS THAT WERE AWARDED TO 11 NONPROFITS OUT THERE, AND WE CONTINUE TO PUT ON MORE CLINICIANS THROUGH THE BEST PROGRAM.

I THINK WE HAVE THREE OR FOUR HIRED RIGHT NOW, AND WE'RE LOOKING TO PUT OUT MORE. THAT'S BEEN VERY SUCCESSFUL. IN DEALING WITH A LOT OF THE CALLS WE HAVE, WHERE THERE'S MENTAL ILLNESS, IN SOME CAPACITY THAT'S IMPACTED.

SO THE BEST PROGRAM HAS BEEN

GREAT.
DIALOGUES CONTINUE.

WE JUST FINISHED A PROGRAM IN APRIL.

WE WERE THERE FOR THE GRADUATION.

THAT WAS A GREAT EVENT.

AND WE'RE CURRENTLY WORKING WITH MEDICINE WHEEL AND MIKE DONAHUE AND HIS CREW IN EAST BOSTON WHICH IS A YOUTH POLICE DIALOGUE THAT WAS STARTED IN SOUTH BOSTON AND THAT'S GOING WELL TO WORK

WITH A LOT OF, YOU KNOW, THE IMMIGRANT COMMUNITY OUT THERE, WHO SOMETIMES ARE FEARFUL OF THE POLICE.

SO IT'S BEEN GOING WELL.
WE WORK WITH YOUTH CONNECT.
WITH THE SOCIAL WORKERS, TO HELP
KIDS WHO MIGHT GET IN TROUBLE
GET THE SOCIAL SERVICES THEY
NEED.

WE DO HOME VISITS THROUGH OPERATION HOME FRONT, SERGEANT SEXTON WORKS WITH THE SCHOOLS, WITH THE CLERGY.

WITH KIDS IN TROUBLE THEY DO THAT.

OBVIOUSLY WITH THE SUMMER WE ALWAYS DO THE TEEN POLICE ACADEMY AS WELL AS THE JUNIOR POLICE ACADEMY SO THOSE ARE SOME OF THE IDEAS.

BUT WE WILL CONTINUE TO INCREASE COMMUNITY ENGAGEMENT, EVEN FURTHER, GOING FORWARD.

LAST YEAR WE DID OVER 100 PEACE WALKS IN THE COMMUNITY.

FROM MAY TO DECEMBER.

WE'VE ALREADY STARTED THIS YEAR. WE WERE OUT AT THE BAPTIST

CHURCH THIS PAST FRIDAY.

LAST NIGHT WE WERE ON HUMBOLDT FOR REVEREND CULPEPER WALKING THAT PARTICULAR AREA.

THAT'S A BIG PART OF OUR STRATEGY.

WE'RE IN THE SCHOOLS, WITH OUR SCHOOL POLICE UNIT, ALL OF US ARE IN THE SCHOOLS, READING TO THE KIDS, JUST TO SORT OF BREAK DOWN THE BARRIERS, SO THEY'RE NOT AFRAID OF THE POLICE.
WE HAVE FLASH LIGHT WALKS, WE HAVE COFFEE WITH A COP.

WE DO SO MANY EVENTS OUT THERE. THE ICE CREAM TRUCK.

CONTINUALLY ENGAGING WITH THE PUBLIC.

CHRISTMASTIME WE GIVE OUT MORE TOYS.

ALL OUR DISTRICTS, OTHER MILESTONES, YOU KNOW, WE WENT TO PUERTO RICO TO HELP IN THE RECOVERY THIS PAST YEAR. THAT WAS VERY EFFECTIVE.

IN EACH DISTRICT WE PUT A PATROL RIFLE SO OFFICERS RIDING AROUND WOULD HAVE THE ABILITY TO COMBAT SOMETHING LIKE WHICH HAPPENED IN EAST BOSTON, WHERE SOMETIMES THEY'RE CONFRONTED WITH SOMEONE WHO HAS AN ASSAULT RIFLE.

MOVING FORWARD OUR GOALS FOR NEXT YEAR ARE VERY SIMILAR TO WHAT THEY WERE THIS YEAR.

WE'LL CONTINUE TO REDUCE CRIME, AND WORK TO PREVENT THE VIOLENCE.

WE'LL ENGAGE EVEN MORE WITH THE COMMUNITY OUT THERE THROUGH OUR EFFORTS, WHETHER, YOU KNOW, IT'S AGAIN, IT'S BASKETBALL GAMES, IT'S SOCCER GAMES, FRANK WILLIAMS RUNS THE TENNIS PROGRAM.

WE'RE INVOLVED IN MORE ACTIVITIES OUT THERE, AND OBVIOUSLY EFFICIENT AND TIMELY RESPONSE TO CRIME AND CALLS FOR SERVICE.

A FEW EXAMPLES WE TARGET THE KIDS DRIVING THE VIOLENCE AND WE TARGET THE PLACES WHERE THE VIOLENCE ARE.

I THINK THAT'S WHY WE CONTINUE TO DRIVE THE VIOLENCE DOWN IN OUR CITY.

WE'LL ALSO CONTINUE ALL THESE YOUTH PROGRAMS THAT WE'VE HAD. WE ALSO DO ALL TRAINING, ALL HAZARDS TRAINING, ESPECIALLY NOW WITH THE ACTIVE SHOOTER EVENTS GOING AROUND THE COUNTRY. WHETHER IT WAS SANTA FE, HOUSTON WHERE IT WAS JUST A TERRIBLE TRAGEDY.

YOU KNOW WHAT WE'VE SEEN IN PARKLAND AND NEWTOWN, WE'RE WORKING WITH ALL THE PUBLIC SCHOOLS.

WE'RE WORKING WITH THE CATHOLIC SCHOOLS.

WE'RE WORKING WITH THE JEWISH COMMUNITY CENTERS, THE HOSPITALS, THE UNIVERSITIES. WE'VE PROBABLY DONE OVER 500 ACTIVE SHOOTER TRAININGS ACROSS THE COUNTRY.

AND WE'LL CONTINUE TO DO THAT

BASED ON WHAT GOES ON WE'RE ALSO HAVING AN HAVING A SUPERIOR OFFICERS PROMOTIONAL EXAM NEXT FALL WHICH IS IN THIS BUDGET. WE'LL CONTINUALLY UPGRADE OUR RADIO SYSTEM.

OVER THE PAST SEVERAL YEARS WE SPENT \$25 MILLION TO DO THAT TO GET IT UP TO SPEED DIGITALLY. WE ALSO HAVE IN THIS BUDGET 12 ADDITIONAL LPR CAMERAS OUT THERE ON THE STREET.

AND FOR THE FIRST TIME, WE INTEND ON THIS BUDGET HAVING ALL OUR OFFICERS HAVING ACCESS TO A SMARTPHONE.

THAT WAY THEY CAN GET THE TECHNOLOGY FIRSTHAND. A LOT OF CITIES AROUND THE COUNTRY HAVE THEM.

NEW YORK CITY, I THINK EQUIPPED ALL 36,000 OF THEIR OFFICERS WITH IT.

SO THAT'S VERY EFFECTIVE.
OUR OFFICERS CAN GETS SHOTS
IMMEDIATELY ON THEIR PHONE,
MISSING PERSONS, PATIENTS
MISSING, THEY CAN CHECK CRIMINAL
RECORDS.

THEY CAN DO A LOT OF THINGS. SO WE'RE LOOKING TO MOVE THAT. AND OBVIOUSLY SECURITY UPGRADES AT OUR EVIDENCE MANAGEMENT. SO AS YOU CAN SEE, WE'VE DONE A LOT.

AND WE'LL MOVE TO CONTINUE THE PROGRESS WE HAVE.

OBVIOUSLY AS TECHNOLOGY CHANGES, WE'RE CHANGING, A LOT OF CITIES HAVE A LOT OF THIS TECHNOLOGY THAT WE'RE MOVING TO.

SO, WE'RE NOT THE FIRST ONES TO TRY IT.

A LOT OF THESE TOOLS HAVE BECOME EFFECTIVE AND EFFICIENT.
YOU KNOW, TOOLS OF LAW ENFORCEMENT AROUND THE COUNTRY, AND SO, WE'LL CONTINUE TO WORK AND BE AS TRANSPARENT AS POSSIBLE WHEN AND IF WE LOG SOME OF THESE NEW IDEAS.

AND LASTLY, I JUST WANT TO THANK THE MAYOR FOR HIS TEND SUPPORT. YOU KNOW, ANY TOOLS, ANYTHING WE

NEED TO MAKE US A MORE EFFECTIVE AND EFFICIENT DEPARTMENT, HE'S FULLY BEHIND US.

AND SO WITH WITH THAT, THAT SORT OF LETS YOU KNOW WHERE WE WERE AND WHERE WE WANT TO GO.

BUT HONESTLY, I'M VERY PROUD OF OUR DEPARTMENT.

I THINK WE HAVE THE FINEST POLICE DEPARTMENT IN THE COUNTRY, NO DOUBT.

AND YESTERDAY I HAD SOMEONE FROM AUSTRALIA COME IN HERE TO LEARN ABOUT COMMUNITY POLICING.

YOU KNOW, AFRICA'S COMING IN THIS WEEK.

LIKE WE HAVE MORE VISITORS FROM AROUND THE WORLD COMING TO BOSTON.

SO I THINK WE DO A GREAT JOB, AND WE'RE NOT PERFECT.

BUT WE STRIVE TO -- FOR
PERFECTION, AND I'M JUST REAL
PROUD OF BOSTON BEING ONE OF THE
SAFEST CITIES IN AMERICA.
>> WELL, I HAVE TO ECHO THAT,

>> WELL, I HAVE TO ECHO THAT, COMMISSIONER.

I THINK WE DO HAVE THE FINEST MEN AND WOMEN IN BLUE IN THE ENTIRE COUNTRY.

AND PROBABLY THE WORLD NOW THAT AUSTRALIA'S COME AND AFRICA. I THINK WE DO SET A GREAT EXAMPLE, AND I WANT TO START BY JUST THANKING CAPTAIN PAUL RUSSELL AT D-14 AND HIS ENTIRE TEAM OF CSOS AND DETECTIVES, AND PATROL OFFICERS, AND SUPERIOR

OFFICERS.

I'VE ENJOYED A GREAT WORKING RELATIONSHIP WITH ALL OF THEM OVER THE YEARS, AND YOU WON'T MEET A FINER GROUP OF PEOPLE.
JUST GOING TO JUMP IN TO SOME -- OH, AND DURING YOUR PRESENTATION, WE WERE JOINED BY COUNCIL PRESENT ANDREA CAMPBELL, CITY COUNCILOR AT LARGE MICHAEL FLAHERTY, DISTRICT CITY COUNCILOR ED FLYNN, AND DISTRICT CITY COUNCILOR LYDIA EDWARDS. YOU KNOW, I THINK EVERY YEAR, COMMISSIONER, WE TALK ABOUT, YOU KNOW, NUMBERS.

WE'VE BEEN KIND OF STATIC OR FLAT WITH UNIFORM PERSONNEL FOR PROBABLY THE TEN YEARS, AT LEAST, THAT I'VE BEEN HERE, OVER TEN YEARS.

ARE WE STILL AROUND THE 2,000,
2200 UNIFORMS?

WE'VE ALSO SORT OF THE MAGIC NUMBER HAS ALWAYS BEEN 2185. AROUND THAT.

>> RIGHT.

>> IT HAD MORE TO DO WITH TIED IN TO FEDERAL GRANTS AT THE TIME.

>> YEAH.

>> AND NOW I WANT TO THANK THE MAYOR.

I THINK HE RECOGNIZES,
OBVIOUSLY, WHETHER IT'S THE
SOUTH END THAT'S EXPANDING,
WHETHER IT'S EAST BOSTON, ALL
AROUND THE CITY, AS YOU KNOW,
WE'RE GETTING MORE AND MORE
RESIDENTS, THE CITY IS BASICALLY
BOOMING RIGHT NOW.

>> YEAH.

>> AND YOU KNOW, I THINK WE'RE APPROACHING PROBABLY 700,000 RESIDENTS.

SO YOU KNOW, OBVIOUSLY MAYOR WALSH RECOGNIZES WE NEED MORE OFFICERS.

SO I'M HOPING THAT WE GET UP TO THE 2010 WITH THIS NEW CLASS. >> RIGHT.

AND I THINK IT BEGS THE QUESTION, IF WE ACTUALLY NEED MORE, BECAUSE OF THAT POPULATION SURGE IN THE PAST SEVERAL, MANY YEARS NOW, ACTUALLY THE PAST FIVE YEARS, I THINK WE'VE GROWN AT LEAST 50,000 PEOPLE PROBABLY. AND YOU KNOW, WE HAD EMS IN HERE JUST RECENTLY, AND YOU KNOW, WE WANT THEM TO HAVE THE TOOLS THAT THEY NEED, AND THEIR LINE OF BUSINESS, MUCH LIKE YOURS, IS GETTING TO THE SCENE AS QUICKLY AS YOU CAN.

AND SO WE WANT TO ENSURE THAT, YOU KNOW, WE HAVE A GREAT

UNPREDICTABLES, MARK.

I MEAN, WHETHER WE HAVE A SPIKE IN CRIME, YOU TRY TO ADDRESS THAT BY PUTTING EXTRA UNITS OUT. SUCH AS RECENTLY WE HAD THE UNFORTUNATE DEATHS OF TWO YOUNG

KIDS IN PEACHTREE.

OBVIOUSLY THEY WERE GOING AT IT
WITH ANOTHER DEVELOPMENT.

SO IN A CASE LIKE THAT, YOU
KNOW, WE PUT EXTRA VISIBILITY
OUT THERE AND WE TRY TO
SOMETIMES STOP THESE GANG FEUDS
BY PUTTING ADDITIONAL UNITS OUT.
I ALWAYS SAY HOW THE SUMMER GOES
AND HOW VIOLENT IT IS IS
OBVIOUSLY GOING TO IMPACT OUR

BUT ALSO, CITY'S BOOMING RIGHT NOW.

WE HAVE BOSTON CALLING THIS WEEKEND, WHICH IS OVERTIME. YOU KNOW, LIKE A LOT OF THE OFFICERS, A LOT OF THEM REALLY DON'T WANT IT, BUT WE JUST HAVE SO MANY EVENTS.

WE'VE GOT PARADES.

>> RIGHT.

BUDGET.

>> YOU KNOW, WE HAVE, YOU KNOW, THE FREE SPEECH MARCH LAST YEAR, WHICH I THOUGHT OUR DEPARTMENT DID AN OUTSTANDING JOB POLICING. YOU KNOW, ALMOST LIKE 70,000 PEOPLE.

>> RIGHT.

>> I MEAN ON THAT WOMAN'S MARCHES, THE WHOLE CALL OUT FOR

THE SUPER BOWL, EVEN THOUGH THEY DIDN'T WIN, WE HAD TO CALL EVERYONE IN.

THOSE UNPREDICTABLES EVERY WEEKEND, IS WHAT REALLY MAKES OUR BUDGET SOMETIMES GET OUT OF WHACK.

- >> WE DON'T HAVE FIXED EVENTS.
- >> RIGHT.

AND A LOT OF IT IS REACTIVE. A LOT OF IT IS PREVENTIVE.

- >> RIGHT.
- >> BUT A LOT OF IT IS REACTIVE.
- >> YEAH.
- I LIKE THE PREVENTIVE PART, AND I ALWAYS SAY I'D RATHER THROW, I DON'T SAY AS MONEY AT SOMETHING, AS OPPOSED TO GET ONE YOUNG ADULT HIT.

SO I LIKE TO INCREASE THE VISIBILITY ON THE WEEKENDS TO DEAL WITH, YOU KNOW, THE HOUSE PARTIES SOMETIMES THAT CAN TURN OUT WHERE WE HAVE VIOLENCE DEALING WITH A LOT OF THE ISSUES THAT WE DO HAVE TO PUT OUT ADDITIONAL UNITS.

WHETHER IT'S THE THEATER
DISTRICT, AND YOU KNOW, WE STUDY
EVERY WEEK WHAT'S GOING ON.
WE LOOK FORWARD TO WHAT'S COMING
UP ON THE WEEKEND.

AND BASED ON THAT, WE HAVE TO PUT EXTRA DEPLOYMENT OUT.

AND I CAN HONESTLY SAY, MOST OF OUR MONEY IS SPENT IN DORCHESTER BECAUSE HONESTLY, THAT'S

UNFORTUNATELY WHERE WE HAVE A LOT OF GUN PLAY.

AND YOU KNOW, I DON'T WANT TO SEE IT GET OUT OF CONTROL.

YOU KNOW, THOSE DISTRICTS HAVE MOST OF THEIR OFFICERS PROBABLY ALMOST DOUBLE WHAT THE SMALLER STATIONS HAVE.

AND MY PRIORITY IS KEEPING THE CITY SAFE.

AND TRYING OUR BEST TO NOT LET

THE GUN VIOLENCE GET OUT OF CONTROL.

>> I THINK THE FACT THAT I THINK IT'S TWO YEARS IN A ROW YOU'RE REPORTING PART ONE CRIME GOING DOWN.

TWO YEARS IN A ROW ARRESTS ARE DOWN AT THE SAME TIME.

I THINK THAT'S -- THAT'S VERY POSITIVE NEWS.

I JUST HAVE A QUICK BUDGET QUESTION, TOO.

YOU TALKED ABOUT THE BODY CAMERAS.

WOULD THAT BE UNDER POSSIBLY CONTRACTED LINE? 52.900.

THE 1.8 EXTRA, I GUESS? OKAY.

AND WE'VE ALSO BEEN JOINED BY COUNCILOR MATT O'MALLEY RECENTLY.

MR. CHAIRMAN, COMMISSIONER, CHIEFS, EVERYONE, GOOD TO SEE YOU.

THANK YOU.

FOR BEING HERE.

I WANT TO ECHO THE EARLIER COMMENTS BY THE CHAIRMAN THAT I THINK, WE'RE ALL VERY PROUD OF THE WORK YOUR MEN AND WOMEN DO EVERY DAY, AND I THINK, ESPECIALLY WHEN WE SEE HOW SOME OTHER CITIES DEPARTMENTS HAVE DEALT WITH SOME OF THE ISSUES, PARTICULARLY AROUND RALLIES AND MARCHES AND PROTESTS AND SOME OF THE OTHER COMMUNICATIONS ISSUES. YOU KNOW, BOSTON CONTINUES TO BE AN EXAMPLE, AND I'M SURE THAT, YOU KNOW, IT'S TRAINING BUT ALSO COMES FROM LEADERSHIP I THINK THAT'S SITTING UP HERE.

SO I APPRECIATE THAT.

AND I THINK IT MAKES IT EASIER
ON OUR END TO TALK ABOUT THIS.
BUT, TO JUMP RIGHT INTO IT, I
HAVE JUST A COUPLE QUICK
QUESTIONS AND AGAIN, COUNCILOR
CIOMMO TOUCHED ON SOME OF THIS.
AS FAR AS STAFFING GOES.

YOU KNOW THE CITY IS GROWING, RESIDENTS OBVIOUSLY DURING THE DAY, WE HAVE A LOT MORE PEOPLE IN HERE FOR WORK.

WEEKEND EVENTS.

YOU KNOW, IS THERE DISCUSSION ABOUT SAYING, I THINK YOU SAID 2185 WAS THE IDEAL --

>> RIGHT NOW WE HAVE 2155.

WE'VE ALWAYS STRIVED FOR THE 2185, BUT NOW WE'RE GOING TO GO UP TO 2010.

>> SO IS THERE ANY THOUGHT OR PLANNING OF DO WE NEED 200 OR 300 MORE OFFICERS IN THE NEXT FIVE OR TEN YEARS, POPULATION GROWING, I MEAN HOW DO YOU FEEL ABOUT --

>> I THINK THE MAYOR REALIZES THAT.

I THINK HE SEES IT GROWING.
YOU KNOW, I DON'T THINK IT'S
GOING TO GO DOWN ANY TIME SOON.
SO I THINK HONESTLY, IT'S A
MATTER OF BEING ABLE TO DO IT.
YOU KNOW, OUR ACADEMY RIGHT NOW,
WE'RE THROWING EXTRA SEATS IN
THERE.

THEY CAN ONLY HANDLE WHAT WE HAVE.

YOU KNOW, I THINK IF WE HAD A LARGER CAPACITY WE COULD PROBABLY LOOK TO PUT MORE ON. WE JUST HAD A CLASS GRADUATE OF 97.

ABOUT A MONTH AGO.

SO WE'RE PUMPING THEM OUT.

I THINK THE MAYOR REALIZES.

IT'S JUST A MATTER, THE ACADEMY IS SIX MONTHS.

SO I THINK AS QUICK AS THIS ONE GETS OUT I THINK THE MAYOR RECOGNIZES HE'S GOING TO HAVE TO GET ANOTHER ONE IN THERE.

SO WE'RE TRYING TO KEEP UP WITH RETIREMENTS, BELIEVE IT OR NOT. AND WE'RE CATCHING UP.

>> RIGHT.

I THINK THAT'S SOMETHING THAT, YOU KNOW, OFTEN WHATEVER ISSUES WE'RE TALKING ABOUT, I THINK PEOPLE IN OUR NEIGHBORHOODS REALLY DO WANT TO MAKE SURE WE HAVE THE STAFFING WE NEED. I THINK THIS BODY WOULD CERTAINLY SUPPORT THAT, THE CAPACITY.

ON ANOTHER UNRELATED ISSUE, YOU KNOW, ON PEDESTRIAN CYCLE SAFETY, VISION ZERO, I KNOW YOU HAVE BEEN A PART OF THOSE DISCUSSIONS, AND OBVIOUSLY AS THE TRANSPORTATION DEPARTMENT IS REALIGNING AND REDESIGNING MANY OF OUR STREETS, WHAT IS THE VIEW, OR HOW ARE YOU COMMUNICATING TO OUR OFFICERS ABOUT, YOU KNOW, NOT JUST SPEEDING AND TYPICAL TRAFFIC VIOLATIONS, BUT YOU KNOW, PARKING AND BIKE LANES, SAFETY ISSUES LIKE THAT? I KNOW SOME OF THAT IS BPD, DO YOUR OFFICERS HAVE THAT ON PATROL.

HOW DOES THAT COME ON THE PRIORITY LIST?

>> WE MESH U WHEN WE DO CAMPS EVERY TWO WEEKS ONE OF THE THINGS WE DO RECOGNIZE IS HOW MANY PEDESTRIAN ACCIDENTS ARE IN EACH DISTRICT, HOW MANY BICYCLE ACCIDENTS.

WE ALSO HAVE CRIME ANALYSIS PEOPLE LOOK AT THE INTERSECTIONS WHERE MOST OF THEM ARE.

AND THAT'S WHERE WE TRY TO DO OUR ENFORCEMENT.

AND YOU WE KNOW BEACON AND MASS IS A PROBLEM.

IT ALWAYS SEEMS TO BE THE SAME INTERSECTIONS.

AND I THINK YOU'LL SEE THAT THE MOTORCYCLES UP THERE, YOU KNOW, THE MOP CYCLES DOING IT.

SO WE'RE TRYING TO CONCENTRATE ON TROUBLED AREAS WHERE WE'RE SEEING IT.

YOU KNOW THIS MORNING, AS WELL AS COMP STAT THE OTHER DAY I STRESSED WITH THE SUMMER MONTHS WE'RE REALLY GOING TO INCREASE OPERATION CROSSWALK.

IN AND AROUND THE PARKS SO WHEN MOTHERS WITH THE BABY CARRIAGE OR THE PEOPLE GOING TO THE PARKS IN THE SUMMER, WE'LL MAKE SURE PEOPLE ARE SLOWING DOWN.

YOU KNOW, WE INTEND ON PUTTING THE TRAFFIC SUPERVISORS OUT IN AND AROUND THE CROSSWALKS IN THE PARK.

SO WE'RE GEARING UP FOR THE SUMMER TO MAKE SURE WE CAN MAKE THE BIKERS AS WELL AS THE PEDESTRIANS AS SAFE AS POSSIBLE. >> AND AS FOLKS, AGAIN, HOW DO YOU SEE THE DIVISION BETWEEN BPD AND BTD ON, I MEAN, DOUBLE PARKING, CARS PARKED IN THE BIKE LANES, WHICH I KNOW MY COLLEAGUES WE OFTEN GET TAGGED ON TWITTER WHEN PEOPLE, YOU KNOW, ARE SEEING THIS, AND TAG BOSTON POLICE ALSO. WHOSE RESPONSIBILITY, HOW DO WE SEE THAT?

I KNOW, OBVIOUSLY YOU HAVE A LOT ON YOUR PLATE.

>> YEAH, I MEAN FOR THE MOST PART I'LL BE HONEST, WE CONCENTRATE ON THE REAL SERIOUS HAZARDS, WHETHER IT'S CROSSWALKS, CORNERS, HYDRANTS, TRANSPORTATION MOSTLY DOES RESIDENTIAL BUS LANE AND PEDESTRIAN PARKING FOR THE MOST PART.

WE LEAVE IT TO TRANSPORTATION. IF THEY'RE OVERWHELMED, THEY'LL LET ME KNOW.

BUT WE TALK ALMOST DAILY, EVERY OTHER DAY ON THAT WHOLE ISSUE. BUT AS FAR AS THE BIKE LANE I THINK TRANSPORTATION HANDLES THAT.

WE HANDLE THE MORE SERIOUS VIOLATIONS.

JUST TO KEEP OUR OFFICERS FREE UP FOR THE CALLS.

>> AND I THINK THAT'S ALL I HAVE.

I JUST WANT TO SAY, I KNOW YOU HAVE THE CSOS THAT WE HAVE IN MY DISTRICT THAT HAVE BEEN WORKING WITH OUR NEIGHBORHOOD GROUPS, OUR CIVIC ASSOCIATIONS, YOU KNOW, ROUNDLY APPLAUD ON A REGULAR BASIS.

SO I DO THINK THAT COMMUNITY
POLICING CLEARLY IS EFFECTIVE,
AND PEOPLE APPRECIATE HAVING THE

NAME, THE NUMBER, THE E-MAIL ADDRESS, YOU KNOW, OF AN INDIVIDUAL OFFICER OR CSO SERGEANT TO TALK TO ON THESE ISSUES.

I JUST URGE YOU TO CONTINUE THAT AND THANK YOU ALL FOR YOUR WORK.

>> JUST SO YOU KNOW, COUNCILOR ZAKIM WE INTEND ON KEEPING A HIGH VISIBILITY IN THE COMMON.

I KNOW UNFORTUNATELY LAST YEAR WE HAD A COUPLE TOUGH EVENTS.

BUT THE CAPTAIN AND THE SERGEANT ARE COMMITTED TO THREE OFFICERS DOWN THERE ALL THE TIME TO MAKE SURE WE HAVE A SAFE AND A GOOD PARK WHERE PEOPLE CAN SAFELY WALK THROUGH IT.

>> THANK YOU.

THANK YOU MR. CHAIRMAN.

- >> GOOD MORNING.
- >> GOOD MORNING.

>> I BET YOU'RE GOING TO GET
THIS FROM EVERYONE, BUT THANK
YOU FOR WHAT YOU DO DAY-TO-DAY,
AND WE'RE ALWAYS VERY, VERY
PROUD, AND GRATEFUL FOR THE TIME
THAT YOU PUT IN TO SUPPORT NOT
JUST THE SAFETY OF OUR RESIDENTS
BUT REALLY PARTNERSHIPS
THROUGHOUT THE CITY AND WITH THE
COUNCIL.

SO I WANTED TO DIVE IN A LITTLE BIT ON THE EXTERNAL GRANT FUNDING.

BECAUSE IT LOOKS LIKE A LOT OF THE PREVIOUSLY AWARDED FUNDING, ESPECIALLY FROM THE FEDERAL AND STATE LEVEL FOR COMMUNITY OUTREACH PROGRAMS IS ENDING. SO, THINGS LIKE BOSTON RE-ENTRY INITIATIVE, COMMUNITY BASED VIOLENCE PREVENTION PROGRAM, EOPSS JAG YOUTH ENGAGEMENT FOR EXAMPLE.

SO HOW ARE THESE AREAS OF SUPPORT GETTING ABSORBED INTO OTHER FUNDING OR OTHER PROGRAMS? >> GOOD MORNING COUNCILOR, MY NAME IS JOHN DALEY, SPELLED D-A-L-E-Y FOR THE RECORD, SO ON THE GRANTS WE HAVE HAD SOME

SLOWDOWN IN NOTIFICATIONS FROM THE FEDERAL GOVERNMENT ABOUT GRANTS, JAG GRANT IN PARTICULAR, WAS ONE THAT WE'RE CONCERNED ABOUT.

BUT, WE -- THEY HAVEN'T SAID NO, WE'RE STILL WAITING FOR SOME PREVIOUS YEAR FUNDING, AND WE -- WE'RE WAITING TO HEAR WHAT'S GOING TO HAPPEN GOING FORWARD. I KNOW THERE'S SOME LAWSUITS AT THE NATIONAL LEVEL THAT MIGHT BE HOLDING THINGS UP.

>> IT'S HARD TO SAY TOTAL DOLLARS.

YOU KNOW, DEPENDING ON HOW WE REALLOCATE.

BUT I THINK THERE'S ABOUT HALF A MILLION DOLLARS SHORTFALL ON THE JAG GRANT PRESENTLY.

AND WE'RE HOPING THAT WE DO RECEIVE WORD FROM THE FEDERAL GOVERNMENT ON THAT.

>> OKAY, GREAT.

IN TERMS OF THE YOUTH CONNECT PROGRAM, JUST HAD NOTED THAT THE NUMBER OF REFERRALS SORT OF LIFTED YEAR, AND THE GOAL FOR THIS YEAR ACTUALLY PROJECTS A DECREASE IN THE NUMBER OF YOUTH WHO WOULD BE REFERRED.

  >> CARRIE RUNS EVERYTHING FROM
  THE BACK, SO YOU DON'T HAVE

- >> I THINK THE NUMBERS ARE RIGHT TO TELL YOU THE TRUTH.

- >> I WOULD -- I'M SURPRISED AT THAT.
- I SEEN THAT.

YOU KNOW, I THINK ADRIAN PARY

AND YOUTH CONNECT DO A SUPERJOB. IN FACT I'M MEETING WITH THEM NEXT WEEK TO TRY TO GET MORE IN THE DISTRICTS.

CURRENTLY, WE HAVE -- WE JUST RECENTLY PUT ONE IN EAST BOSTON, AND SO YOU KNOW, WE HAVEN'T BEEN I BELIEVE SIX DISTRICTS NOW.

PENNY.

>> COULD YOU TOUCH A LITTLE BIT ABOUT THE BUDGET FOR PROFESSIONAL STANDARDS?
IT LOOKS LIKE IT'S BEEN GOING DOWN FAIRLY STEADILY.
IS THAT -- IS THERE A CERTAIN REASON BEHIND THAT?
>> I DON'T KNOW.
THERE'S NO REASON BEHIND IT.
I DON'T KNOW WHY.
BUT THEY'RE STILL DOING A GREAT JOB AND WE'RE NOT CUTTING THEM.
MIGHT BE A NUMBER.

>> OKAY.

AND THEN I HAVE TWO OTHER KIND OF UNRELATED, OR ON A SEPARATE NOTE, WE HAVE A HEARING ORDER READY AND WE TALKED A BUNCH OF TIMES ON SURVEILLANCE, AND JUST BEING AWARE THAT SO MUCH MORE IS GOING TO BE COLLECTED AS EVERY PART OF THE CITY BECOMES SMARTER, SO, COULD YOU TELL US, JUST GIVE A SUMMARY ON WHAT KIND OF ELECTRONIC EQUIPMENT IS INSTALLED, PARTICULARLY IN THE DOWNTOWN BID AREA, AND THEN WHAT IS THE PLAN FOR THIS YEEX FISCAL YEAR?

>> I KNOW WE WORK WITH THE BID AREAS TO GET ADDITIONAL CAMERAS UP THERE, AND SUPPLIED PLENTY.
AND I THINK OBVIOUSLY CAMERAS ARE VERY POWERFUL FOR US.
OBVIOUSLY NOT TO BE USED IN ANY SINISTER WAY BUT TO BE OUT THERE, AND BE OUR EYES AND EARS.
TWO WEEKS AGO WE HAD A
16-YEAR-OLD ON A GPS BRACELET SHOOT ANOTHER INDIVIDUAL, AND I WAS DOWN THERE.

AND WITHIN THREE MINUTES WE HAD A GREAT PICTURE OF THAT KID WHO DID THAT SHOOTING.

SO, OBVIOUSLY WE DIDN'T HAVE A WHOLE LOT OF COOPERATION, SO CAMERAS ARE A KEY FOR US TO SOLVE QUITE A BIT OF CRIMES.
OBVIOUSLY THEY'RE OUT IN PUBLIC SPACES FOR THE MOST PART.
WHERE REALLY PEOPLE DON'T HAVE A RIGHT OF PRIVACY SO MUCH.

WE DON'T HIDE THEM.

BUT THAT'S VERY INSTRUMENTAL.
AND A LOT OF OUR CASES THAT
WE'RE SOLVING, WHETHER IT'S
HEATH STREET A COUPLE WEEKS AGO,
WHETHER IT'S RAYMOND STREET NOT
LONG AGO, MOST THOSE,
UNFORTUNATELY, ARE SOLVED BY THE
CAMERAS.

I WISH WE HAD BETTER COOPERATION.

SO I'M ALWAYS LOOKING TO PUT MORE CAMERAS OUT IN THE OPEN SPACES.

SO WE GET THE PEOPLE WHO ARE RESPONSIBLE FOR SHOOTINGS,

BECAUSE OTHERWISE WE HAVE RETRIBUTION, AND WHATNOT. SO HAVING THEM DOWN THE BID WAS VERY EFFECTIVE.

I'M ALWAYS ABOUT PUSHING MORE CAMERAS OUT, BELIEVE IT OR NOT. BECAUSE THEY'RE OUR EYES AND EARS OUT THERE.

YOU KNOW, AS FAR AS THE BODY CAMERAS.

THE STUDIES ARE CONCLUDING IN .THINE.

I KNOW THE MAYOR IS PROBABLY MOVING IN THAT DIRECTION MOST LIKELY.

I THINK HE'S APPROPRIATED ALMOST \$2 MILLION.

I THINK WE'RE GOING TO PUT THAT MOST LIKELY IF THE STUDY IS -- COME OUT THE WAY WE ANTICIPATE, WE'LL PROBABLY GO TO INCREMENTAL DISTRICT BY DISTRICT TO GET THAT UP AND ROLLING.

AS FAR AS THE LICENSE LEADERS, CURRENTLY WE HAVE THREE OUT THERE.

WE'D LIKE TO PUT MORE OUT THERE. WE WORK WITH THE ACLU, BECAUSE THEY HAD CONCERNS THAT WE'RE JUST LOOKING TO CAPTURE ANY AND ALL INFORMATION OUT THERE. WE HAVE A POLICY THAT SETS UP THE PARAMETERS OF HOW WE'LL USE IT.

AND ALSO WORK WITH THEM, WE WENT PURGING THE INFORMATION, I BELIEVE, FOR ALMOST SIX MONTHS. THEY RECOMMENDED I THINK THREE MONTHS, AND NOW WE CAME BACK AND WE GOT RID OF THE INFORMATION AFTER 30 DAYS.

SO IT'S ONLY GEARED TOWARDS A SPECIFIC CRIMINAL INVESTIGATION. SO, WE'RE GOING TO BE LOOKING TO PUT MORE OUT.

AND IT'S NOT JUST AROUND THE BALANCE, IT'S AROUND DOWNTOWN. THE THREAT OF TERRORISM AND WHATNOT.

THIS DAY AND AGE, IF YOU GO AND LOOK AT NEW YORK CITY, THAT PLACE IS SWARMING WITH BODY -- WITH CAMERAS, LPRS ALL OVER THE PLACE.

I THINK ANY MAJOR CITY FOR THE MOST PART HAS THOSE.

AND OBVIOUSLY DOWN THE LINE, YOU KNOW, WE'RE GOING TO BE LOOKING TO GO TO DRONES, ALSO.

WE MADE THE COMMITMENT TO HAVE A PUBLIC FORUM AND GET FEEDBACK ON THAT.

I KNOW I'VE BEEN WORKING WITH PRESIDENT CAMPBELL AND THE SOCIAL JUSTICE TASK FORCE. WE'RE GOING TO WALK THEM THROUGH IT.

AND SEE, LIKE THE BODY CAMERAS, WHAT THEY WOULD LIKE TO SEE.
WHEN WE PUT THAT POLICY OUT IT'S JUST GOING TO BE, AGAIN, ABOUT PUTTING IN PUBLIC SPACES WHERE NO ONE HAS AN EXPECTATION OF PRIVACY FOR SPECIFIC REASONS.
AND THEY'RE KEY.

I KNOW THE STATE POLICE USES THEM NOW.

EVERY DEPARTMENT, MAJOR CITY DEPARTMENT ACROSS THE COUNTRY USE THEM.

WE USE THEM FOR ACCIDENT RECONSTRUCTION.

CRIME SCENE PHOTOS, AND MEASUREMENTS.

MISSING CHILDREN, MISSING ALZHEIMER'S PATIENTS.

DEALING WITH MONITORING PROTESTS, CURRENTLY WE USE A STATE POLICE HELICOPTER UP THERE.

IT WOULD BE A LITTLE QUIETER, OR A LITTLE EASIER IF WE COULD MONITOR IT FROM THE BRICK OURSELVES.

THAT WILL ALL BE PUT OUT IN THE POLICY.

SPECIFICALLY SAYING WHAT THE PURPOSE IS, AND WE WILL NOT, OBVIOUSLY, USE IT TO GO IN TO PEOPLE'S HOMES, OR INTO PEOPLE'S PRIVATE SPACE.

SO, SOME OF THE TECHNOLOGY, OBVIOUSLY THE iPHONES I TOUCHED ON.

WE'RE HOPING TO GET ALL 2185 OFFICERS EQUIPPED WITH THEM, HOPEFULLY IN JANUARY WE'RE GOING TO DO THAT. >> GREAT.

CHIEF, ARE YOU WILLING TO SPEAK?

>> -- DOMESTIC PREPAREDNESS,

WHEN WE HAVE OUR SPECIAL EVENTS,

CAMERAS ARE INSTRUMENTAL.

WE HAVE A LAW ENFORCEMENT

EXECUTIVE COMMAND CENTER.

OF COURSE WE HAVE LIAISONS FROM

ASSISTING AGENCIES.

WE REALLY RELY ON TECHNOLOGY,

ESPECIALLY CAMERAS.

AND I THINK DRONES WOULD ENHANCE

THAT, AS WELL.

AS WELL AS OFFICERS RECEIVING THE SMARTPHONES.

BUT THE COMMISSIONER TOUCHED ON THAT.

>> GREAT.

OKAY.

YEAH I THINK EVERYONE THAT I'VE HEARD FROM IS UNITED IN WANTING EVERY COMMUNITY TO BE AS SAFE AS POSSIBLE.

AND TO HAVE THE GREATEST DEGREE OF TRUST AS POSSIBLE, AS WELL. SO I THINK IT'S REALLY JUST, YOU KNOW, ANY ACTION, ON MY PART OR WITH COLLEAGUES, I CAN SAY HAS BEEN WITH TRYING TO SET THE EXPECTATION THAT THERE WILL ALWAYS BE A POLICY IN PLACE, WHICH IS WHAT YOU ALL HAVE BEEN DOING ALREADY, AND WHICH IS WHAT I THINK, YOU KNOW, WE'VE HAD SEVERAL CONVERSATIONS ABOUT MOVING FORWARD ON ANYWAY. SO, HAVING THAT CONVERSATION OUTSIDE OF THE BUDGET SPACE ON THE HEARING ORDER, AND THEN FINALLY, I'M SORRY, TAKING A LOT OF TIME.

THE LAST QUESTION JUST TO FOLLOW UP ON COUNCILOR ZAKIM'S POINT WITH JOEL HERE, REPRESENTING THE RIDE OF SILENCE, AND THE REPORT ABOUT THE CRASH THAT CLAIMED THE LIFE OF ANITA KERRMAN, HE HAS SOME SUGGESTIONS THAT HE'LL OFFER HIMSELF.

BUT I WAS CURIOUS ABOUT, IN TERMS OF FUTURE PROCESS FOR VISION GEAR, PARTICULARLY WHEN THERE ARE BAD CRASHES AND GOD FORBID FATALITIES, WHETHER THERE COULD BE MORE DIRECT
CONVERSATION BETWEEN MEMBERS OF
THE CYCLING COMMUNITY, AND BPD
AS THEY'RE LOOKING TO, YOU KNOW,
DEVELOP THE REPORT, NOT TO
DICTATE THE REPORT OR ANYTHING,
BUT TO INCLUDE MEMBERS IN
TRAINING FOR OFFICERS, OR SOME
SORT OF FEEDBACK AND
COLLABORATION.

>> RIGHT.

I MEAN WE'RE ALWAYS LOOKING TO WORK WITH THE COMMUNITY, AND YOU KNOW, WE WORK WITH THE BIKERS GROUP IF THEY THINK THAT THERE'S SOME SUGGESTIONS.

BUT, YOU KNOW, THIS WAS AN UNFORTUNATE ACCIDENT.

I THINK.

AND YOU KNOW WE DON'T USUALLY GET INVOLVED WITH WHETHER THEY'RE HOMICIDE INVESTIGATIONS, OR BIKE OR PEDESTRIAN.
YOU KNOW, THAT INFORMATION IS USUALLY KEPT PRETTY TIGHT.
SO NOT ONLY BECAUSE OF THE PROSECUTION, BUT ALSO FOR THE FAMILY.

BUT YOU KNOW, ANY SUGGESTIONS
THAT THEY THINK WE CAN DO A
BETTER JOB ON KEEPING THE BIKERS
SAFE, WE'RE ALL ABOUT IT.
BUT YOU KNOW, I THINK THIS, YOU
KNOW, OUR HEARTS GO OUT TO THE
VICTIM IN THIS CASE.
THE OFFICERS DID A VERY THOROUGH

THE OFFICERS DID A VERY THOROUGH INVESTIGATION.

I KNOW, YOU KNOW, SOMETIMES THE BIKERS WEREN'T HAPPY WITH IT. BUT YOU KNOW, THE FACTS TAKE US WHERE THEY DO.

AND THAT WAS THE END RESULT HERE.

BUT WE'LL GLADLY WORK -- I KNOW THE CAPTAIN HAS A LOT OF DIALOGUE WITH THEM, AND WE'RE OPEN ALWAYS.

>> OKAY, GREAT.

THANK YOU VERY MUCH.

THANK YOU, MR. CHAIRMAN.

>> THANK YOU.

COUNCILOR ESSAIBI-GEORGE?

>> THANK YOU, CHAIR.

THANK YOU ALL FOR BEING HERE

TODAY.

I JUST WANT TO FOLLOW UP ON A FEW OF COUNCILOR WU'S QUESTIONS. ON VISION ZERO THERE WAS ONCE A GRANT FUNDED POSITION FOR SOMEONE WHO COORDINATED EFFORTS BETWEEN BPD AND BTD.

IS THAT POSITION NO LONGER

IS THAT POSITION NO LONGER FUNDED?

>> THAT'S CORRECT.

YES.

WE LOST THAT POSITION, AND THAT INDIVIDUAL DID SOME ANALYSIS, IN-HOUSE ANALYSIS AND WAS ABLE TO PRODUCE SOME DATA AROUND CRASHES.

>> AND WAS THAT -- I MEAN WAS THAT A HELPFUL POSITION?
IT SEEMS THAT MAYBE SINCE THAT POSITION HAS GONE AWAY, THAT THERE'S BEEN A LACK OF DATA SHARING BETWEEN DEPARTMENTS.

>> THAT'S CORRECT.

AND WE'VE WORKED WITH TRANSPORTATION, AND WE'RE TRYING TO IDENTIFY RESOURCES TO FUND A POSITION THAT WOULD HELP WITH THAT DATA.

>> GREAT.

THANK YOU.

>> IT WOULD BE INTERESTING TO FIND OUT HOW WE CAN MAKE THAT HAPPEN, BE MORE PRODUCTIVE.

SO I HAVE A COUPLE QUESTIONS AROUND, I'LL USE THIS SEGMENT TO ASK ABOUT THE CRIME LAB AND THE CRIME LAB'S REACTION TO THE NEW CRIMINAL JUSTICE REFORM BILL THAT WAS PASSED UP AT THE STATE HOUSE.

AND IN PARTICULAR, THE SEXUAL ASSAULT KITS AND THE TURNAROUND TIME.

CAN WE TALK ABOUT OUR ABILITY TO BUILD CAPACITY AT THE CRIME LAB IN ORDER TO CONFORM WITH THE NEW CRIMINAL JUSTICE BILL.

>> I KNOW ONCE THEY HAD SEEN THE BILL BEFORE IT WAS PASSED, OBVIOUSLY THE CRIME LAB WASN'T HAPPY WITH THE WAY IT WAS ROLLED OUT.

I MEAN, FROM WHAT I UNDERSTAND, TO HAVE THE TURNAROUND WITHIN 30

DAYS WAS VERY MUCH UNREALISTIC. I KNOW THEY WROTE ME A LETTER, WHICH I FORWARDED TO THE PUBLIC SAFETY DIRECTOR DAN BENNETT ASKING FOR MORE LEEWAY ON THAT. BUT I KNOW THAT'S TROUBLING TO US GIVEN THE CASE LOAD THAT WE HAVE.

I THINK WE WERE LOOKING FOR MORE LIKE 90 DAYS THERE.

WHICH WAS MORE REALISTIC.

SO, WE DO HAVE A PROBLEM WITH THAT COUNCILOR, AND YOU KNOW, WE'LL JUST HAVE TO SEE HOW THAT PLAYS OUT.

BUT I KNOW WE HAD OPPOSITION TO THAT TIME LINE.

>> SO WITH.

30-DAY REQUIREMENT, IS THERE ANY SORT OF PLAN TO INCREASE CAPACITY IN THE CRIME LAB TO INCREASE THE NUMBER OF PERSONNEL TO PROCESS THE WORKLOAD?

>> WE'RE LOOKING AT THAT RIGHT NOW.

YOU KNOW, UNFORTUNATELY, LIKE I SAID, YOU KNOW, WE'RE GOING TO HAVE TO LOOK AT HOW IT'S GOING TO IMPACT US, WHEN IT GOES -- WHEN IT REALLY STARTS TO SORT OF IMPACT US.

BUT RIGHT NOW, YOU KNOW, IT'S TROUBLING TO US.

WE TRY TO STOP THAT PART OF THE BILL, BUT, ROBB WE'RE GOING TO HAVE TO HIRE MORE BECAUSE WE CAN'T LET THESE CASES GET THROWN OUT BECAUSE WE CAN'T PROCESS THEM.

>> YES.

>> SO WE'RE JUST GOING TO SEE, YOU KNOW, EXPERIMENT WITH HOW THIS GOES AND SEE IF WE CAN PUSH IT.

BUT OTHERWISE WE'RE GOING TO HAVE TO HIRE.

>> YEAH, NO, SO, ASKING ABOUT THIS IS REALLY TO MAKE SURE THAT WE CAN RESPOND TO THE NEW CRITERIA, AND THAT WE HAVE THE CAPACITY TO DO SO.

BECAUSE I DON'T WANT TO SEE IT INCREASE IN CASES, ESPECIALLY THE SEXUAL ASSAULT CASES BEING THROWN OUT BECAUSE WE WERE UNABLE TO TURN AROUND THE TIME. CAN WE TALK A LITTLE BIT ABOUT THE RELATIONSHIP, SINCE I BROUGHT UP CRIME LAB, BETWEEN THE STATE CRIME LAB AND BPD'S CRIME LAB?

WHAT DOES -- WHAT'S THE STATE RESPONSIBLE FOR?

WHAT'S BPD RESPONSIBLE FOR?
>> WELL, I THINK RIGHT NOW THE
STATE OBVIOUSLY DOES THE DRUG
TESTING FOR THE MOST PART.
YOU KNOW, AND I KNOW THAT'S
SLOW.

WE'D LIKE IT, OBVIOUSLY, TO BE A LOT QUICKER.

BUT THE CASELOAD IS THE WHOLE STATE.

WE'VE ALWAYS TALKED ABOUT THE CAPABILITY OF BUILDING OUR OWN DRUG LAB.

BUT, YOU KNOW, THE EXPENSE WE LOOKED AT THAT IS TREMENDOUS. BUT WE DO, OTHERWISE WE DO OUR OWN TESZING, OBVIOUSLY, YOU KNOW, BALLISTIC TESTING, THE DNA TESTING, YOU KNOW, OUR OTHER TRACE EVIDENCE, WE DO THAT ALL IN-HOUSE FOR THE MOST PART. THE STATE DOES MOST OF OUR DRUG TESTING, IS MAINLY THEIR RESPONSIBILITY.

>> AND DO WE USE OUR CRIME LAB FOR OTHER COMMUNITIES? >> NOT TO MY KNOWLEDGE, GIVEN OUR CASELOAD.

MOST OF THEM SHIP IT TO THE STATE.

>> I WOULD WONDER IF WE WERE TO LOOK AT BUILDING -- INCREASING OUR CAPACITY, BOTH JUST IN NUMBERS TO CONTINUE DOING MORE OF THE WORK WE DO NOW, BUT THEN TO EXPAND OUR WORKLOAD, IF WE COULD, SIMILAR TO HOW THE ACADEMY BILLS OUR COMMUNITIES TO TRAIN, THAT WE COULD BILL OTHER COMMUNITIES TO DO SOME OF THE LABWORK, AS WELL, SIMILAR TO WHAT THE STATE DOES FOR US WITH DRUGS AND FOR OTHER COMMUNITIES WITH DRUGS.

>> I MEAN, IT'S A POSSIBILITY.

BUT YOU KNOW, OBVIOUSLY, WE HAVE OUR HANDS FULL PROCESSING WHAT WE HAVE RIGHT NOW.

SO THAT WOULD BE OBVIOUSLY A HUGE INCREASE IN COST TO BUILD, BUT ALSO IN PERSONNEL.

>> OKAY.

ALL RIGHT.

THAT'S IT FOR THIS ROUND. THANK YOU.

>> COUNCILOR CAMPBELL?

>> THANK YOU, COUNCILOR CIOMMO AND THANK YOU COMMISSIONER, YOUR TEAM, AND CHIEF AND YOU GUYS FOR BEING HERE.

I REALLY APPRECIATE IT.

AND THANK YOU TO THE WORK THAT YOU DO EVERY DAY.

I HAVE TO GIVE A SPECIAL SHOUT-OUT TO CAPTAIN HUSSEIN AND McCHALK LYNN WHO JUST CAME OVER TO C-11.

WE'VE HAD SOME GOOD CAPTAINS IN C-11 AND HE'S GREAT ALREADY. SO THANK YOU, AND THANK YOU TO THEM.

I JUST HAVE A FEW QUESTIONS, AND THEN SOME COMMENTS.

BUT ONE IS, FOR THE BODY CAMERAS, WHERE ARE WE WITH THAT? WHAT -- WHEN WILL IT BE ROLLED OUT?

WHAT'S THE PROCESS RIGHT NOW? WHAT UNITS.

WHO WILL BE OUTFITTED, WHERE? ARE WE THERE YET?

>> WELL, COUNCILOR I THINK WE'RE WAITING FOR ANTHONY BRAGGER AND JACK McDEAF IT'S FINAL REPORT TO COME OUT IN JUNE.

I THINK THE PRELIMINARY REPORT SHOWED BASICALLY THAT WE DID HAVE A SLIGHT DECREASE IN THE USE OF FORCE, AS WELL AS A SLIGHT DECREASE IN THE COMPLAINTS AGAINST OFFICERS, SO, YOU KNOW, THE MAYOR HAS LOOKED LIKE HE'S TRENDING IN THAT POSITION, BUT I THINK WE'RE WAITING FOR THE FINAL REPORT. BUT, I THINK, YOU KNOW, ALLOCATING \$2 MILLION SHOWS THAT WE'RE MOVING IN THAT DIRECTION. SO I THINK THE SOCIAL JUSTICE

TASK FORCE WILL MEET IN LIKE TWO OR THREE WEEKS.

I THINK TOGETHER WE'RE GOING TO MAKE THOSE DECISIONS, WHERE WE'RE GOING WITH IT.

AND HOW WE'RE GOING TO IMPLEMENT IT, AND WHERE WE'RE GOING TO START.

>> OKAY.

- >> BECAUSE WE WANT COMMUNITY INPUT ON THIS VERY SUBJECT. YOU KNOW.
- >> SO THE GOAL THEN IS TO WAIT FOR THE REPORT TO BE RELEASED. >> AND THEN WE'LL SIT DOWN WITH THE SOCIAL JUSTICE TASK FORCE, AND SEE HOW WE WANT TO IMPLEMENT IT.
- >> \$2 MILLION, OBVIOUSLY, IS ONLY GOING TO COVER SO MUCH. >> RIGHT.
- >> ONLY GOING TO COVER SO MANY OFFICERS.

SO I'M ASSUMING IN THOSE
CONVERSATIONS WE HAVE TO DECIDE
ONE, WHAT UNITS WILL BE
INCLUDED, WHAT LOCATIONS, HOW
MANY OFFICERS \$2 MILLION COULD
OUTFIT, AND THEN HOW WE GO ABOUT
PHASING IN ADDITIONAL OFFICERS
UNTIL EVERYONE IS OUTFITTED.
SO, LOOKING FORWARD TO STARTING
THE CONVERSATION AT SOCIAL
JUSTICE TASK FORCE.
ARE WE IN COMMUNICATIONS NOW

WITH THE VARIOUS BARGAINING
UNITS RELATED TO THIS?

>> I THINK THE MAYOR'S HAD AT
LEAST CONVERSATIONS ABOUT IT.
I DON'T THINK THERE'S BEEN ANY
NEGOTIATION.

## >> OKAY.

AND I'M ASSUMING AT SOME POINT,
NOT JUST PATROLMEN FOR EXAMPLE,
REPORTING FOR THE PILOT, BUT THE
DETECTIVES WERE NOT, WE HEARD
SOME CONCERNS AROUND THAT, I'M
ASSUMING AT SOME POINT BECAUSE
THE GOAL IS TO OUTFIT EVERYONE,
THAT ALL OF THE BARGAINING UNITS
WILL BE INVITED TO PARTICIPATE
IN SOME WAY IN THESE
CONVERSATIONS, TOO?
>> SURE.

IT'S GOING TO IMPACT EVERYBODY. >> LOOK FORWARD TO ONGOING CONVERSATIONS IN THE FINAL REPORT COMING OUT IN JUNE. FOLLOWING UP ON COUNCILOR WU'S QUESTION RELATED TO THE GRANTS, PARTICULARLY THE GRANTS COMING OUT OF THE FEDERAL GOVERNMENT, OR SUPERINTENDENT DALEY PROMISE SOMETHING AND I THINK THEY'RE JUST LIKE HOLDING OUR MONEY, UNFORTUNATELY, AND SADLY, WHAT HAPPENS, AND I THINK IT IS WORST CASE SCENARIO, WHAT HAPPENS IF WE FIND OUT THAT WE DON'T GET THAT MONEY?

THEN IS IT A CONVERSATION WITH US IN TERMS OF LOOKING INTERNALLY AT BPD TO COVER SOME OF THOSE?

AND IF NOT, HOW CAN THIS BODY ADVOCATE WITH BPD AND YOU GUYS TO FIND RESOURCES ELSEWHERE, IF THERE ARE NO RESOURCES INTERNALLY TO COVER THESE IMPORTANT GRANTS?

>> I THINK PRIMARILY THE CONCERN IS AROUND POSITIONS THAT ARE GRANT FUNDED.

ESPECIALLY UNDER THE JAG GRANT. SO WE WOULD LOOK FOR WAYS TO EITHER REALLOCATE PERSONNEL OR TO FIND ADDITIONAL POSITIONS TO, YOU KNOW, TO TAKE ON THOSE ROLES.

THAT WOULD BE THE IMPACT.

>> I IMAGINE A DEVASTAING ONE
IF YOU'RE ASKING FOLKS WHO
CURRENTLY PROBABLY OVERWORKED,
AND DOING A LOT ALREADY, TO TAKE
ON THE RESPONSIBILITY OF
POSITIONS THAT MAY NOT BE
FUNDED.

>> YES, YES.

>> WE'LL LOOK FORWARD TO STAYING IN CONTACT WITH YOU GUYS IN THE GRANT DIVISION ABOUT THIS.
IT'S FRANKLY, SAD, AND I'M SAD AND FRANKLY UNACCEPTABLE.
BUT IT IS WHAT IT IS.
AND THANK YOU FOR YOUR ADVOCACY IN PUSHING THE GOVERNMENT TO GIVE US OUR MONEY.
LASTLY, A COUPLE MORE QUESTIONS

RELATED -- FIRST OF ALL, THANK YOU, AND LISA, AND THE DIVISION FOR THE WORK ON THE YOUTH DEVELOPMENT GRANTS.

THE MAYOR'S AWARE OF THIS, NEAL, AS WELL FROM IGR, MY HOPE WAS TO SEE THAT DOUBLED, JUST GIVEN THE FACT THAT WE HAD OVER 100 ORGANIZATIONS APPLY FOR FUNDING, WHICH ACCEPT STRAIGHTED THAT FRANKLY, I THINK THERE'S A NEED. PEOPLE WERE EXCITED TO SEE THE CITY COME UP WITH SOME FUNDING TO HELP THEM.

EVEN THOUGH THEY COULD PROBABLY USE A LOT MORE MONEY.

BUT IT MADE A DENT FOR THE ORGANIZATIONS THAT DID RECEIVE IT.

PEOPLE WERE TALKING ABOUT NOT JUST THE POLICE DEPARTMENT, BUT THE CITY AS BEING PRO-ACTIVE IN HELPING ORGANIZATIONS THAT SERVE OUR YOUTH.

BUT NOT JUST YOUTH WHO ARE IDENTIFIED AS AT-RISK, I THINK THE FRUSTRATION IN THE BEGINNING WHEN THEY EVEN STARTED THE CONVERSATION, THAT A LOT OF YOUTH ORGANIZATIONS SERVING YOUTH THAT THEY DID NOT DEFINE AS AT-RISK WHO STILL NEEDED SUPPORT AND SERVICES.

THIS IS A GREAT WAY TO MEET THAT NEED.

I'M GOING TO KEEP PUSHING HOPEFULLY TO DOUBLE THAT AMOUNT SO WE COULD REACH MORE ORGANIZATIONS, JUST PUTTING THAT OUT THERE.

BUT THANK YOU GUYS FOR THE WORK THAT YOU GUYS DID OVER THE SUMMER, PARTICULARLY WHEN I WAS HAVING A CHILD.

I REALLY APPRECIATE IT.

AND HOPPING ON PHONE CALLS WITH YOU GUYS.

SUPERINTENDENT LISA HOLMES AND SO MANY OTHER GREAT OFFICERS ARE EITHER GONE, OR ON THEIR WAY

IS THERE ANYONE, DO WE KNOW WHO IS REPLACING SUPERINTENDENT HOLMES YET?

>> NOT YET.

RIGHT NOW, CAPTAIN --

- >> AND YOU KNOW SHE'S LEAVING --
- >> SLEAZE GONE.
- >> SHE'S NOT COMING BACK.
- >> SHE'S GONE.
- >> I KNOW HER RETIREMENT IS COMING UP.
- >> IT'S COMING UP.

AND SUPERINTENDENT JOE HARRIS --

>> YES.

>> WE'RE ABOUT THE LAST PEOPLE STANDING HERE.

SO IT'S UNFORTUNATE WE LOST SO MUCHKNOWLEDGE.

BUT, YOU KNOW, I THINK ME AND

THE CHIEF WILL BE SITTING DOWN

WITH THE MAYOR SHORTLY AND JUST

SEEING, YOU KNOW, GOING OVER THE

COMMAND STAFF AND, OBVIOUSLY,

LOOKING TO GET THE BEST AND

BRIGHTEST TO LEAD THE CITY

FORWARD.

OBVIOUSLY, AND MAKE SURE, YOU KNOW, WE HAVE A GOOD-- YOU KNOW, CROSS-DIVERSITY OF WOMEN, AFRICAN AMERICANS, LATINOS,

THROUGHOUT OUR COMMAND STAFF.

>> I APPRECIATE THAT.

AND SUPERINTENDENT HOLMES WAS AN INCREDIBLE LEADER.

HARRIS, THE SAME THING.

WE WERE ABLE TO HONOR HIM AT ONE OF THE CIVIC ASSOCIATION MEETINGS.

AND I THINK THE CAPTAINS IN THE BEGINNING, BUT I WANT TO THANK THE COMMUNITY SERVICE OFFICERS WHO COME TO THE CIVIC

ASSOCIATION MEETINGS OFTEN.

YOU COME TO SOME OF THEM AS WELL, I KNOW.

SO I APPRECIATE THAT.

MOST FOLKS DON'T USUALLY KNOW YOU GUYS ARE AT THESE MEETINGS.

BUT IT IS A BIG DEAL, AND I MY RESIDENTS, PARTICULARLY THE

FOLKS IN MATTAPAN, APPRECIATE WHAT YOU DO.

SPEAK OF DIVERSITY-- I HAVE MY
PARTNER IN CRIME-- NO PUN
INTENDED-- COUNSELOR McCARTHY
AND I TAKING ON THE NUMBER OF
WOMEN AND FOLKS OF COLOR WHO ARE

OFFICERS IN THE CITY OF BOSTON,

AND WORKING ON SHORT-TERM AND LONG-TERM SOLUTIONS TO MAKE SURE IT'S MORE REPRESENTATIVE OF THE CITY OF BOSTON.

AND NOT JUST AT THE ENTRY LEVEL, BUT ALSO AT THE HIGHER TIER LEVELS-- SUPERINTENDENTS, CAPTAINS.

I THINK THERE ARE SOME SHORT-TERM SOLUTIONS TO CHANGE THESE NUMBERS, SO WE'RE NOT TALKING ABOUT THEM IN THREE OR FIVE YEARS.

AND THEN I THINK THERE ARE SOME LONG-TERM SOLUTIONS THAT I THINK THE CITY MIGHT WANT TO TAKE ON THAT INTERFACE OR REQUIRE US TO CONNECT WITH THE STATE, MAYBE IT'S REVIEWING CIVIL SERVICE AND HOW IT SHOWS UP.

BUT THE GOAL IS, ONE, TO DO IT IN PARTNERSHIP, TO NOT DO IT SEPARATELY, TO HAVE PUBLIC SAFETY AGENCIES COME TOGETHER, INCLUDING THE CHIEF AND COMMISSIONER FLYNN, UNDERSTANDING THAT THERE ARE DIFFERENT PRACTICES AMONG EACH AGENCY.

BUT WITH I DO THINK, BASED ON WHAT WE'VE LEARNED SO FAR, THERE'S A SHARED GOAL AMONGST ALL OF THE AGENCIES TO MAKE SURE THAT THE NUMBERS ARE REPRESENTATIVE OF THE POPULATION.

AND I TOLD THIS TO COUNSELOR McCARTHY, I'M SORT OF DONE MEETING WITH PEOPLE IN SILOS, WHETHER IT'S VETERANS OVER HERE OR FOLKS OF COLOR, OR OTHERS WHO JUST CARE ABOUT THIS ISSUE, AND LIVE IN THE CITY OF BOSTON AND WANT TO HAVE MORE WOMEN OR BE MORE REFLECTIVE AND REPRESENTATIVE.

THE GOAL IS TO BRING US TOGETHER OVER A SERIES OF DATES, OVER THE NEXT FURYK OR SEVERAL MONTHS, AND TO SIT DOWN AND TALK ABOUT WHAT YOU'RE CURRENTLY DOING SOMEWHAT SOME PEOPLE DON'T KNOW ABOUT, THAT ARE WORKING, AND WHERE YOU SEE SOME OF THE

BARRIERS ARE.

MICHAEL GASKINS HAS BEEN INCREDIBLE GETTING US INFORMATION AND DATA. THAT'S VERY HELPFUL IN YOUR HUMAN RESOURCES DEPARTMENT. SO THANK YOU.

THIS IS JUST TO SAY THANK YOU AND LOOKING FORWARD TO THOSE CONVERSATIONS.

- >> OKAY, THANK YOU.
- >> THANK YOU, COUNCILOR CIOMMO. THANK YOU, GUYS, GUY.
- >> COUNCILOR FLATTER.
- >> THANK YOU, COMMISSIONER, TO YOUR TEAM.
- I THINK YOU DO COMMUNITY
  POLICING BETTER THAN ANYBODY.
  IT'S A GREAT REFLECTION ON OUR
  CITY.

WE'RE THE ENVY OF OTHER
JURISDICTIONS IN TERMS OF HOW WE
HANDLE PHONE CALLS, HOW WE
RESPOND TO COMMUNITY-BASE
INITIATIVES, AND ALSO YOU'RE A
GREAT PARTNER FOR THE CITY, SO I
APPRECIATE YOUR TIME AND TALENT,
AS WELL AS THE TEAM YOU'VE
ASSEMBLED.

I WANT TO STATE BRIEFLY ON THE AGE.

THIS HAS NOTHING TO DO WITH GROUP 4.

WE HAVE MANDATORY RETIREMENT AT AGE 65.

65, MAYBE 30 YEARS AGO, MIGHT HAVE BEEN THE END OF THE ROAD FOR SOME FOLKS.

WHY NOT SAY 67, WHY NOT 69? WHY NOT 70?

I KNOW THE JUDICIAL CUTOFF, JUDGES HAVE MANDATORY RETERMT AT 70.

I'M SURE JUDGES COULD GO TO 72, 73.

SO PEOPLE LIKE YOU THAT RUN IN MARATHON IN THEIR 60s.

SO I DIDN'T KNOW WHETHER OR NOT ANY THOUGHT HAS GONE INTO THAT, IF PEOPLE ARE BURNED OUT, AND IT'S TIME TO BRING IN THE NEXT GENERATION.

THAT'S ONE THING.

BUT I LOOK AT IT FROM A TALENT

AND EXPERIENCE PERSPECTIVE, BUT IF WE'RE LOSING GREAT LEADERS BECAUSE THERE IS MANDATORY RETIREMENT, YOU KNOW, THERE IS STL AN OPPORTUNITY THROUGH SOME LEGISLATION OR CITY ORDINANCE TO CHANGE THAT TO 65 NORTH. AND I DON'T KNOW WHAT THAT NUMBER IS.

IS IT 67?

IS IT 69?

I DON'T THINK IT SHOULD BE 65.

I THINK IT SHOULD BE A DIFFERENT NUMBER.

>> WHEN YOU LOSE PEOPLE LIKE JOE HARRISON AND LISA HOLMES-- LISA WASN'T AT MANDATORY AGE RETIREMENT.

LIKE YOU SAID, THERE ARE A LOT OF GOOD PEOPLE WHO GO KICKING OUT THE DOOR BECAUSE THEY LOVE WHAT THEY DO, AND THEY'RE VERY VALUABLE.

YOU KNOW, YOU LOOK AT OTHER, YOU KNOW, STATE, POLICE STATE DID AWAY WITH THEIR RETIREMENT. AT ONE TIME THEY WERE 50. AND THEN WHEN THEY MERGED WITH THE M.D.C., AND WHATNOT, I THINK THEY DID AWAY WITH THEIR RETIREMENT.

SO I'D LOVE TO SEE IT BECAUSE WE WOULDN'T LOSE SO MANY PEOPLE. BUT, AGAIN, THAT'S-- THAT'S FOR YOU GUYS.

WHATEVER YOU CAN DO.

I MEAN, I HATE TO LOSE PEOPLE WHO ARE STILL CAPABLE OF DOING THE JOB BECAUSE THEY HAVE SUCH KNOWLEDGE.

THEY HAVE SUCH EXPERIENCE, AND YOU DON'T HAVE TO GO THROUGH THE WHOLE IDEA OF TRAINING SOMEONE FOR SIX MONTHS.

>> IF I RECALL, I LED THE EFFORT TO MOVE IT, AND MAYBE WE CAN HAVE TALKS ON THE BACKEND WITH YOUR TEAM.

SO IT'S-- IT MAY BE WORTH A CONVERSATION.

AGAIN, I DON'T KNOW WHAT THAT NUMBER IS.

AND IT'S GOING TO MEAN DIFFERENT THINGS TO SOME PEOPLE.

SOME PEOPLE HAVE DONE THEIR TIME OF SERVICE, AND, LIKE, LISA, AND TIME FOR HER TO TAKE ADVANTAGE OF ALL, YOU KNOW, HER SWEAT EQUITY, AND SHE WANTS TO RELAX AND ENJOY HER RETIREMENT.
AND THERE ARE OTHERS THAT MAY HAVE SOME GAS 11 IN THE TANK, AND THEY WANT TO THAT TO TO ADD VALUE.

I THINK THE TIME HAS COME THAT WE MAYBE MOVE OFF OF THE MANDATORY RETIREMENT AT 65 AND JUST PARTICULAR A NUMBER THAT'S NORTH OF THAT, FOR A VARIETY OF DIFFERENT REASONS.

SO IF YOU WOULDN'T MIND AT SOME POINT, WE'LL HAVE A CONVERSATION, AND I'LL REACH OUT TO THE LEADERS BEHIND ME FROM B.P.P.A., THE DETECTIVES, AND SUPERIOR OFFICERS AND GET A SENSE WHETHER OR NOT THERE'S ANY APPETITE FOR THAT.

STAYING ON THAT, AND SOMETHING I THINK WE NEED TO BE CONSCIOUS OF THROUGH THE CHAIR OF WAYS AND MEANS IS WE SEE A LOT OF JUMPING FROM THE ACADEMIES.

YOU'LL HAVE FOLKS THAT GO THROUGH THE POLICE ACADEMY AND THE MINUTE THE FIRE ACADEMY STARTS THEY JUMP.

- I WOULD LIKE TO HAVE A COORDINATED EFFORT BETWEEN THE POLICE ACADEMY AND THE FIRE ACADEMY, START THEM AT THE SAME TIME.
- I KNOW WE HAVE THE ABILITY, THEY'RE TWO SEPARATE ACADEMIES LOCATED IN TWO SEPARATE PART OF THE CITY.
- I THINK WE CAN WALK AND CHEW GUM.
- I HATE TO HAVE A SITUATION WHERE SOMEONE TAKES US A PRECIOUS SPOT, GET IN GREAT SHAPE, AND THE MINUTE THE MOMENT RINGING THEY'RE HOPING.

IF THERE'S EVER A WAY THAT WE AS A CITY COULD COORDINATE THROUGH CIVIL SERVICE WHERE WE HAVE THESE EXAMES, AND WE ALSO HAVE THESE ACADEMIES STARTING AT THE

SAME TIME, I THINK WE'LL SEE COST SAVINGS FOR OUR CITY. NOTHING WORSE THAN GOING THROUGH RECRUITING INVESTIGATION, DRUG TESTING, PSYCHE TESTING, THE P.A.T., START THE ACADEMY AND SOMEONE IS IN THERE FOR SIX, EIGHT, 10 WEEKS, AND THEY GET THE POSTCARD IN THE MAIL SAYING THEY CAN JUMP AND GO TO THE FIRE DEPARTMENT AND THEY JUST LEAVE. AND THERE'S AN EMPTY SEAT THERE THAT SOMEONE IS WORKING THEIR WHOLE LIFE, THEY'VE GONE TO SCHOOL, HAVE A CRIMINAL JUSTICE DEGREE.

BUT THEY'RE ON THE OUTSIDE LOOKING IN.

ON THE BACK END OF THAT QUESTION, TO HAVE THE ABILITY TO BACKFILL THOSE SEATS.

I KNOW YOU DON'T WANT TO-- YOU DON'T WANT TO BE OUT OF THE ACADEMY TOO LONG BEFORE YOU MISS OUT ON IT.

IS THERE A STOP DATE?

IS IT TWO WEEKS?

IS IT THREE WEEKS?

IS IT A MONTH?

IF WE HAVE SOME FLEXIBILITY WHERE WE COULD BACK-FILL THOSE SEATS, I THINK THAT WOULD BE A HUGE SERVICE, AS WELL AS THE COST SAVINGS, BECAUSE WE'VE ALREADY DONE THE RECRUIT INVESTIGATION ON THAT CANDIDATE. >> I THINK, COUNCILOR, MOST OF THE CANDIDATES WE SEEM TO BE LOSING TO THE FIRE ARE TWO, THREE YEARS ON THE JOB. WE DON'T GET A WHOLE LOT WHERE THEY'RE ACTUALING SITTING IN THE ACADEMY-- I DON'T THINK THAT'S BEEN TOO MUCH OF AN ISSUE. WE'RE LOSING THEM SOMETIMES TWO, THREE, FOUR YEARS ON OUT OF THE ACADEMY.

- >> THAT'S EVEN WORSE.
- >> YEAH.
- SO THAT'S THE PROBLEM.

WE TRAIN THEM UP FOR SIX MONTHS, AND WE JUST HAD ONE INDIVIDUAL, HE LEFT OUR JOB, WENT ON THE FIRE, AND DECIDED HE DIDN'T LIKE THE FIRE AND WANTS TO COME BACK. YOU KNOW, SO THE JUMPING AROUND, I MEAN MAYBE WE CAN MAKE THEM SIGN THAT THEY'RE COMMITTED TO THIS JOB FOR FIVE YEARS OR SOMETHING.

BECAUSE IT'S MORE OF A PROBLEM FOR US AS OPPOSED TO THE FIRE LOSING PEOPLE HOPPING OVER TO OUR JOB.

AND SD, YOU KNOW, WHATEVER WE CAN DO IT, BECAUSE IT IS FRUSTRATING FOR US.

YOU KNOW, I GREW UP IN THE CITY. YOU DID.

PEOPLE WOULD LOVE TO BE ON EITHER JOB, BUT FOR SOMEONE TO GET TWO BITES AT THE APEXPEL PLAY SORT OF GAMES, I'M 100% BEHIND YOU.

>> I AGREE WITH THAT.

AND THERE'S A FOR RESPONSE WE HAVE TO THE TAXPAYER, A FIDUCIARY RESPONSE.

AND TO YOUR POINT, IF WE'RE LOSING FOLKS THAT COME ON TWO OR THREE YEARS, WE'RE LOSING STREET TRAINING AS WELL.

ANOTHER AREA THAT IS VERY PERPLEXING, AND I LOOK FORWARD TO WORKING WITH YOU AND THE SUPERIOR OFFICE WHERE'S WE HAVE SERGEANT DETECTIVES, LIEUTENANT DETECTIVES, CAPTAIN DETECTIVES, SUPERVISING DETECTIVES, YET, THEY'VE NEVER BEEN A DETECTIVE. I THINK THAT IS SO UPSEED DOWN. I THINK YOU COME OUT OF THE ACADEMY, YOU START OFF AS A NEW OFFICER.

I THINK THAT AFTER A SPECIFIC PERIOD OF TIME, WHEN YOU'RE ELIGIBLE TO TAKE PROMOTIONAL EXAMS, I THINK THAT TRAJECTORY, I THINK YOU SHOULD HAVE TO MAKE A DECISION.

DO YOU WANT TO GO THE SERGEANT-LIEUTENANT-CAPTAIN ROUTE, OR DO YOU WANT TO GO THE DETECTIVE ROUTE.

IF YOU GO THE DETECTIVE ROOT, YOU CAN GO THE

SERGEANT-DETECTIVE ROUTE.

MAYBE IF YOU'RE BURNED OUT AND

WANT TO TRY BEING A DETECTIVE OR YOU'RE BURNED OUT BEING A DETECTIVE, THAT THERE'S SOME MECHANISM.

I THINK IN ANY SITUATION,
WHETHER IT'S IN GOVERNMENT OR IN
THE PRIVATE SECTOR, WHERE YOU
WOULD HAVE PEOPLE SUPERVISING
INDIVIDUALS WHO HAVE ACTUALLY
NEVER DONE THE JOB.
IT'S JUST-- IT JUST DELETES

IT'S JUST-- IT JUST DEIFIES LOGIC FOR ME.

I DON'T KNOW IF THERE'S A COST SAVE, JUST FROM I GUESS A CHAIN OF COMMAND STANDPOINT AND/OR FROM AN ORGANIZATIONAL STRUCTURE STANDPOINT.

TO ME, THAT'S JUST-- IT JUST DEIFIES LOGIC.

I DON'T KNOW WHETHER OR NOT YOU HAVE AN OPINION ON IT.

AND I ALSO DON'T EVEN KNOW WHAT THE MECHANISM IS BY WHICH TO DO THAT.

I THINK WE HAVE A SITUATION WHERE YOU'RE EITHER GOING TO GO DOWN THAT ROAD OR YOU'RE GOING TO GO DOWN THIS ROAD. AND WHEN WE HAVE A SITUATION

AND WHEN WE HAVE A SITUATION WHERE--

>> I MEAN, A COUPLE OF THINGS ON THAT.

OBVIOUSLY, IT SORT OF HINDERS SOMEONE'S DEVELOPMENT.

THERE AREN'T ENOUGH SERGEANT DETECTIVES, AS OPPOSES TO REGULAR SERGEANT.

WE HAVE PROBABLY OVER 200, 300 SERGEANTS.

WE HAVE SERGEANT DETECTIVES, THE NUMBERS ARE A LOT LOWER.

WE HAVE 10, 11 SERGEANTS EACH DIRECT, AND THERE ARE ONLY TWO SERGEANT DETECTIVES.

I DON'T KNOW IF THAT'S AN AVENUE THAT THE UNIONS WOULD WANT BECAUSE IT WOULD-- BASICALLY, IF YOU'RE JUST GOING TO TAKE A DETECTIVE TRACK, THERE'S NOT GOING TO BE AS MANY JOBS OUT THERE, COUNCILOR.

YOU KNOW WHAT I MEAN?

>> YEAH, BUT IN THOSE SITUATIONS

-- BUT-- SO IF YOU GET DETECTIVE

ROUTE, AND YOU ARE A DETECTIVE, THEN THE PROMOTIONAL OPPORTUNITY FOR YOU WOULD BE SERGEANT DETECTIVE, LIEUTENANT DETECTIVE, CAPTAIN DETECTIVE.

>> WHAT I'M SAYING IS THERE ARE NOT A WHOLE LOT OF THOSE JOBS.

>> IT REALLY HINDERS YOUR

DEVELOP THE IN THE DEPARTMENT BECAUSE THERE ARE ONLY SO MANY CAPTAIN DETECTIVES.

LAWYER ONLY SO MANY LIEUTENANT DETECTIVES.

SO IF YOU CHOOSE--

>> THERE WOULD BE A LOGJAM OF DETECTIVES?

>> RIGHT.

THEY'D ALL BE-- BECAUSE VERY RARELY DOES A SERGEANT DETECTIVE JOB OPEN.

THE SERGEANT JOBES, THE LIEUTENANTS, THERE'S A LOT MORE TURNOVER.

SO IT WOULD REALLY HINDER SOMEONE'S DEVELOPMENT IN THE DEPARTMENT.

I DON'T KNOW IF ANYONE WOULD WANT THAT.

BUT, ALSO, WHAT WE'RE DOING NOW MORE THAN ANYTHING IS WE'RE PUTTING PEOPLE INTO THOSE POSITIONS WHO REALLY EARNED IT, YOU KNOW.

>> THAT'S FAIR.

>> YOU KNOW, LIKE, YOU KNOW, JOHN DININE WAS IN DISTRICT SUX. HE'S A GREAT WORKER.

HE PUT HIM IN THE POSITION OF SERGEANT DETECTIVE.

JOHN TARANTINO.

FOR THE MOST PART, WHO IS GOING INTO THOSE POSITIONS RIGHT NOW ARE GUYS WHO REALLY SHOW US THAT THEY HAVE ALL THE POTENTIAL.

AND A LOT OF THESE GUYS, BELIEVE IT OR NOT, THEY'RE EITHER IN THE DRUG UNIT, THE GANG UNIT, WHO HAVE EXHIBITED THOSE VERY QUALITIES YOU'RE TALKING ABOUT, BEFORE WE PUT THEM IN THERE.

WE DON'T WANT PEOPLE WHO HAVE NEVER - LIKE MYSELF.

I'VE NEVER BEEN IN THE DETECTIVE BRANCH.

YOU KNOW, I COULDN'T TELL YOU ANYTHING.

I SORT OF STAY OUT OF THE YELLOW LINE WHEN I GO THERE.

YOU KNOW, I HAVE NO BUSINESS GOING INTO THAT FIELD.

BUT WE LOOK RIGHT NOW AT PEOPLE WHO REALLY HAVE THAT TYPE OF KNOWLEDGE, AND WE PUT THEM IN THAT POSITION.

>> OKAY.

AND THEN JUST BRIEFLY ON-- I GUESS ON TRANSPORTATION AND TRAFFIC.

YOU KNOW, IT'S OBVIOUSLY A
B.P.T. ISSUE, BUT IT'S A B.P.D.
ISSUE, BECAUSE WE THAT ENFORCE
THE CHAPTER 90 REGULATIONS.
AND I DON'T KNOW WHETHER WE HAVE
AN OPPORTUNITY THROUGH THE
BUDGET TO BEEF UP OR ENHANCE THE
TRAFFIC DIVISION.

I GUESS EACH DISTRICT HAS SORT OF A TRAFFIC OFFICER, IF YOU WILL.

ANYWHERE YOU GO, YOU WALK OUT HERE, COMMISSIONER, IT'S JUST GRIDLOCK.

MASS. AVE. IS GRIDLOCK.
HYDE PARK AVE. IS GRIDLOCK,
CENTRE STREET IS GRIDLOCK,
WHETHER BLOCKING OF THE BOX OR
HAVING SOMEONE THAT CAN HANDLE
OR MANAGE TRAFFIC.

I DON'T KNOW WHETHER OR NOT THERE'S AN OPPORTUNITY TO BEEF UP THAT.

AND IT CAN'T JUST BE SOMEONE WHEN IS LOOKING FAIR QUICK FOUR HOURS OF OVERTIME.

IT HAS TO BE SOMEONE PASSIONATE ABOUT TRAFFIC AND CAN KIND OF MOVE THE FLOW.

OR MAYBE WE COULD USE OUR CADETS.

I KNOW YEARS AGO, WE USED OUR CADETS.

PERFECT EXAMPLE, SOUTH STATION THAT PTHAT WHOLE AREA, SUMMER STREET, ATLANTIC AVE., IT'S A DISASTER MORNING, NOON, AND NIGHT.

AND HAVING SORT OF SOMEONE THERE IN UNIFORM-- I DON'T WANT TO GET

INTO THE UNIFORM VERSUS THE FLAG-MAN ARGUMENT-- BUT I THINK WE HAVE AN OPPORTUNITY HERE TO PARTNER WITH THE CITY TO SORT OF SOLVE A MAJOR TRANSPORTATION INFRASTRUCTURE DEFICIENCY, WHICH IS TRAFFIC.

AND WE CONTINUE TO BRING MORE BUSINESSES HERE.

WE CONTINUE TO BRING MORE PEOPLE HERE, BUT, YET, WE'RE NOT SOLVING THAT PROBLEM.

I THINK EVERYONE THINKS PEOPLE ARE GOING TO WALK OR TACK A SKATEBOARD.

IT'S ELLOGICAL TO THINK THAT. PEOPLE NEED THEIR CARS.

BUT IF WE WANT TO CONTINUE TO ENCOURAGE COMMERCE TO COME HERE, I THINK THE POLICE DEPARTMENT NEEDS TO STEP UP AND BE A PARTNER AND SOLVING THAT PROBLEM.

WHETHER IT'S ENHANCING THE TRAFFIC DIVISION, TRAINING THE MEN AND WOMEN IN THE ACADEMY ON HOW TO HANDLE THOSE TRAFFIC SITUATIONS OR MAYBE USING OUR CADETS AND NEW RECRUITS TO FILL IN THAT POSITION TO HELP US OUT. >> AGAIN, IT IS A CONCERN. I THINK-- I TALK TO

TRANSPORTATION SECRETARY ALL THE TIME.

WE SEE HOW MANY MORE PEOPLE-- I THINK A STUDY CAME OUT RECENTLY ON UBER.

THERE ARE 100,000 MORE IN THE CITY.

AND, OBVIOUSLY, THAT'S AN ISSUE. THEY'RE JUST STOPPING ANYWHERE THEY WANT TO STOP.

THEY JUMP OUT IN THE MIDDLE OF THE STREET.

OBVIOUSLY, THEY'RE AN ISSUE.
, AND CLEARLY, THE CITY IS
BOOMING RIGHT NOW, AND WITH IT
IS THE TRAFFIC.

WE TRIED TO PUT OUR OFFICERS IN PLACES WHERE WE SEE PROBLEMS

LIKE BLOCK THE BOX.

THEY'RE CONSTANTLY UP AT

COMM AND MASS. AVE., WHICH IS A CONTINUOUS PROBLEM.

WE LOOK FOR THOSE LOCATIONS

WHERE WE CAN PUT THEM, AND THOSE SIEBLG GOES OUT THERE BASED ON

THOSE COMPLAINTS.

LIKE YOU SAID, EVERY STATION HAS A TRAFFIC OFFICER WHO TRIES TO--I THINK WE'RE OVERWHELMED RIGHT NOW WITH THE AMOUNT OF UBERS AND CONGESTION.

BUT IT'S A CONSTANT DIALOGUE BETWEEN THE MAYOR, AND MYSELF ON HOW WE CAN DO BETTER.

>> AND THERE'S ALSO A SKILL SET TO IT.

IT CAN'T JUST BE SOMEONE LIKE, "COME ON!"

IT HAS TO BE SOMEONE WHO IS IN TO IT.

>> YOU WANT TO SHOW ME HOW TO DO IT, GET OUT THERE?

>> THERE ARE TIMESSENT TO GET OUT OF THE CAR, COMMISSHOULD,. I'M NOT SURE THERE ARE ENOUGH OF

THEM OR HOW MUCH TIME WE SPEND TRAINING THE CADETS.

I WOULD LOVE TO BE ABLE TO DEPLOY THE CADETS TO SOUTH STATION, NORTH STATION, EVERY

>> I THINK LISA HOLMES DID DO THAT, PULLED THEM OUT FOR A DAY AND DO THAT TRAFFIC.

AGAIN, IF I HAD 3,000 OFFICERS I COULD PROBABLY ESTABLISH A TRAFFIC DIVISION.

>> THAT'S THE KEY.

ANY THOUGHTS IN TERMS OF-- AND CONGRATS ON THE RECEIPT ARREST ON THOSE TWO INDIVIDUALS, THE RECENT COLLEGE GRAD AND THE MILITARY VETERAN, MINDING THEIR OWN BUSINESS OVER THERE, AND YOU GUYS DID A GREAT JOB

INVESTIGATING AND LEADING TO A OUICK ARREST.

BUT I KNOW THE TEAM YOU HAVE IN TERMS OF THE COLD CASE SQUAD, AND JUST TRYING TO SOLVE SOME OF THE OLDER HOMICIDES, CAN YOU JUST GIVE US AN UPDATE?

AND THERE ARE A COUPLE RIGHT NOW IN FRONT OF THE GRAND JURY. THEY'RE DOING AN OUTSTANDING JOB, BUT I THINK WE COULD DO BETTER, OBVIOUSLY, IF WE HAD A LOT MORE COOPERATION.

I THINK THE MAJORITY OF THE CASES WE SAW IS THROUGH ELECTRONIC SURVEILLANCE THAN IT IS FROM COOPERATION.

YESTERDAY WAS A FINE EXAMPLE.
WE HAD MORE PEOPLE COME FORWARD,
GIVE OUT A DESCRIPTION, AND
WITHIN A MINUTE, WE HAD THE TWO
INDIVIDUALS WHO-- YOU KNOW, HE
SHOT A YOUNG KIDED IN THE FACE,

>> WE NEVER CEASE OUR CAMPAIGN FOR THE PUBLIC TO ASSIST US.

EVERY TIME THE COMMISSIONER OR MYSELF DO A SOUNDBITE, WE ALWAYS ASK FOR THE PUBLIC'S HEALTH.

>> AND WE'RE IN A DAY AND AGE WHERE WE'RE WATCHING "C.S.I."
ALL THE TIME, AND EVERYBODY THINKS IT WILL BE THE FIBER, AND YOU DO NEED EYEWITNESS TESTIMONY.

OBVIOUSLY, SURVANCE CAMERAS ARE VERY HELP ENVELOPE LEADING THAT EFFORT BUT PEOPLE NEED TO STEP UP AND PARTICIPATE.

FINALLY, ON THE CRIME STUFF, YOU AND I TOUCHED ON THIS THE OTHER DAY.

I BE THERE'S A LOT OF UNREPORTED CRIME TAKING PLAY THROUGHOUT OR NEIGHBORHOODS, AND WHETHER OR NOT YOU GUYS HAVE FOLKS TRACKING THE FACEBOOK TRAFFIC, IF YOU WILL, JUST TO KEEP A HANDLE ON, AND EITHER TAP INTO THOSE VIDEOS VIDEOS THAT PEOPLE ARE PUTTING ON-- IN MY NEIGHBORHOOD, THERE'S ONE EVERY NIGHT.

COUNCILOR FLYNN CAN ATTEST TO

BUT THEY ARE TAKING A FEW MINUTES TO UPLOAD IT AND PUT IT ON FACEBOOK AND NOTIFY THE NEIGHBORS AND SHAME THE INDIVIDUALS.

I DIDN'T KNOW WHETHER OR NOT YOU
WERE SEEING A TREND ACROSS THE
CITY AND/OR IF WE CAN FIEND A
WAY TO TRACK THAT AT ALL.
>> AGAIN, PEOPLE HAVE TO LEARNED
TO STEP UP AND COME DOWN AND

TO STEP UP AND COME DOWN AND REPORT IT OR CALL US.

I READ THE REPORTS ACROSS THE CITY EVERY DAY.

WHEN YOU BROUGHT THIS ISSUE UP TO ME, YOU KNOW, I SAID, WE DON'T HAVE A PROBLEM IN SOUTH BOSTON WITH CARS GETTING BROKEN INTO, BECAUSE I READ THE REPORTS AND I DON'T SEE IT.

BUT I HAVE TO TELL YOU I'M NOT ON FACEBOOK.

>> IT WILL BE A PART OF OUR INFORMATIONAL CAMPAIGN AS WELL.

IF PEOPLE EXPERIENCE CAR
BREAKS-- I KNOW THE DISTRICT
CAPTAINS AND COMMUNITY SERVICE

OFFICERS OFTEN PUT OUT PAMPHLETS

AND COMMUNICATE WITH THE READS RESIDENTS.

HARD ON IT, AS OTHER BOSTON
POLICE AS WELL, BUT WE DO HAVE
SOME PROBLEMS AT MOAKLEY PARK.
IT'S FRUSTRATING FOR THE SOUTH
BOSTON LITTLE LEAGUE PROGRAM, AS
YOU KNOW, TO USE THE PARK

  I WAS JUST CURIOUS ABOUT YOUR PLANS FOR THE GUN BUYBACK PROGRAM FOR FISCAL YEAR 2019, AND OVERALL.
- >> WE HAVE A LOT OF FUNDING. WE GOT FUNDING FROM PRIVATE SOURCES.

THANK GOD WE HAD THE MASS.
GENERAL, BOSTON CHILDREN'S
HOSPITAL-- WE HAD A COALITION OF
HOSPITALS STEP UP AND GIVE US A
GOOD AMOUNT OF MONEY TO HELP
SUPPORT OUR GUN BUYBACK.
SO A LOT OF OUR FUNDING HAS COME

PEOPLE WHO ARE AT EVERY
COMMUNITY MEETING AND THEY KNOW
THE KIDS.

LIKE COUNCILOR O'MALLEY WAS SAYING, THEY'RE IN THE COMMUNITY, THEY KNOW THE NEIGHBORHOOD GROUPS, THEY KNOW THE NEIGHBORHOOD LEADERS, AND THEY KNOW THE ISSUES GOING ON. THEY'RE INCREDIBLY RESPONSIVE, BUT I FEEL LIKE WE'RE BEING SO REACTIVE WITH OUR SPEEDING THROUGH THE NEIGHBORHOODS. IN ROSLINDALE, IT'S TIP KACIALG

ALL THE CUT-THROUGH STREETS. AND A LOT OF IT IS BECAUSE AS YOU KNOW, THE DEVICES SENDING PEOPLE OFF THE MAIN DRAGS. THEY DON'T KNOW THE NEIGHBORHOODS AND THEY'RE FLYING THROUGH THE SIDE STREETS. IF THERE'S ANYTHING WE CAN DO BUDGETARY-WISE, TO HELP OUT, GET MORE SPEED TRAPS, MORE COPS THAT CAN LOOK AT PEOPLE ROLLING THROUGH STOP SIGNS OR BARELY TOUCHING THEIR BRAKES GOING THROUGH STOP SIGNS, THAT WOULD BE INCREDIBLY HELPFUL. DRIVEWAYS IN HINGHAM OR IN DRIVEWAYS IN-- I GET THOSE CALLS LIKE, "THAT'S MY GAS MONEY." >> CERTAIN UNITS ARE 24/7, AND SO THEY HAVE TO BE AVAILABLE, CERTAIN SERGEANTS ON THE SWAT TEAM WHO MIGHT GET CALLED OUT TO A CODE 99, BARRICADED SUSPECT. WE NEED TO GET QUICKLY TO THE SEEN.

OUR CANINE OFFICERS, OBVIOUSLY, WHETHER THEY BE DRUG DOGS, BOMB DOGS, A LOT OF THE TACTICAL UNITS HAVE THE CAPABILITY TO BRING THEIR VEHICLE HOME.
OBVIOUSLY, THERE'S A LOT OF UNMARKED VEHICLES, THE SAME REASON.

A LOT OF THE DETECTIVES ARE ON CALL, SERGEANT DETECTIVEES, LIEUTENANT DXES, WHO RESPOND TO MAJOR CRIMES, WHETHER THEY'RE LATE AT NIGHT OR EARLY IN THE MORNING.

SO WE HAVE A COMPREHENSIVE LIST OF WHO IS AUTHORIZED.

WHATEVER THE ISSUE IS.

I JUST WANT TO MAKE SURE WHEN THESE PEOPLE CALL I HAVE A BETTER ANSWER THAN, "I HAVE NO IDEA."

THAT'S REALLY NOT A GOOD ANSWER. THE BIKE PATROL, AFTER READING A REPORT, I'M REALLY EXCITED ABOUT THE FACT WE'RE GETTING THE BIKES BACK.

WE HAVE, PARTICULARLY MAG CONLEY DOING IT IN HYDE PARK.

AND THEY WERE UNBELIEVABLE.

WHEN THE BIKES GOT PULLED OUT, WE LOST THAT.

GOING INTO TOT WERE MORE CRIMINAL INTENT THAN MOST OF THEM.

AND SO THEY DO A GOOD JOB

INCIDENT HAPPEN.
YOU KNOW, TOMMY, WORK WITH OUR

AND THEM, TO DO EXTENSIVE
TRAINING AROUND, HEAVEN FORBID
SOMETHING LIKE THAT HAPPEN, WHAT
EVERYBODY'S RESPONSIBILITIES
ARE.

BEEFING UP THE SCHOOL UNIT?
I DID THAT WHEN I BECAME
COMMISSIONER, AND I'LL CONTINUE
TO DO IT BECAUSE IT'S SO

WATCHES THIS.

BUT LISA AND I MET 25 YEARS AGO WHEN I FIRST STARTED WITH THE CITY, AND WE'VE BEEN FRIENDS EVER SINCE.

SO I JUST WANT TO WISH HER THE BEST OF THE BEST FOR A LONG AND HEALTHY RETIREMENT.

>> I DON'T THINK SHE'S GOING AWAY.

I THINK SHE'S GOING TO TRY TO HELP OUT, BELIEVE IT OR NOT, WITH A LOT OF THE NONPROFITS. >> YEAH, I WOULDN'T BE SURPRISED.

>> YEAH.

WE DID A GREAT EVENT UP IN YOUR

AREA ABOUT TWO WEEKS AGO, SHE ABOUT 30 BIG SISTERS, AND SHE DOES THAT.

SHE DOES A GREAT JOB WITH THAT PROGRAM.

I DON'T THINK-- SHE MIGHT HAVE LEFT THIS JOB, BUT HER HEART IS IN HELPING THE YOUNG KIDS AROUND THE CITY.

I THINK WE'LL STILL SEE HER AROUND.

>> ALL RIGHT, SOUNDS GOOD. THANK YOU.

GREAT.R BAKER.

>> MR. CHAIR, GOOD MORNING COMMISSIONER, AND YOUR TEAM. THANK YOU FOR COMING OUT, FOR ALL YOU MEN AND WOMEN DO FOR THE CITY.

CAN YOU TALK OF THE LICENSE PLATE READERS A LITTLE BIT? WHAT DO THEY LOOK LIKE, A SHOT SPOT?

BUT ALSO, PLACES LIKE COPLEY SQUARE WHERE YOU WORRY ABOUT TERRORISM, WHERE THE MARATHON, DOWN AROUND THE TRANSPORTATION HUBS, WHERE SOUTH STATION, KNOTS STATION, HEAVEN FORBID WE HAVE AN INCIDENT.

HAVING THAT ABILITY TO CATCH ONE OF THE INDIVIDUALS THAT MIGHT BE INVOLVED IS KEY.

WHETHER IT'S LONDON, NEW YORK, ALL THE BIG CITIES HAVE THEM. >> YEAH.

>> I DON'T EVEN KNOW, NEW YORK PROBABLY HAS, YOU KNOW, A THOUSAND OF THEM UP THERE.

>> THAT NIGHT THAT WE HAD THAT SHOOTING.

>> YEAH.

>> WE HAD ACCESS TO THOSE CAMERAS RIGHT AWAY.

WE WERE OUT THERE, AND WE WERE ABLE TO BRING UP --

>> WE DIDN'T HAVE TO ASK FOR IT.

>> YEAH.

>> DO WE HAVE ANY MONEY SET
ASIDE FOR ACTUAL CAMERAS OR ARE
WE JUST GOING TO TRY AND
PRIVATELY FUND THEM?
WHAT'S THE PLAN NOW?
>> IN THE BHA WE DO.
THE MAYOR HAS COMMITTED OVER \$1
MILLION.

>> IS THAT OUR ONLY PLACE WE HAVE MONEY FOR CAMERAS?

>> I BELIEVE SO.

RIGHT NOW WE DO.

I MEAN, WE'RE CONTINUALLY WORKING WITH EVEN PRIVATE BUSINESSES.

WHETHER IT'S ALONG HANCOCK STREET, GENEVA, A LOT OF THE GOOD VIDEO WE HAVE ISN'T SO OCH OFF OF OUR CAMERAS BUT IT'S FROM HOUSE CAMERAS, BELIEVE IT OR NOT.

THE MORE CAMERAS WE GET OUT THERE, THE BETTER OFF, I THINK WE ARE.

>> YEAH, BECAUSE MY BIG ASK FROM DEVELOPMENT IS TO LAND CAMERAS, AND I ALWAYS WANT THEM TO BE CAMERAS THAT ARE INTERFACED WITH

YOU GUYS SO YOU HAVE THEM IN REALTIME.

HANCOCK STREET I HAVE
COMMITMENTS FROM DEVELOPERS.
SOUTH BAY, THOSE CAMERAS OVER
THERE, THEY CONNECTED TO YOU,
JOHN, THE SOUTH BAY CAMERAS DO
YOU KNOW OF THEM?

>> NOT IF IT'S A PRIVATE ENTITY. NOT YET.

HAVEN'T HEARD ANYTHING ABOUT THAT.

>> BECAUSE I HAVE COMMITMENTS FROM MULTIPLE DEVELOPERS, AND WE HAVE THE BRA TODAY, SO I'D LIKE TO FIGURE OUT THE WAY, HOW DO WE GET THE DEVELOPERS NOW TO PUT THE MONEY UP AND MAKE SURE THAT THEY'RE OUR CAMERAS.

SO IF WE CAN STAY IN CONTACT ON THAT, AND I'VE BEEN WORKING WITH THE B.R.A. TO HELP YOU GUYS OUT ON THAT.

## OKAY.

CAN YOU TALK A LITTLE BIT ABOUT WHAT'S GOING ON OVER AT, YOU KNOW, BY ALBANY STREET AND ALL THAT.

LIKE WHAT'S -- HOW ARE WE DOING WITH WORKING WITH THE BEST TEAM? LIKE THE NEW OPIOID RESPONSE QUAD THAT WAS LAST YEAR. ARE WE SEEING ANY RESULTS OR IS IT MORE -- IS IT -- WE'LL HAVE SOME RESULTS, AND THEN 100 MORE PEOPLE SHOW UP?

>> WELL, I THINK, YOU KNOW,
OBVIOUSLY THEY DID SOME
ENVIRONMENTAL DESIGN DOWN THERE.
>> YEAH.

>> WITH THE FENCE AND STUFF AND OBVIOUSLY THAT'S NOFD SOME PEOPLE A LITTLE BIT.

>> BACK TO ATKINS STREET.

>> THEY PUSHED THEM AROUND A LITTLE.

I THINK THAT'S THE ISSUE. CLEARLY IT'S A PUBLIC HEALTH ISSUE.

AS MUCH AS WE PUSH IT.
WE HAVE OUR BIKE SQUAD DOWN
THERE CONTINUALLY.
NOT SO MUCH TIME TO LOCK THESE

YOUNG KIDS, WHICH MOST OF THEM

ARE, BUT TO TRY TO POINT THEM IN THE DIRECTION OF SERVICES.
YOU KNOW, WE GIVE THEM CARDS, ABOUT WHERE TO SEEK SERVICES, AND WE'RE WORKING WITH BMC, WE'RE WORKING WITH THE BEST TEAM, AND YOU KNOW, LIEUTENANT LARKIN AND HIS STRIKE UNIT DOWN THERE CONTINUALLY, THE OPIOID SQUAD IS DOWN THERE -- >> WHAT DOES THE OPIOID SQUAD DO?

>> FOR THE MOST PART THEY WORK WITH A LOT OF THE KIDS WHO OVERDOSE.

THEY DO HOME VISITS. FOLLOW-UP.

>> IS THAT WHAT LARKIN --

>> HIS OPIATE SQUAD.

BUT THEY ALSO TRY TO TRACK WHERE A LOT OF THESE DEADLY CASES ARE COMING FROM.

YOU KNOW, AND THEY'RE TRYING TO WORK WITH THE D.A. TO TRY TO BRING MORE OF THESE CASES TO HIM TO TRY TO GO AFTER THE SELLER. SO THEY TRACK THE OVERDOSES. YOU KNOW, IF IT'S A DEADLY STRAND OF FENTANYL OR CAL FENTANYL.

THEY'RE DOING A GOOD JOB.
WHERE THEY'RE DOING A LOT OF
WORK IS TRYING TO REFER THESE
PEOPLE TO SERVICES.

THEY DO HOME VISITS ALL THE TIME TO THESE YOUNG KIDS WHO OVERDOSE.

>> SO ONE OF THE NEW TOOLS I HAPPEN TO LOVE IS THE SECTION 35, THE ABILITY FOR OFFICERS TO SECTION PEOPLE.

HOW OFTEN ARE WE USING THAT? IS THAT BEING USED?

>> IT'S BEING USED.

I MEAN, JUDGE COFFEY HAS BEEN GREAT IN WEST ROX BRIE DOING IT. I'VE HEARD A LOT OF FEEDBACK. EVERY OPPORTUNITY WE GET WE TRY TO GET SOMEONE SECTIONED AND BRING THEM OUT THERE. THE ONLY ISSUE DOWN THERE, IS IT'S A LONG RIDE WITH THEM.

>> YEAH.

>> BUT WE'RE HOPING TO GET MORE

JUDGES TO DO IT.

BUT THE PROBLEM IS, AS YOU KNOW, THERE'S NOT ENOUGH FACILITIES TO TAKE THEM.

>> YEAH.

>> YOU KNOW, I THINK IF WE HAD MORE AND MORE RESIDENTIAL FACILITIES WE COULD DO A LOT MORE WITH THE SECTIONING.
BUT, WE RUN OUT OF BED SPACE.
>> YEAH.

WE SHOULD REBUILD THE BRIDGE, YOU THINK?

MAYBE?

YOU DON'T HAVE TO ANSWER THAT.
>> NO, BUT THE MAYOR'S COMMITTED
TO REBUILDING THE BRIDGE.
I THINK WE ALL KNOW, IT'S
CONTRIBUTED TO MORE HOMELESS,
AND YOU KNOW, I KNOW QUINCY, AND
I DON'T WANT TO GET POLITICAL,
BUT YOU KNOW, IT'S A GOOD
TREATMENT.

AND I KNOW NOBODY WANTS IT IN THEIR BACKYARD BUT THAT PLACE WAS A GREAT HAVEN TO GET THESE PEOPLE THE SERVICES, THE CARE THEY NEEDED, I HOPE, YOU KNOW, THEY THINK BETTER OF IT. YOU KNOW, THAT TREATS PEOPLE FROM QUINCY.

>> I DO KNOW.

>> ONLY 40% OF THOSE PEOPLE DOWN THERE FOR THE MOST PART ARE FROM THE CITY.

IT'S JUST NOT A BOSTON ISSUE.
WE HAVE TO SHARE RESPONSIBILITY.
I THINK LONG ISLAND SHELTER WAS A GREAT PLACE WHERE THEY GOT THE CARE THEY REALLY NEEDED.
WE'RE OVERWHELMED DOWN THERE,

THERE'S NO DOUBT ABOUT IT.
THAT'S WHY WE NEED LONG ISLAND
OPENED.

>> I THINK LONG ISLAND, I THINK QUINCY'S PERCEPTION IS WE'RE GOING TO CLOSE OUR SERVICES AND PUT EVERYTHING IN LONG ISLAND. WE NEED IN ADDITION TO ALL OUR SERVICES WE NEED LONG ISLAND ALSO, AND HOPEFULLY WE CAN GET THAT DONE IN THE NEXT COUPLE

YEARS.

WHEN IS THE NEXT CADET CLASS GOING ON?

>> IN JUNE.

WE HAVE 33 GOING ON.

>> HOW MANY ARE IN THERE?

>> 33.

>> OH, GOOD.

AND WHEN THE NEXT -- WHEN IS THE NEXT ACTUAL OFFICER CLASS?

>> NOVEMBER WE'RE HOPING TO HAVE 130 GO ON.

>> AND WHAT'S YOUR GRADUATION RATE OUT OF THAT?

SO 130 ENTER, WHAT --

WANT TO TALK A LITTLE BIT ABOUT THE DOLLARS, AND THAT FUNDING.
>> I THINK TO FULLY FUND FOUR
WE'RE POSSIBLY ABOUT 80,000
SHORT BASED ON THEIR BASE SALARY
AND THEIR FRINGE SO RIGHT NOW I
THINK THAT FUNDING THE 234 WOULD
REALLY FUND 2.6 ANNUALLY.
UNTIL WE HAVE A BIT OF A GAP TO

UNTIL WE HAVE A BIT OF A GAP TO GET FOUR ON FULL TIME.

>> SO WE NEED 80 MORE.

SO WE STILL HAVE THE TWO GRANT POSITIONS?

>> CORRECT.

ONE IS VACANT.

ONE IS FULL.

ONE IS UNDER DEPARTMENT OF MENTAL HEALTH.

AND ONE IS UNDER THE DJA GRANT. CURRENTLY JAKANT.

>> BUT WE HAVE BOTH OF THOSE GRANTS?

>> YES.

>> WHAT'S THE CHALLENGE WITH FILLING?

>> I THINK FOR, YOU KNOW, FOR THE CLINICIANS, IT'S A -- I THINK IT TAKES A UNIQUE PERSONALITY TO WANT TO WORK IN THAT ENVIRONMENT AND THOSE HOURS, ESPECIALLY WORKING EVENING SHIFTS, SO WE'LL PULL OUT THE CALL THROUGH BOSTON MEDICAL CENTER AND THEY'RE JUST NOT GETTING THE REPLIES THAT WE WOULD HOPE.

>> OKAY.

>> HOPED TO HAVE.

>> OKAY.

SO, I WILL ADVOCATE FOR THE ADDITIONAL \$80,000 MORE AND I'M HOPEFUL THAT COUNCILOR PRESSLEY WILL SIGN ONTO THAT ADVOCACY BECAUSE IT WAS SOMETHING THAT WAS PERSON TO HER AND I AS WELL AS THE WHOLE COUNCIL, THAT THOSE

POSITIONS BE FILLED.
WE WANT TO MAKE SURE THEY'RE
FILLED AND FULLY FUNDED.
ACTIVE SHOOTER TRAINING.
WE TALKED A LITTLE BIT ABOUT IT
TODAY.

I AM -- IT'S YOUR HONOR FORTUNATE THAT WE HAVE TO TALK ABOUT ACTIVE SHOOTER PREPARATIONS.

WE'VE TALKED ABOUT IT AT THE EMS HEARING YESTERDAY, WE'VE TALKED ABOUT IT WITH BOSTON PUBLIC SCHOOLS EXTENSIVELY.

WE'VE TALKED ABOUT IT, I THINK WITH ALMOST EVERY DEPARTMENT THAT HAS A HAND IN IT.

CAN WE TALK, WILL YOU SHARE JUST A LITTLE BIT ABOUT THE ACTIVE SHOOTER TRAINING THAT YOU HAVE YOUR MEN AND WOMEN GO THROUGH? >> YEAH.

AGAIN, WE DO A LOT WITH THE PUBLIC SCHOOLS.

AND MORE IMPORTANTLY LET THEM
KNOW WHAT OUR ROLE WILL BE AND

WHAT THEIR RESPONSIBILITIES ARE. SO, YOU KNOW, UNFORTUNATELY, IT'S A NECESSARY EVIL. AND WE'RE CONTINUALLY LETTING PEOPLE KNOW IF THEY NEED THAT FOR THEIR COMPANY, FOR THEIR PUBLIC EDUCATION FACILITY OR WHAT TYPE WE'LL GO OUT AND DO IT.

## >> THAT'S GREAT.

I WOULD LIKE TO EMPHASIZE I THINK THE NECESSITY OF HAVING THE LOCAL DISTRICT OFFICES IN ADDITION TO THE S.W.A.T. TEAM AND THE SPECIAL SCHOOL POLICE UNIT THAT THE LOCAL DISTRICT BE -- PARTICIPATE IN THAT ACTIVITY.

BECAUSE THEY'RE LIKELY TO BE THE FIRST RESPONDER TO AN INCIDENT AT ANY OF OUR SCHOOLS.
AND SOME OF OUR SCHOOLS HAVE VERY COMPLEX LAYOUTS.

>> RIGHT.

>> AND THERE OFTEN ISN'T TIME TO PULL OUT BLUEPRINTS AND SORT OF --

## >> RIGHT.

AND WE HAD ONE TIME DONE ALL THE BLUEPRINTS FOR ALL THE SCHOOLS. BUT I AGREE WITH YOU, THE MORE THEY CAN BE FAMILIAR WITH THE SCHOOLS AND WE'RE CONTINUALLY HAVING THEM IN THE SCHOOLS, BUT THAT BEING ONE OF THE REASONS, THE BETTER WE'LL BE.

>> AND BPS IS GOING THROUGH AND DOING THEIR OWN SCHOOL AUDIT RYE NOW FOR FRONT DOOR, MAIN ENTANSS, LOOKING AT THE PA SYSTEM, CLASSROOM DOORS, AND WHETHER OR NOT TEACHERS AND ADMINISTRATORS HAVE ACCESS TO KEYS AND PROPERLY LOCKING DOORS. YOU KNOW, MAKING SURE THAT EXTERIOR DOORS WITH ALL CLOSED IF THERE'S A RECEPTION PROCESS WHEN GUESTS COME INTO THE BUILDING.

AND THE PROTOCOLS ARE IN PLACE. BUT ONE OF THE PIECES THAT I WASN'T CONFIDENT IN WAS WHAT PROTOCOL WOULD BE SHOULD THERE BE AN INCIDENT THAT TAKES PLACE, WHAT THE PROTOCOL IS FOR FAMILIES, AND FOR COMMUNITIES TO REUNITE WITH CHILDREN IF ITS KIDS ARE EVACUATED FROM A BUILDING.

I THINK IT'S REALLY IMPORTANT
THAT THAT PROTOCOL BE IN PLACE.

>> YEAH, AND I THINK THAT'S SORT
OF SOMETHING THAT EACH SCHOOL
PRINCIPAL SHOULD HAVE PROBABLY
AND ROLL OUT WITH THE PARENTS.
LIKE IF THERE IS AN INCIDENT,
WHERE DOES EVERYBODY MEET UP?
LIKE IF IT WAS THE QUINCY
SCHOOL, HEAVEN FORBID, MAYBE,
THEY'LL MEET DOWN BEFORE
WASHINGTON STEWART.
BUT I THINK, OBVIOUS, I THINK

THAT'S SOMETHING THE SCHOOL AND THE PARENTS SHOULD WORK OUT.
YOU KNOW, WHERE IT'S GOING TO BE THE GATHERING AREA.

WHERE CAN THEY BE INFORMED OF WHAT'S GOING ON?
AND YOU KNOW, WE'LL WORK TO DO OUR BEST TO PUMP OUT THE INFORMATION THROUGH SOCIAL MEDIA

BUT, LIKE THE MARATHON, YOU KNOW, NO ONE EVER ANTICIPATED WHAT WAS GOING TO HAPPEN.
BUT NOW WHEN WE DO A MARATHON WE HAVE A PLAN THAT IF SOMETHING SHOULD HAPPEN, YOU KNOW, POLICE ARE GOING TO GO HERE, AND THE MEET UP FOR THE RUNNERS AND THE FAMILY, OBVIOUSLY, WE'VE HAD IT DOWN AT THE PARK PLAZA CASTLE ALL THE TIME.

SO I THINK EVERY SCHOOL AND THE PARENTS SHOULD HAVE A PLAN THAT THIS IS WHERE WE'RE GOING TO GO, HEAVEN FORBID SOMETHING LIKE THAT HAPPENS.

>> I THINK, FORTUNATELY, WE HAVE NOT HAD AN INCIDENT SIMILAR TO WHAT WE'VE SEEN IN SOME OTHER STATES, BUT IT'S, I THINK, JUST BEEN -- IT'S JUST BEEN I THINK A LITTLE BIT OF LUCK AND MASSACHUSETTS IS A LITTLE BIT DIFFERENT BUT WE NEED TO BE PREPARED.

WE'VE SEEN IT IN OTHER PLACES.

WE'VE SEEN IT HAPPEN.

AND THERE IS NO REASON THAT IT SHOULDN'T OR COULDN'T -- I'M USING THE WRONG WORDS, BUT IT COULDN'T HAPPEN IN BOSTON SO WE NEED TO BE PREPARED AND CERTAINLY LEARN FROM THOSE EXPERIENCES, AND EARLIER YOU HAD MENTIONED THE ACTIVE SHOOTER TRAINING, 500 ACTIVE SHOOTER TRAININGS?

>> UPWARDS, AROUND 500 AROUND THE CITY.

>> THAT'S GREAT.

THAT'S REALLY GREAT TO HEAR.
I KNOW, JUST BEFORE I LEFT
TEACHING WE HAD DONE AN ACTIVE
SHOOTER TRAINING, A LECTURE
STYLE WITH THE TEACHERS AND
STAFF AT THE HIGH SCHOOL I
TAUGHT AT, AND THEN COMING HERE,
ALMOST WITHIN THE FIRST FEW
MONTHS OF BEING IN THIS BUILDING
WE DID AN ACTIVE SHOOTER
TRAINING HERE.

IT'S PROBABLY TIME FOR ANOTHER ONE.

IT'S BEEN ABOUT 2 1/2 YEARS NOW. SO, I'M HAPPY THAT YOU'RE DOING THEM, I THINK AS MANY AS YOU CAN DO AS POSSIBLE WOULD BE GREAT. THEN COULD YOU JUST TOUCH ON THERE WAS SOME CONTROVERSY A FEW YEARS AGO ABOUT THE LONG-RANGE GUNS WITH SOME OF OUR COLLEGE POLICE.

>> RIGHT.

- I MEAN, SOME OF THE COLLEGES OBVIOUSLY WERE ARMING THEMSELVES UP.
- I THINK MORE OF THE CONCERN WAS WE WEREN'T REALLY IN THE GAME ABOUT IT.

USUALLY IF OUR S.W.A.T. TEAM IS GOING TO RESPOND WE'VE WORKED WITH OTHER COLLEGE AGENCIES TO SORT OF -- SO WE HAVE A UNIFIED EFFORT.

I THINK THERE WAS MORE OF A LACK OF COMMUNICATION WITH THAT ISSUE.

BUT, YOU KNOW, WE ALWAYS HAVE TACTICAL CARS RIDING AROUND CITYWIDE, EVERY DISTRICT NOW TWO OFFICERS WHO ARE HIGHLY TRAINED TO HAVE PATROL RIFLES. I THINK WE'VE SEEN IN EAST BOSTON WHEN WE HAD OFFICER RICH SANTOLO AND MATT MORRIS GET

SHOT.

THEY WERE UP AGAINST AN AR-15 AND THANK GOD THAT WE HAD A TACTICAL CAR CLOSE BY BECAUSE THAT TACTICAL WEAPON WAS USED TO NEUTRALIZE THAT THREAT. UNFORTUNATELY WE'RE SEEING A LOT OF HIGH POWERED GUNS OUT THERE THAT CAN DO A LOT OF DAMAGE. WE DO HAVE NOW AN OFFICER, TWO OFFICER VEHICLE IN EACH DISTRICT THAT CAN RESPOND TO AN ACTIVE SHOOTER, AND THEN THE TACTICAL UNITS, ANY TIME THE TACTICAL UNITS GATHER IN THE CITY AND THEY HAVE THE SHOT SPOTTER TECHNOLOGY, YOU LISTEN TO THE RADIO LIKE LAST NIGHT ON ADAMS, THEY'RE ROLLING. AND THEY'RE GOING TO GET THERE

OUICK.

BECAUSE THEY'RE THE ONES WHO HAVE ALL THE GEAR, HAVE ALL THE TACTICAL EQUIPMENT.

>> THAT'S THE END OF IT. THAT'S THE END OF MY QUESTIONS FOR TODAY.

JUST APPRECIATE YOUR WORK, CHIEF'S WORK, YOUR COMMAND STAFF, AND THE MEN AND WOMEN THAT ARE OUT WALKING THE BEATS EVERY DAY.

SO IT'S NOT LIKE IT'S ALL ABOUT SPORTS, IT'S ABOUT BRINGING POLICE AND YOUTH TOGETHER IN ALL DISTRICTS.

BECAUSE YOU DON'T ALWAYS REACH KIDS THROUGH SPORTS.

YOU'VE GOT TO REACH THEM THROUGH PROGRAMS LIKE URBAN IMPROV, MEDICINE WHEEL, AND ANYTHING WE ASK P.A.L. TO BRING US CLOSER TO, ESPECIALLY THE YOUNG KIDS, THEY'RE ALWAYS ON BOARD AND CAN HELP US DO THAT.

>> I THINK THE MOST IMPORTANT ASPECT OF OUR P.A.L. IS THAT WE'RE DEFINITELY DEVELOPING NEW RELATIONSHIPS.

LET'S SAY IF YOU HAD A POOR RELATIONSHIP WITH THE POLICE BEFORE, NOW YOU'RE PUTTING CHILDREN THROUGH PROGRAMS, AND INCORPORATING THEIR PARENTS, AS WELL.

WE HAVE A WHOLE NEW LINE OF COMMUNICATION.

AND IT REALLY SHOWCASES THAT THE BOSTON POLICE DEPARTMENT ISN'T JUST INTERESTED IN PUTTING CUFFS ON A SITUATION BUT WORKING IN PARTNERSHIP WITH THE COMMUNITY TO SOLVE THIS PROBLEM.

ESPECIALLY WITH THE YOUTH, AND P.A.L. IS A BIG PART OF THAT. THE COMMUNICATION, THE INTERACTION, IT'S JUST HELPING US BUILD A BETTER LEVEL OF TRUST WITH THE COMMUNITY THAT WE SERVE.

>> THANK YOU FOR THAT.
AND THAT'S A PROGRAM I HAVE
GREAT RESPECT FOR.
SO I'M GLAD IT'S DOING WELL.
COMMISSIONER, CAN YOU TALK A
LITTLE ABOUT THE DOMESTIC
VIOLENCE UNIT?
THE SUCCESS OF THE PROGRAM?
HOW IT'S DOING?

I KNOW THEY'RE DOING A LOT OF WORK ACROSS THE CITY.

BUT CAN YOU GIVE US A LITTLE BIT OF BACKGROUND ABOUT IT? >> YOU KNOW, THEY WORK OUT AT

>> YOU KNOW, THEY WORK OUT AT THE FAMILY JUSTICE CENTER, OUT IN ALLSTON.

THEY DO A GREAT JOB.

OBVIOUSLY IT'S ONE STOP SHOPPING OUT THERE.

ONE STOP SHOPPING WHERE THEY WORK WITH OTHER CITY AGENCIES AS WELL AS PROGRAMS LIKE DRESS FOR SUCCESS AND OTHERS WHERE FAMILIES GET A LOT OF THESE RESOURCES.

THEY JUST DON'T GET OUR DETECTIVES.

BUT WE HAVE 11 DOMESTIC VIOLENCE DETECTIVES.

EACH ONE ASSIGNED TO EVERY UNIT IN THE CITY.

EVERY DISTRICT.

AND WHOSE SOLE FUNCTION IS TO FOLLOW UP.

IF VICTIMS NEED RESTRAINING ORDERS, EMERGENCY ORDERS, THEY WALK THEM THROUGH THE COURT. THEY WALK THEM THROUGH THE TRAUMATIC EXPERIENCES OF SUFFERING ABUSE AT THE HANDS OF SOMETIMES A LOVED ONE. THEY DO A GREAT JOB OUT THERE. BUT THEY ALSO WORK WITH ALL THE OTHER SOCIAL SERVICES AGENCIES, SO IF THEY NEED EMERGENCY HOUSING, OR IF THEY NEED CLOTHES OR THEY NEED FOOD, YOU KNOW, THEY WORK WITH THE CITY, THEY WORK WITH THE STATE, AND THEY DO A SUPER JOB BUT IT'S AMAZING THE CASELOAD.

AGAIN, YOU KNOW, IT'S DOMESTIC VIOLENCE, IT'S OVERWHELMING, AND EVERY ALMOST POLICE REPORT YOU READ EVERY DAY A LOT OF IT HAS TO DO WITH DOMESTIC VIOLENCE. SO THEY WORK HARD.

BUT I WISH ALWAYS THAT THEY HAD A LESS CASELOAD.

AND THAT'S ALL I HAVE,
COMMISSIONER, I AGAIN JUST WANT
TO SAY THANK YOU TO YOUR STAFF,
AND THE MEN AND WOMEN OF THE
BOSTON POLICE FOR EVERYTHING
THAT YOU DO EVERY DAY.
THANK YOU VERY MUCH.
>> THANK YOU, COUNCILOR.

>> THANK YOU, COUNCILOR. COUNCILOR EDWARDS.

>> THREE FOLLOW-UP QUESTIONS.
I'VE BEEN GETTING A LOT OF
E-MAIL ABOUT SULLIVAN SQUARE AND
ABOUT THE NEED FOR POLICE
DETAIL, CALLS, E-MAILS, EVEN
TODAY, ESPECIALLY BECAUSE OF
WHAT'S HAPPENING WITH THE CASINO
AND INCREASED AMOUNT OF TRAFFIC
FROM THAT END.

I KNOW COUNCILOR FLAHERTY BROUGHT IT UP BEFORE. WE'RE REALLY HOPEFUL AND I KNOW THE CASINO'S EVEN OFFERED TO PAY FOR ADDITIONAL DETAILS THAT WE LACK THE MAN OR WOMAN POWER TO EVEN FILL THOSE SEATS.

>> BECAUSE IT'S ONLY GOING TO INCREASE WITH THE CASINO GETTING -- BUILDING UP MORE AND BUILDING IN MORE TRAFFIC. THEY'RE GOING TO GET A 4:00 A.M. LIQUOR LICENSE AT THAT. THERE'S A LOT OF THINGS THAT ARE COMING THROUGH BOSTON, ESPECIALLY IN THAT AREA. REALLY WE DESPERATELY NEED THE BODIES THERE.

JOEL FINEGOLD, I'M THE ORGANIZER OF THE RIDE OF SILENCE IN BOSTON.

GENERALLY SPEAKING AN ALTERNATIVE TRANSPORTATION ADVOCATE.

PARTICIPATE IN MANY OF THE IMPORTANT RIDES IN BOSTON EVERY YEAR.

THE BIKE MARATHONS, FUND-RAISER, THE PEACE RIDE IN BOSTON THE LAST COUPLE OF YEARS, AS WELL AS ORGANIZING THE RIDE OF SILENCE. THE FIRST THING THAT I WOULD LIKE TO SAY IS THANK YOU VERY MUCH TO ALL THE OFFICERS, AND LEADERSHIP IN THE POLICE DEPARTMENT.

I'VE HAD FANTASTIC EXPERIENCES WITH SO MANY PEOPLE THAT I'VE MET, THIS YEAR'S RIDE OF SILENCE WAS SUPPORTED BY OFFICERS FROM THE CITY OF BOSTON'S BIKE SQUAD, FROM CAMBRIDGE POLICE, NORTHEASTERN AND BOSTON UNIVERSITY POLICE AND THE STATE POLICE.

BECAUSE THEY KNOW WHAT WE'RE TRYING TO DO IS IMPROVE SAFETY FOR RIDERS.

TO ME IT'S NOT REALLY A
POLITICAL THING AT ALL, IT'S
JUST A MAT ERT OF HOW DO WE SET
EP OUR PRIORITIES, AND IN THE
CONTEXT OF THIS MEETING, HOW DO

WE ALLOCATE OUR RESOURCES TO TRY TO MAKE THINGS SAFER FOR PEOPLE? I'M NOT GOING TO GO INTO THE COMPLEXITIES, BUT THERE'S SO MUCH INTERRELATIONSHIPS. WE'VE HEARD SEVERAL TIMES ABOUT THE DIFFICULTY OF THE DOUBLE PARKING, THAT THE LYFT DRIVERS AND THE UBER DRIVERS, AND SO FORTH WHICH BLOCK TRAFFIC BUT THEY ALSO CREATE GREAT ACRE FOR CYCLISTS THAT NOW HAVE TO CUT IN AND OUT OF TRAFFIC AND SO ON. THE COMPLEXITY OF WHAT HAPPENS IN THE CITY SURROUNDING TRANSPORTATION, AND CYCLING SAFETY, IS VERY GREAT. ALL THAT SAID SOMETIMES WE WIND UP AT LOGGERHEADS A LITTLE BIT WHICH POPPED UP IN THE ANITA KERRMAN INVESTIGATION. MY TAKEAWAY FROM THAT IS IT WOULD BE GREAT FOR US TO BEGIN TO EDUCATE EACH OTHER SO THAT WE CAN LEARN MORE ABOUT THE PROCESS WHICH TAKES PLACE IN A DEPARTMENT WHEN ONE OF THESE CRASHES IS INVESTIGATED, AND THAT WE CAN PROVIDE INSIGHT FROM THE BIKE RIDER PERSPECTIVE ABOUT WHAT WAS TRANSPIRING ON THE ROAD.

BECAUSE, IT APPEARS TO TO US
THAT THE INVESTIGATION, I KNOW
IT'S ONLY ONE INVESTIGATION, IT
APPEARS TO US THAT THE
INVESTIGATION, GATHERING
EVIDENCE, REALLY WAS A WONDERFUL
JOB.

I MEAN THE OFFICERS INVOLVED FOUND VIDEO, THAT MADE AN INCREDIBLE STORY, THERE WAS GREAT WORK THERE.
BUT SOMEHOW WHAT THEY SAW AND HOW THEY INTERPRETED THAT IS

HOW THEY INTERPRETED THAT IS DIFFERENT THAN WHAT WE SAW. AND THEN THE CONCLUSIONS, AND THE APPLICATION OF THE LAW THAT WENT WITH IT IS DIFFERENT THAN OURS, AS WELL.

AND SO, I THINK IF WE BEGIN A DIALOGUE WITH EACH OTHER AND HAVE AN OPPORTUNITY TO SIT DOWN AND TALK, AND EXTEND THIS

INVITATION ON BEHALF OF THE OTHER ORGANIZATIONS THAT DON'T KNOW I'M MAKING THIS, YOU KNOW SOMETIME IN THE NEXT MONTH, GET AROUND THE TABLE, AND TALK ABOUT THE EXPERIENCES THAT WE HAVE AND HOW WE CAN MAKE THIS WORK BETTER GOING FORWARD.

JUST TO WRAP UP, WE THINK THAT ON THE ENFORCEMENT SIDE WE NEED MORE.

PEOPLE WILL COME WITH THE TRANSPORTATION HEARING AND TALK ABOUT THE INFRASTRUCTURE, AND THEY NEED MORE, TOO.

AND WE KNOW THAT MONEY IS TOUGH. BUT IF THE MORE THAT CAN BE HAD ON THE ENFORCEMENT SIDE INCLUDES OFFICERS, INVESTIGATORS, AND LEADERSHIP WITH GREAT BIKE TRAINING, WITH EXPERIENCE ON THE ROAD, SO THAT OFFICERS WORKING ON A CRASH HAVE ACTUALLY RIDDEN THE ROUTE ON A BICYCLE, THAT THE VICTIM TOOK, AND MORE THINGS LIKE THAT, WHICH ARE CONTAINED IN THE LETTER WHICH I DROPPED OFF TODAY, WE THINK THAT THESE THINGS WILL HELP, AND I HOPE THAT WE CAN DO MORE TOGETHER IN THE FUTURE AND WORK ON IT. THANK YOU VERY MUCH.

LEADS FOR MAYOR WALSH FOR SERIOUS AND FATAL CRASHES TO GET IT TO ZERO.

WE'RE IMPORTANT THAT THE BPD
DATA POSITION THAT WAS
PREVIOUSLY GRANT FUNDED THAT IT
IS A DEDICATED STAFF POSITION,
AND SO WE WOULD RECOMMEND A LINE
ITEM OF BETWEEN \$75,000 AND
\$85,000 TO FUND A PERMANENT
STAFF ANALYST POSITION.

MY NAME IS ANDREW McFARLAND, I'M THE COMMUNITY ENGAGEMENT MANAGER FOR THE WHOLE STREET ALLIANCE. I JUST WANT TO ECHO BRANDON'S POINTS.

WE ARE ALSO A MEMBER OF THE MASSACHUSETTS VISION ZERO COALITION, AND SOME OTHER ADVOCATES ON THE CITY'S OFFICIAL TASK FORCE, ALONG WITH THE POLICE DEPARTMENT, AND WE WOULD JUST ECHO THE NEED FOR A PERMANENT CRASH ANALYST WITHIN THE POLICE DEPARTMENT. AS WE'VE MENTIONED PREVIOUSLY DURING THIS HEARING, THAT POSITION WAS GRANT FUNDED, AND THAT'S NO LONGER A BUDGET GUARANTEE, IN FY'19. AND I JUST WANT TO SPEAK TO THE GROWING NEEDS TO HAVE SOMEBODY

TO ANALYZE THESE CRASHES. WE'VE JUST SEEN A CONSIDERABLE UPTICK IN CRASHES YEAR BY YEAR. IN 2015 WE HAD ABOUT 4,100 CRASHES.

THAT RESULTED IN INJURY ON CITY STREETS.

THAT INCREASED TO 4,370 IN 2016. AND THIS PAST YEAR WE'VE SEEN OVER 4,500.

SO WE KNOW THAT WE'RE SEEING MORE AND MORE CRASHES ON OUR STREETS.

THAT'S GOING TO NEED SOMEBODY WHO IS IN A PERMANENT CAPACITY TO REPORT ON THOSE CRASHES, REDACT SENSITIVE INFORMATION, AND MAKE SURE THEY'RE BEING SHARED WITH THE TRANSPORTATION DEPARTMENT, THE PUBLIC WORKS DEPARTMENT, THE PUBLIC HEALTH COMMISSION, TO MAKE SURE THAT THEY CAN DO WHAT THEY NEED TO DO FROM A VISION ZERO PERSPECTIVE, JUST HAVING SAT ON THE TASK FORCE, THE PREVIOUS PERSON WHO FILLED THAT POSITION WAS FANTASTIC IN THAT ROLE AND REALLY, REALLY HELPED REPORTING ON CRASHES, AND WAS AMAZING TO HAVE LIKE ON THE TASK FORCE.
