### Public Hearing Continued

PHC 1. On a joint petition by Broadway & A St LLC and the Boston Planning and Development Agency for the **Vertical Discontinuance** of portions of the following public ways in South Boston, vertically above and below the grades of the sidewalks: (NB 7/12/2018, PH 8/23/2018)

- **West Broadway** – on its southwesterly side at addresses #79-89, southeast of A Street.
- **A Street** – on its southeasterly side southwest of West Broadway.

### Public Hearing

PH 1. On a joint petition by CVPA Chain Forge LLC and the Boston Planning and Development Agency for the making of **Specific Repairs** within the following public ways in Charlestown, consisting of curb, sidewalk, and pedestrian ramp reconstruction, as well as new and relocated specialty pavement, street trees, irrigation infrastructure, and driveway curb cuts: (NB 8/23/2018)

- **First Avenue** – on its northwesterly side at address #105, between Ninth Street and Thirteenth Street.
- **Ninth Street** – on its northeasterly side northwest of First Avenue.
- **Thirteenth Street** – on its southwesterly side northwest of First Avenue.

PH 2. On a joint petition by CVPA Chain Forge LLC and the Boston Planning and Development Agency for the granting of a **Projection License** for the installation of canopy over a portion of the sidewalk within **First Avenue**, Charlestown, located on its northwesterly side at address #105, generally between Ninth Street and Thirteenth Street. *(NB 8/23/2018)*

As shown on a plan entitled "City of Boston Public Works Department, Engineering Division, License Plan, First Avenue, (Public Street), Charlestown," 1 sheet dated May 23, 2018.

PH 3. - **Newmarket Square** – generally between Glynn Way and Southampton Street.
- **Theodore A. Glynn Way** – between Massachusetts Avenue and Southampton Street.
- **Topeka Street** – northeast of Southampton Street.
