The Boston City Council's Committee on the Community Preservation Act will hold a public hearing on **Monday, June 3, 2019 at 1:30 p.m.** in the Iannella Chamber, Boston City Hall, Fifth Floor.

The subject of the hearing is:

**0803 Message and order for an appropriation order in the amount of One Million Two Hundred and Two Thousand Three Hundred and Thirty-Seven Dollars (\$1,202,337.00) for the administrative and operating expenses of the City of Boston Preservation Committee ("CPC") for Fiscal Year 2020, and a further appropriation Order in the amount of Twenty-Four Million Three Hundred and Nine Thousand Eight Hundred and Thirteen Dollars (\$24,309,813.00) from the Community Preservation Fund's ("the Fund") estimate annual revenues for Fiscal Year 2020, to be appropriated and reserved for future appropriation.**

This matter was sponsored by Mayor Martin J. Walsh, and referred to the Committee on May 15, 2019.
