>> Michael Flaherty chair of committee on government operations.

Today is thus May 2nd. We're here to discussion docket 348 regarding equity in the city of Boston.

This is stream lined.

>> This body passed equity in the city of Boston ordinance. It was signed into law by mayor Walsh.

This ordinance included changes to the RFP process of the city and requirements of quarterly reporting, procurement projects today.

Number of contracts entered into it and those owned by women, people of color and Boston residents.

Today's hearing is to discuss the results.

I turn it over to Michelle WU and Kim Janey for additional opening comments and then get into it.

We have our first panel here. Welcome to all of you from the administration.

I will give my colleagues a opportunity to give us their thoughts.

Michelle WU.

>> Thank you, Mr. Chairman. Thank you for making sure we had a expedited time in the chamber given the busyness of budget season.

Thank you for all of staff for accommodating that.
Thank you to the panelists and co sponsor, Kim Janey, to keeping the attention on this.
This is one of the most important ordinances that I worked on during my time on the council.

This is entirely in the city's

control directing where our tax payer dollars are going and a lining them with larger goals to create, generate and grow wealth in our community particularly for businesses owned by people of color, women, local Boston residents.

Having the numbers was extremely Aye opening from November 2018 and seeing it looks like there may of been adjustments.

The numbers of contracts by, designated by minority business enterprises, state and local business enter prices, less than one percent each or one percent each of the cities entire spent discussion airy spending.

Looking forward to digging into those.

Hearing the update ask appreciate my colleagues time in the administration.

I know you live and breath this. We're lucky to get a little of your insight on how to continue to move forward.

We will get above one percent and a lot higher beyond that as well.

Locking forward today's conversation with all community leaders in the room.

>> Thank you, counselor WU. Chair recognizes counselor Kim Janey.

>> Thank you, Mr. Chair.
Thank you to counselor WU for her partnership on this issue, dating back to before I arrived on the city council.

Acknowledge Ayanna Pressley for Herrin yesterday I believe work. I'm deeply committed to this. I want to be sure our close to one billion dollars we spend as a city does end up in the hands of people who live in our city. People of color and women Entrepreneurs.

Looking forward to a productive hearing.

Thank you.

I want to acknowledge the panelists and community advocates as well.

>> Thank you.

Chief, good to see you again.

>> Good afternoon chairman

Flaherty, counselor WU and counselor Janey.

I'm John bowers chief of economic development foresighty of Boston.

To my left is SALINA, director of equity and inclusion.

To my right is Stacy Williams

the certification manager.

On be half of me and Martin J.

Walsh thank you for the

opportunity to discuss equity in the city's procurement process.

Mayor Walsh has taken several

steps making sure business conducted in the city and by the

city have equity number of women

and people of color

participants.

Given the city's uncredible spending power of close to a billion dollars it's imperative we have municipal policies promoting engaging with women owned and minority owned businesses particularly for our own contracts.

This effort is not without challenges.

As you know with respect to construction Boston did have a robust and successful program requiring general contractors to award 15% of the total contract to minority owned businesses and 5% to women owned businesses. Unfortunately the program was eliminated due to a court ruling in the early 000s.

Our WBE and NBE numbers have never recovered.

However we have identified and working on several policies to reverse the troubling trend.

To begin we're in the process of conducting the city's first disparent study since 2003 to identify and address gaps in the

city's procurement practice as cross all departments and provide an enhanced platform for future equity based policies. In additionally October of 2018 mayor Walsh announced the department of neighborhood development and Bostons planning and PBA will include diversity, inclusion, and -- all requests for proposal release of public land moving forward. The first was the four RFPs released for land in the Dudley square area. We have successfully received

We have successfully received applications from very diverse development groups.

We're very happy with the first leg of response.

I also want to encourage an open dialogue and partnership with the council.

So that we can look at and address the state's procurement laws

Specifically chapter 30B requiring Boston to accept the lowest bid for any, any contract over ten thousand dollars. We should and must have the ability to take into account more factors when selecting contractors.

In reassess 30B it's my hope to provide the city with the flexibility needed to make a meaningful impact on our spending powers. I am optimistic that the

disparity study coupled with an assessment coupled with procurement laws will improve city contracts awarded to women and people of color.

I do want to be clear however it's not all bad news.

As you will hear from the director of equity inclusion Selina's presentation there will be improvements in numbers. Slight and somewhat immaterial but TREnDing in the right direction.

This is being done by creating strong partnerships with equity inclusion unit and departments such as public works.

And parks.

We are eager to participate you on this work.

Yielding additional successes prior to the disparity study and other pop see discussions. At this point I want to turn it over to Selina for more specifics on our efforts.

>> Welcome, Salina.

>> Good afternoon.

My name is Selina BARoS MILNER.

I wanted to share with you a little more about what we're doing to both develop the supply of women and minority vendors and create demand.

I will go through and start off in the presentation with a look at the current certified vendor pool.

>> The different categories of certification we do.

I put a place here for the different types.

MBEs are businesses 51% minority owned.

We have a total of 304 of those.

144 are Boston based businesses.

Women owned we have 214 of those

50 are Boston based.

Small and local business enterprises which that

certification is about both the size of the business in terms of

the gross receipts as well as

their being located in Boston. We have 213 small and local

businesses.

199 are based in Boston.

Then we have veteran owned businesses both include veteran owned small businesses as well as disabled veteran owned small businesses.

Those are 93 bases in Boston. If you're pulling out your calculators I guarantee the numbers won't add up. A lot of these categories

overlap.

If you see within minority owned this are women owned and male owned businesses.

So within small and local some are minority owned, etcetera, etcetera, this is a gimps of doing current vendor pull in the certification database managed by Stacy.

There is a lot of room to grow. A lot of room to diversify. One of the steps we have taken towards that is partnership with the commonwealth.

Their supplier diversity office. They do certification for the state.

We signed a MoU with them in December of 2018 formally establishing a cross certification agreement and process between the two agencies.

Now if you're certified with one of the -- the state or city the other party will recognize that certification and fast track your certification process through them.

We are looking to A sign our data system.

So if someone is looking for a minority owned business we're in talks for.

That we're looking to make the process more business friendly and stream lined.

Certification is not the end.

The contract is the end.

We want this to be as smooth as possible.

This will create contract opportunities for our vendors. We also launched this year the economic development center. Our unit launched the pathways to city contracting series. That consisted of a opportunity fare where business owners could

fare where business owners could learn about opportunities coming up.

Also a series of technical assistance workshops.

You can see the types of information and member of attendees.

So far we have had 452 members come through.

All of the workshops are free of charge and available to the public.

Just to take a look who has participated in the workshops.

We have a racial breakdown on the left and gender breakdown on the right.

Majority African-American.

Hispanic.

White, Asian.

Other.

Majority male.

Male and female participation. Those are the neighborhoods when we track participant data. those

are the neighborhoods that

participants reside in.

We head the first opportunity

fair in the building in Dudley.

It was good to see people from all across the city.

These are quotes people made.

Meaningful connection.

It was priceless information.

This is just a little deeper

look at the opportunities.

You can see how we took advantage of this not opening yet.

We were able to use the great space in the street level of the bowling building.

You see the commitment from departments really wanting to get out there and meet folks.

That particular event we had 250 vendors and residents come

through.

For us it's not just enough to have the events but follow people through getting a city contract.

This is an example of a initiative with the department of public works.

We're partnering with contracts prior to them coming out.

Working with them to see how the

contracts can be more inclusive for businesses of different sizes and ownership. The two RFPs we have worked on so far one was the -landscaping RFP and the other was a recycling cart delivery. The partnership is from the beginning to the end. First we look at the contract size, itself.

We see if there is a way to make it in the recycling cart example they broke it up into two contracts to cover east and west parts of the city, north and south.

That's a contract that would have been larger.

That was a contract that was bundled into the sanitation contract.

A multi million dollar contract. The specific replacement of the recycling carts they were like this is something that doesn't have to be bundled into this.

Let's separate this out.

You need a pickup truck.

You need this amount of space.

You need dry storage.

We came up with a criteria and discussed how it would be more inclusive for a smaller business owner getting started.

That went out to bid

April 18th.

We were able to work prior to that on the RFP language.

On outreach.

We have an outreach manager,

Joshua Mcfad in.

He reached out to landscapers and hauling businesses.

We did a neighborhood

information system.

Most RFPs have a information system attached.

A lot are in the department where it's offered.

This had a information session in the department of public works.

We were able to use the Boston

water and sewer building 5-7:00 p.m. not during the workday but at a more convenient time for people.

Despite the efforts we learned we need to further diversify the vendor pool.

We didn't have a lot in our existing database.

We were limited in who we thought had the criteria required for the contracts.

In addition we saw given the bids that were submitted.

Proposals submitted that there is a strong need for capacity building.

Either people getting them in late, wrong format, small things.

So now we have, this is a lotted thanks to Joshua's leadership.

From A-Z how to fill it out. Format and page number.

All of what you need.

It's the type of thing if you're a minute late you're out.

>> If you miss a form you're out.

We are designing a new series to meet that.

Another new initiative is the next initiative is sector specific sources.

We're doing a partnership with commonwealth kitchen to certify their businesses that use this space.

So that will be the first time we're doing a sector specific.

A ton of opportunities for restaurants and catering companies to do business with the city.

We have trainings to GALAS to all kinds of events where we need food.

That is a new tish Tiff.
Trying to match the vendor pool to, to the need.

Thank you.

So we have a certification event at commonwealth kitchen. June 4th, 5-7:00 p.m.

We're still confirming details. We will support businesses there on becoming a city vendor. That's a small hurdle we have noticed through our work. You can't do business with the city if you're not in the city vendor.

That's an easy process.

Easier than being certified as a woman owned business.

It can take you ten minutes to walk someone through it we will make sure the businesses are city yendors as well.

You can't pay someone if they're a city vendor.

We are finding the gaps for specific interventions. The next piece is the quarterly data that we're here to discuss. I won't read through the numbers.

This covers the first quarter of FY19.

You can see the comparison in November.

You can see as the chief mentioned the numbers of contracts are going up for MBEs, WBEs, small and local businesses.

The trend is going in the right direction.

It's still willfully under what it should be but this is a glimpse where we are now.

>> To be clear the FY19 first quarter is compared to the FY18 year.

So this is showing trend and the move.

>> Do have a first quarter 18?

- >>
- >> We can get that to you.
- >> We will get that to you.
- >> That's trending.
- >> Trending in the right direction.

However recognizing we are way -- we have a lot of work to do.

>> And you see a increase of first quarter 2018 --

>> The number of contractors.

We think that's where the work has to be.

The willingness to contract is there.

The number of contractors is not.

We have done historic work to look at where the numbers. How many certified MWBEs the city had in the database before it dismantled the MWBE program in the early two thousands. More people were available for city contracts.

Women and minority owned business compared to today. Clearly as the shifty shifted the goals andy limit nated goals se see eliminated businesses in Boston.

Over the last couple of decades we have decimated women owned and minority owned businesses that would apply for the bids. We have a lot of work to do. This is why you hear about the efforts to certify and create more capacity in the space doing business with the city.

>> Okay.

>> This is a little more detailed information about the disparity that the chief mentioned.

We have completed phase one. December 2018.

The goal of phase one was to really assess the quality of the city's data and viability of the disparity study.

Just making sure we had the necessary data available to analyze.

It took a preliminary look at the MWBE discussion airy spent data. in the initial they field they had the information they need to move forward. Phase two was looking at the market and generating the availability of those providing serves to procure.

Now who is available out there

to perform the work.

That's what that is about.

It results in new programs for dissipate findings.

I want to highlight that we're doing the disparity study and partnership with several other departments including the procurement office, Boston of housing and public works and BPDA.

The last S I couldn't get a picture of everyone on the team. Our team is changing and growing.

We have an outreach manager. Compliance manager, Jess darks not in this picture.

She's camera shy.

And rich, the program monitor. He works with city departments to find out about contracts coming up and monitor the spending.

We also have been approved for a position for our certification work in the FY20 budget.

>> The mayor has included an additional position.

We're asking for your support and vote in the affirmative in that position when you get the chance to do such.

- >> Thank you.
- >> Thank you.
- >> Anything else to add?

Stacy, anything additional?

>> -- prior to the program changing there were Mora vail ability of women and minority businesses.

Particularly in the area of contracting for construction projects.

So, after that as we have been moving forward to engage the businesses.

Small businesses and help them we have found there are fewer and they're looking for technical assistance.

We are able to offer and provide for them.

>> Thank you, chief.

Thank you, Stacy.

>> A couple quick questions.

We have been joined by Matt

O'Malley as well.

What contracts do we spend the most money on.

What contracts is that money going to?

>> The biggest ones are public works.

Neighbor hod development.

Boston public schools.

Here we go.

Police and do it.

Those are our top five.

I didn't make that slide.

I want to mention we recently applied for the living cities

inclusive procurement

accelerator.

Cities get technical assistance and they're part of nine other cities to learn from each other about inclusive procurement practices.

And it provides incline and financial assistance for inclusive -- we are looking to create a inclusive procurement council.

In that proposal we have the department that's I listed for the most part.

BPS, purchasing do it.

All have gone into the

application with us.

If we're selected for the program we will work with five other city departments to create a procurement council and create new best practices in a consolidated buying plan which the city of Boston has never had.

>> Very good.

This maybe a function of the first quarter versus the snap of the year.

I notice the percentage of women owned business, minority and small businesses have grown minimally in 2019.

The number is less than fiscal year 18.

Can you explain to me why that's the case.

- >> The actual contracts.
- >> Correct.
- >> That is a function of the quarter.

Versus the year.

The quarter we have more than half.

More than half of contracts already then we had in 2019. I mean 2018.

It sets up for a favorable year.

You're right.

The 19 verse 28 is a function of the time frame.

>> You mentioned chapter 30B with respect to any contract over 30,000.

You suggesting flexibility in increasing contracts under 25,000 or under 50,000 or a hundred thousand or should we have discretion through 30B.

>> Low bid should be one of the factors not the only factor taken into consideration.

Past experience with a contractor on city contracts should be included as that.

The ability for the contractor to respond should be included in that.

That would allow city goals. Allowing us to look at policy and practices and take into consideration along with the low bid and recommendation for contracting.

>> And helping with technical assistance and things that had nature how much is financing. How much is bonding.

How much is insurance for companies to compete to accept the types of contracts.

The vendors need the assistance. How much is financing, workers comp.

Those factors and figures come into play if someone wants to step in and play in this arena. Are you seeing a lot that had as a deterrent.

>> Anecdotally each industry has it's challenges for participation.

The construction industry has bonding issues.

A big challenge.

A challenge in the construction space is back office.

What you have for the smaller owned businesses you have excellent trades and skills.

When it comes to paper work and back office part of this it's -- you have a small shop.

You have to figure out how to do that.

The other part is in bonding. It continues to be a challenge that we see.

Working capitol and all across the board is a challenge when you have a contract from the city that is larger than the typical contract.

You have to step up.

The working capitol and small loan is always critical.

Depending on this.

-- the city hasn't had these goals besides construction. After this disparity study we will set for the first time in city history goals in services and products.

We will then begin to understand the challenges and nuances in different industries, speaking better to construction give our history and work done there. We notice the nuance with business development in general. >> A little more involved than

>> A little more involved than shark tank with a great idea and a investor.

You need working capitol. Front of the house, back of the house, technical pieces, HR. Hopefully people are getting a grasp on how that works and the financing to support.

That.

>> Also something I know the BPDA is looking at.
We want to make it part of the

accelerator.

Even if we're not selected on how we set the insurance rates for different contracts and seeing if they're set to high it Seems to have been done in a historical fashion.

Those are pieces we want to be strategic about.

- >> Counselors, open for questions.
- >> Thank you, chairman and everyone.

I want to, just cut me off. I have a couple of rounds of buckets of questions.

So clarify my understanding of some of the terminology in terms of SLDE.

Small and local.

Is that the best measurement of a Boston based business? I was confused with the total number of 213 and then a smaller number of Boston based. I would of thought this had to

I would of thought this had to be Boston based.

be Boston based.

- >> Some call phi for small business --
- >> Can you speak into the microphone.

We have a difficult time hearing.

Thank you.

>> Some businesses that apply for certification qualify for a small business.

They may not be within Boston.

- >> Even the 199 that are Boston based are still small.
- >> Yes.
- >> What is the best way to understand total Boston based businesses even if they're not a MBE or WBE or veteran BE.
- >> That's a good question.
- >> Yes Boston based.
- >> So we have 40,000 registered businesses in Boston that meet small business definition.
- >> What is the cut off again?
- >> The 40,000 in the small

business report. Counselor, I will give you my best record.

I don't have it in front of me.

I will forward the report to

you.

I believe how thousand

registered that included.

A majority are single proprietary businesses.

>> Zol proprietary businesses.

>> Yes.

I register as a business.

>> Is there a cut off?

>> 5 million and under.

So that's the universe.

That is just small business.

>> We have 610 total certified

businesses in the database.

A lot have multiple of the types

of certifications.

610 so could be certified by the

city but not a Boston owned city.

>> So historically city and

state governments, you had to be

certified by the EBT it to do

business in the city.

You have to be certified by

Boston.

What is changing now.

I think it's the wave of the

future.

We don't want certification to

be a barrier.

We don't have the partnership of

the state.

But the state has with other

certifying entities the state

has done similar MoUs.

If you are proven to be a

minority owned business and this

is what they do, great.

We trust the profit.

You don't have to do a Boston

certification.

You want to make sure it's

willing legitimate and then move

on.

Then count to a goal in the

future if we have the ability to

have goals set in place.

To clarify on the denominator

we're talking about.

FY18 around \$774 million.

That's the discretion spend from

purchasing and procurement but not from the capitol budget.

Is that correct.

- >> I think it's both.
- >> Does it include all of the capitol contracts too.
- >> No.

That here, this includes all of the contracts.

Looking to make sure.

It's architecture engineering, capitol construction.

Other professional serves.

The, I believe the total includes construction activity as well.

Okay.

- >> What is not captured and is important is the subcontractor work.
- >> Can you go into detail what that means.
- >> So the primary contractors -contracts are awarded to the primary applicant.

They would often sub their work.

Often that's the case in construction.

You have a GC come in and build a library.

They sub contract to a group that's good with plumbing or electrical.

So on and so forth.

What we haven't done over the years is capture well whether those sub contractors are women and minority owned businesses.

>> That's because the general contractor -- the general contractors were no longer failing by the city contract. Sub contract to minority and five to women.

They pretty much stopped. So that is why a lot of the minority and women business that's actually were construction related businesses went out of business, worked with someone else or retire. That is one of the things that caused our pool of certified businesses to drop dramatically.

Also caused the dollar amounts that we were able to record to drop.

They're paid by the general contractor but not caught by the auditing system.

So this comes from the general contractor.

>> So right now we're not capturing right, what I will anecdotally say to you is a lot of money going to subs.

That is how the work is done.

Minority owned or women owned.

Historically that's where the money goes.

What we do is establish new goals like in the past and demand that we get that information to be able to report that to you.

>> We are not sure we're missing.

That it sounds like it could be one of two things.

Either we're under counting.

The money is going to subs and we don't know.

I thought I heard that the under tone is a lot of the contractors.

A lot of the supply of MWBEs dissipated because there was no requirement to prove you used a sub.

They may not go there anymore.

>> Yes.

That is true.

These are both true.

One is we're not counting some of the contracts because of the sub contractors.

Two is the number of sub contractors have dissipated because we don't have the goals. These are final numbers for

These are final numbers for FY18.

\$664 million including all of the capitol contracts and everything else.

The payer this is printed on work on the plaza, etcetera, it looks like there were slight revisions to the reports in November.

Actually adjusted what was done.

She pointed out it was 70%.

It was .72%.

That number is down to

.55 percent in terms of the

contracts going to people of

color by number and .65 percent

of the dollar value.

These are the numbers?

>> I will look at what we

presented in November and let

you know the discrepancy.

>> Is this the format that you

anticipate the quarterly reports

will start coming in.

The second update after the

November 28th report.

They called for quarterly

reports.

I wanted to confirm if this is

the chart you are working off of

or is there another report format.

>> This is our proposed.

He want to be helpful in the

discussion and make sure you get

what you need.

We would love to hear feedback

of what is helpful and not

helpful and make sure it's

consistent enough to look at one

report versus other reports.

>> I guess the only part in

editing this chart I would like

to see a clean break out of is

the Boston based piece.

Both by contracts --

>> I would like a apples to

apples first quarter 18, first

quarter 19.

The trend in that direction as

well

>> I have more questions.

I will squeeze in one more for

this section if it's okay

Mr. Chair and Madam co sponsor.

In terms of the disparity study.

The disparity study went out in

October of 2018 in terms of the

RFP, right.

Are you saying that since

October to 17 the progress is that we will see it done by

2020.

Recommendations back by 2020 for new policies.

>> Yes, to 17.

We made selections early 2018.

We signed a contract 2018.

The fact first was to make sure we had the data for a disparity study.

In 2003 the study came back in conclusive.

The popular talking point is that Boston didn't have disparities.

That is not correct.

It dismantled our programs.

We didn't have the data to back up our goals.

That's why it was in conclusive. We didn't have the data and lost it in court.

That put us in the problem we're in today.

We didn't want to launch another disparity study without the data and be in the same predicament.

This sets all cities back.

We wanted to make sure we had that.

Phase one was completed. Recently we got a report back on the data we do have, what's clean, what's available.

So the study we do run answers the questions we are asking.

And you nowhere the mayor have

to worry about a in conclusive disparity study.

>> What is the data that came back.

>> The research we did has data here that is good and data here that's good.

We have good data.

We have been working on that.

Ever since we came into the administration.

We learned why the 2003 disparity study came back in conclusive.

We have worked hard to make sure we are collect the good data. we put out an RFP.

Brought in a team to look at the

data and confirm it was good enough for a study.

They did that.

They sent back the report.

We are now launched the study.

- >> Could you share that first phase since it's done with the council?
- >> It's a pretty simple thing.
 We could get something written

for you. For the first phase.

- >> Thank you.
- >> Thank you.

A quick question before we turn over to counselor Janey.

There is, the opportunity fair.

17 city departments were represented.

I think you indicated 452 folks attended?

>> The number of folks that participated in the whole series.

The opportunity was the first one.

It was 250, I believe.

We know everyone of the 452 was awarded a contract for the city.

>> We don't have data on that now.

We have the ability to follow-up on some.

We did business in take.

The other piece we did is a partnership with Suffolk construction.

They had the trade partnership series.

That prepares businesses to do joint ventures with Suffolk.

It's pretty successful.

Out of the program we prequalified thee of the

business that's did.

- >> Moving forward keeping track of that I think that's important.
- >> We do have.
- >> We're building excitement around that and it would be great for folks to participate in that the contracts awarded.
- >> Council Flaherty we have last

summer.

Last summer we ran the pilot. We will get you that number off

the top of my head.

We celebrated HP plumbing.

A minority owned local plumbing company that received a ten

the city.

I want to get back to you.

We tracked from last summer.

thousand dollar contract from

Last summer success is why we scaled the program up and are doing more of it.

>>Thank you.

Chair recognizes co-chair woman counselor Janey.

>> Thank you.

Following up on the fair.

I attended the event at bowling.

It was wonderful.

Good job, Selina.

Thank you for your hard work as

well as the team.

Just fog up on the folks

following up on 450.

Those attended some event.

What else is happening in terms of follow-up?

We did a business in take form

for them.

There are vendors and residents that were finding out what the city was doing.

Of the businesses.

>> How many were actual

businesses hoping for a contract for the city versus residents --

>> I would love to have that

data. we had our tablets crash.

People were doing manual sign it

we tried to capture as much.

Unfortunate hee that was a big hit.

Such a large number of people there.

From the first event we don't.

The rest are vendors in the cities.

We did business in take form.

We said the types of services you provide, the type of help

you need.

All of the demographic

information.

We are tracking that information and referring them to either certification, partner programs and also working with the small business unit which is, you know, right on the same floor at 26 court street.

A sign people to other technical assistance they provide.
Our unit is focused on opportunity matching.
Where we see gaps we're able to get people over to natalya and

get people over to natalya and the small business team.

I don't have numbers.

- >> In terms of the certification what is the support that people get.
- >> I come across the few MBEs and WBEs that are not registered or certified with the city how do we help people with that process.
- >> Stacy you want to talk about the support of your team.
- >> So certification basically --
- >> That is when they come to us.

Often times they're newly created.

They're just starting out.
Besides helping them maneuver through the application itself.
Was this are five criteria and they have to meet all five criteria.

Then what I do is introduce them to whether it's a different department that will utilize the services provided.

Put them in contact with the kept or if they need assistance like maybe help with their books or marketing and things like that.

We refer them to the main street units.

So it depends on what the business needs from us at the time.

I wanted, I want to separation

and call it phase one and phase two.

Phase one of the contract was will work with the city on the data and data sets.

They went through the data sets, looked at everything and what we wanted was to be assured the data is good enough for the quality of data you need to present to establish the Lowell framework.

What tripped us up in 2003 was not having good data to establish a disparity or not.

It was in conclusive.

They used the first year for the first phase.

We're now done.

The report because was you have good data. the ding was we're not collecting enough on sub contractors.

Right.

The next phase is the legal study.

People lunch no a disparity study.

The next is the disparity study that typically takes about a year.

That will be done end of this year, early next year.

>> Good.

That is helpful.

On the sub contractors piece. At least with the construction industry we have that information.

So through the BRAQ where we track the subs and whether they meet business in terms of minority and women why not cross-reference at least for the construction field?

Is that something you can do.

- >> It's tricky BRPG tracks hours worked not spend.
- >> I'm very interested in spend. Great.
- >> So I do think that we are interested in looking at whether if this is a minority owned or women owned sub to count

favorably towards someone getting a awarded a contract. The WRP language. I think that's the next step for BJRP and construction in general.

It's not an easy

cross-reference.

Even if we were to know a sub was a minority or a woman we wouldn't know the money spent.

They're tracking work hours.

>> Why not track the spend?

I mean I think that is important.

>> It is important.

>> Last year we count the hours and it's important.

There would be huge differences depending whether or not it's a union shop versus a non union shop.

What is considered low skilled labor and highly skilled labor. Important to know the actual spend.

I think.

>> Super important to know the actual spend.

>> Is that something you will move forward on.

Is that something you look to do to track the spend?

>> Not until this is done and the legal to back the demand of. That because we didn't have that in 2000 the program was struck down.

We weren't here.

We didn't have thely framework for collecting and mandating the goals.

We lost the programs.

We want to wait for the program to return and establish a program collecting the right set of data and demanding the right sat of data.

On the other create the right demand setting up goals for people to meet.

>> I want to come back to the FY18.

The report that we received on

November 1st of last year.
The numbers are different from

your powerpoint presentation today.

I am not sure why that is.

Perhaps we can come back up as a follow-up.

A quarterly report.

>> It's not my understanding it

five departments in terms of spending.

What are the top actual

contracts.

Is it paper for example we spend the most on.

What do we spend the most on.

The top three industries.

The first is construction.

Then goods and services which I think most people think of when they think of M and WPF

they think of M and WBE. There is the transportation cost, and those are the top

three.

It's, it's much more complex than that.

Those are the top three.

>> Just a couple of more questions if I may.

Is something we have to deal with all of the contracts regardless of --

>> Okay.

>> So I would love to work with you in changing that.

I think that's important.

That can be a barrier to what it is we all hope to do here.

Always a year at a time or multi year.

Some years may be when the contract terms are over.

- >> We will have to get you a breakdown.
- >> Thank you.
- >> It would be great.

Even to get a column on this, what the planned end date is. In terms of the contracts that we have.

Just in general a sense what had is the five year cycle looking

like.

What is the average contract length.

Do you happen to know.

One year contract?

Three year contracts?

>> Sometimes they're three year contracts.

One of the things in the report I receive besides contracts what it identifies are vouchers. It could be one annual contract and every time work is done on the contract the payment is made.

You can have one contract that has ten payments on it. That would be reflected in the whole report.

So it may not tell you when the contract begins or ends.

I can review the data they send me

It will tell you at the end how much the contract was awarded for and how much was paid on it. >> Okay.

That would be helpful. I would be trying to build out maybe something you already. Have something I think the community needs a mapping of when the different types of contracts come up.

If we're doing those great

If we're doing those great outreach events and training businesses, here are the opportunities to have.

Know that the next time it comes around won't be two to four years or however long it is.

>> That's the missing piece.

Knowing the timing.

So someone doesn't have to sit at a communitier daily to see the new ones that day are.

If we know looking ahead here is when this big trash hauling contract goes out or the recycling delivery cart happens.

>> That I think is how we actually connect the opportunities, the capacity you are doing a great job of

building up.

>> That's part of the plan and procurement council and our program monitor has sent out a survey to all departments. We're trying to get back

responsive on who does

purchasing in the department.
