TODAY IS MONDAY, MAY 13 AND WE ARE HERE WITH OUR GOOD FRIENDS FROM THE BOSTON PUBLIC LIBRARY DEPARTMENT AS PART OF OUR FISCAL YEAR 20 BUDGET REVIEW, PERTAINING TO DOCKETS 0622 THROUGH 0625, ORDERS FOR THE FY 20 OPERATING BUDGET INCLUDING ANNUAL APPROPRIATION FOR SCHOOL -- FOR DEPARTMENTAL OPERATIONS ANNUAL APPROPRIATION FOR THE SCHOOL DEPARTMENT, APPROPRIATION FOR OTHER POST EMPLOYMENT BENEFITS, AND APPROPRIATION FOR CERTAIN TRANSPORTATION AND PUBLIC REALM IMPROVEMENTS. AS WELL AS DOCKET 0626 THROUGH 0628, CAPITAL BUDGET APPROPRIATIONS INCLUDING LOAN ORDERS AND LEASE PURCHASE AGREEMENTS, I WOULD LIKE TO **REMIND FOLKS THIS IS A PUBLIC** HEARING BEING RECORDED AND **BROADCAST ON COMCAST CHANNEL 8,** R CN8 TWO, VERIZON 1964 AND STREAMED AT BOSTON.GOV BACKSLASH CITY COUNCIL TV. I WOULD ASK FOLKS IN THE CHAMBER TO SILENCE THEIR CELLPHONES AND ELECTRONIC DEVICES AT DIFFERENT TIMES THROUGH THE HEARING WE WILL TAKE SOME PUBLIC TESTIMONY, FOLKS CAN SIGN IN TO MY LEFT BY THE DOOR, PLEASE STATE YOUR NAME, YOUR ADDRESS, ANY AFFILIATION AND PLEASE MARK THE BOX YES IF YOU DO WISH TO TESTIFY. THERE ARE SEVERAL WAYS THAT THE MEMBERS OF THE PUBLIC CAN TESTIFY OVER THIS BUDGET REVIEW PERIOD. YOU CAN COME TO ONE OF THE HEARINGS AND SIGN UP AS I JUST DESCRIBED.

YOU CAN COME TO THE HEARING DEDICATED TO PUBLIC TESTIMONY ON TUESDAY, JUNE 4TH BETWEEN THE HOURS OF 2:00 AND 6:00 P.M. HOWEVER WE WILL STAY AS LONG AS WE NEED TO TO HEAR EVERYONE WHO WOULD LIKE TO SPEAK ON THE BUDGET. YOU CAN ACCEPTED YOUR TESTIMONY TO THE COMMITTEE ON WAYS AND MEANS, BOSTON CITY COUNCIL, FIFTH FLOOR, BOSTON CITY HALL, BOSTON MASS, 00210, AND CCC.WM@BOSTON.GOV, IN ORDER OF THEIR ARRIVAL I AM JOINED BY MY PREPARED TO MY LEFT FROM SOUTH BOSTON, MY COLLEAGUE COUNCILOR FLYNN, TO MY IMMEDIATE RIGHT MY FRIEND FROM JAMAICA PLAIN, COUNCILOR MATT O'MALLEY, TO MY FAR LEFT, MY FRIEND FROM DORCHESTER, AT LARGE CITY COUNCILOR ANNISSA ESSAIBI GEORGE. WITH THAT I WILL TURN IT OVER THE PRESIDENT LEONARD. WELCOME. >> GOOD MORNING. THANK YOU VERY MUCH, MR. CHAIRMAN. FIRST OF ALL. CONGRATULATIONS TO YOU ON COMPLETING SO MANY YEARS OF INCREDIBLE SERVICE TO THE COUNCIL. >> THANK YOU. >> WE HAVE APPRECIATED YOUR LEADERSHIP AND YOUR SUPPORT FOR OUR WORK THROUGHOUT THE YEARS. THIS IS MY FOURTH YEAR PRESENTING AS PRESIDENT OF THE BOSTON PUBLIC LIBRARY AND FIFTH YEAR COUNTING MY YEAR AS INTERIM. I WOULD LIKE TO BEGIN WITH SOME **OPENING REVIEW STATEMENTS FROM** THE LAST 12 MONTHS AND THEN WE WILL MOVE FORMALLY TO LOOK AT THE BUDGET MATTERS AND OPEN QUESTIONS. >> OKAY.THE DOCUMENT THAT WE PROVIDED AS PART OF THE PACKAGE INCLUDES A **39 PAGE REPORT ON OUR** ACCOMPLISHMENTS AND GOALS FOR

THE YEAR, PAGES 2 THROUGH 6 INCLUDE A SUMMARY OF THAT WORK. WHICH I THINK IS BEING INCREDIBLE, OVER THE COURSE OF THE LAST YEAR, WE HAVE SEEN CONTINUED INCREASING DEMAND AND USE SAM ACROSS THE SYSTEM PO FOR THE CENTRAL LIBRARY AND AT OUR 25 BRANCH LOCATIONS THROUGHOUT THE CITY. USAGE FOR BORROWING BOOKS, USES OF SPACES, PROGRAMMING CONTINUES TO BE VERY HIGH. WE CONTINUE TO STAND UP TO THE BUDGET CHANCE WE HAVE AND REALLY MEET THE NEEDS OF THE COMMUNITY BOTH FOR BOSTON, FOR MASSACHUSETTS AND VISITORS FROM BEYOND. A KEY ACCOMPLISHMENT INCLUDE A NUMBER OF IMPORTANT HIRES ON THE LEADERSHIP TEAM. WE HAVE ADDED A NEW CHIEF TECHNOLOGY OFFICER IN THE LAST SEVERAL WEEKS, WHICH IS IN SOME WAYS THE FIRST TIME THAT MY OLD POSITION HAS BEEN BACK FILLED AT THE LIBRARY ON A PERMANENT BASIS, AND A NEW DIRECTOR OF STRATEGIC PARTNERSHIPS AND I AM PLEASED ALSO TO ANNOUNCE THAT OUR AFFILIATE ORGANIZATION FORMERLY THE FOUNDATION OF THE BOSTON PUBLIC LIBRARY NOW NAMED FUND FOR THE BOSTON PUBLIC LIBRARY HAS HIRED A NEW EXECUTIVE DIRECTOR AND WILL HAVE A PUBLIC LAUNCH OF THIS IN THE WEEKS TO COME. THE RELEVANCE OF THAT IS THAT IS HOPED TO BRING ADDITIONAL PRIVATE MONEY TO OUR BUDGET AND **REALLY CLOSE SOME OF THE GAPS** THAT WE HAVE. THE CITY'S APPROPRIATION CONTINUES TO BE STRONG AND WE WILL IN THE UPCOMING YEAR, THE PROPOSED BUDGET FROM THE MAYOR DON'T STRENGTHEN BOTH ON THE OPERATING SIDE AN ON THE CAPITAL SIDE BY ADDING A NUMBER OF LINES AND INCREASES TO OUR BUDGET. **KEY ACCOMPLISHMENTS WHICH RELATE**

TO THE BRANCHES AND I KNOW OUR

CITY COUNCIL COLLEAGUES FOCUS VERY MUCH ON THE BRANCHES AS PART OF THE SYSTEM, THE DUDLEY BRANCH RENOVATION IS PAST THE HALFWAY BUDGET AND IS ON SCHEDULE TO OPEN IN EARLY 2020. LOOKING BACK WE HAD A VERY SUCCESSFUL OPENING. REOPENING OF THE PARKER HILL BRANCH FOLLOWING MORE MODEST RENOVATIONS IN JULY OF 2018. IT, AT THE START TOFFIES CAL YEAR. DESIGN IS BEING COMPLETED FOR BOTH THE ADAM STREET BE BRANCH AND ROSLINDALE BRANCHES AS WELL AS THE RARE BOOKS DEPARTMENT OF THE CENTRAL LIBRARY. THOSE THREE PROJECTS ARE NOW ON THE GUY FINALIZING DOCUMENTATION AND GOING STRAIGHT INTO CONSTRUCTION NATURAL RENOVATION. .. AND WE HAVE KICKED OFF THE BOTH THE PUBLIC PROGRAMMING STUDY FOR THE FIELDS CORNER BRANCH AND WILL DO SO ALSO WHEN DESIGNER SELECTION IS FORMALLY COMPLETED FOR THE SAMUEL BRANCH. ADDITIONALLY, WE WERE ABLE TO ACCOMPLISH SMALLER INTERIOR OR EXTERIOR RENOVATION PROJECTS AT ABOUT THE 100,000-DOLLAR LEVEL OF INVESTMENT FOR WEST ROXBURY -- MILLS AND SOUTH BOSTON. THOSE PROJECTS ARE IN THE VARIOUS STAGES OF IMPLEMENTATION AND A FOURTH OF THOSE IS THE SOUTH END BRANCH WHICH WE WILL BE COMPLETING LATER THIS FALL. THE -- THE OTHER AREA, TWO AREAS I WOULD LIKE TO POINT OUT RELATE TO OUR COLLECTIONS WORK AND PART OF THIS RELATES TO OUR SPECIAL COLLECTIONS AREA. WE WERE VERY PLEASED TO ANNOUNCE THE EXHIBITION CURRENTLY UNDERWAY AT THE MUSEUM OF FINE ARTS OF THE 2 LOOSE LA TRACK EXHIBITION THIS IS THE LARGEST LOAN THAT THE BOSTON PUBLIC LIBRARY HAS DONE IN A SINGLE INSTITUTION CERTAINLY IN RECENT YEARS WHERE MORE THAN 100 WORKS ARE A PART OF THAT EXHIBITION,

AND RATHER THAN JUST DO THIS AS A LOAN AS WE WOULD DO INSTITUTION TO INSTITUTION, WE WERE ABLE THROUGH THE PARTNERSHIP WITH THE MSA AND THEIR SPONSOR TO ENSURE THAT ANY MEMBER OF OUR INSTITUTION. ANYONE WITH THE BOSTON PUBLIC LIBRARY CARD CAN VISIT THE MSA FOR FREE FOR THE MONTH OF JUNE AND NOT JUST SEE THE EXHIBITION BUT THE OTHER ASSETS. ALSO ENSURING WHEN WE DO A LOAN WE ARE ALSO STILL FAITHFUL TO BEING FREE TO ALL AS INSCRIBED ON THE FRONT OF OUR BUILDING. IN PUBLIC SERVICE, I IN PARTICULAR WANT TO HIGHLIGHT THREE AREA WHERE WE ARE REALLY ENGAGING MORE EXPLICITLY AND FORMALLY WITH ISSUES OF THE DAY. THE FIRST RELATES TO THE BY LOT PROGRAM WITH PINE STREET INN WHERE WE ADD ADD SOCIAL WORK OUT **REACH NAVIGATOR TO OUR STAFF AND** THAT PERSON HAS BEEN RESPONSIBLE FOR SEVERAL INDIVIDUALS **OBTAINING HOUSING AND WE ARE --**IF THE BUDGET IS APPROVED AS PRESENTED WILL BE ADDING CAPACITY TO THAT TEAM OVER THE COURSE OF THE COMING YEAR. SECONDLY. WE LAUNCHED A WIFI HOT SPOT LENDING PROGRAM WHERE MEMBERS OF THE PUBLIC WITH A LIBRARY CARD CAN GO TO A BRANCH AND BORROW A HOT SPOT WHICH IS A SOLUTION TO THOSE WHO DO NOT HAVE ACCESS TO BROADBAND AT HOME OR CANNOT AFFORD A FULL-SERVICE DATA PLAN ON THEIR PHONES, AND ANOTHER WAY OF ENSURING THAT ALL OF THE RESIDENTS OF OUR CITY AND STATE HAVE ACCESS TO THESE SERVICES AND THE RESOURCES THEY NEED IN THEIR OWN LIVES. ADDITIONALLY, IN THE, IN THE PROGRAMMING SPACE WE CONTINUE TO PICK UP THE THEMES OF SOCIAL JUSTICE AND OF COURSE OVER THE LAST YEAR NOTABLE WOMEN AND OTHER ISSUES THAT ARE BEING WELL ATTENDED. EVERYTHING FROM DEMOCRACY AND CAPITALISM, DUE TO

GUN CONTROL ADVOCACY AND OTHER PROGRAMS AS WELL. AT THIS POINT, I THINK YOU CAN GET A SENSE OF THE OVERALL ACCOMPLISHMENTS. THE MAIN GOALS FOR NEXT YEAR CONTINUE TO INVOLVE IMPROVING **OPERATIONS, ENSURING THAT OUR** CAPITAL PROJECTS ARE CONTINUED TO BE EXECUTED ON SCHEDULE AND ON TIME, AND BUILDING OUT OR WORKING WITH OUR AFFILIATES TO BUILD TOUT PRIVATE FUND-RAISING CAPACITY SO THAT WE CAN CONTINUE TO MEET THE DEMAND OF THE GENERAL PUBLIC AS WELL AS BRING NEW SERVICES INTO THE MIX. IN ADDITION TO THE TRADITIONAL SERVICES THAT WE OFFER, WHETHER IT IS PRINTED BOOKS, E BOOKS OR OTHER OPTIONS. AS WE LOOK FORWARD TO THE **OPERATING BUDGET, WE SEE** INCREASES SPECIFICALLY FOR OUR COLLECTIONS BUDGET, FOR SECURITY ACROSS THE SYSTEM. AS I AS I NOTED FOR EXPANSION OF OUTREACH SERVICES AND ADDITIONALLY WE HAVE FUNDING PROPOSED TO ADD FOUR ADDITIONAL POSITIONS TO OUR BUDGET NEXT YEAR, THREE OF WHICH ARE FRONT LINE PATRON FACING SERVICES. MR. CHAIRMAN, I WILL PAUSE THERE AND WILL GO TO THE FINANCIALS AND OTHER QUESTIONS YOU MAY HAVE. >> THANK YOU. THANK YOU VERY MUCH AND WE HAVE BEEN JOINED BY MY FRIEND FROM BACK BAY COUNCILOR JOSH ZAKIM. >> LET ME JUST DIVE INTO A LITTLE DISCREPANCY, BUT I THINK I KNOW WHAT IT IS. LAST YEAR'S APPROPRIATION WAS A LITTLE SHY OF 37 MILLION AND IT SHOWS IN THE CURRENT THAT WE **ACTUALLY APPROPRIATED 38.1, IS** THAT DUE TO COLLECTIVE BARGAINING. >> COLLECTIVE BARGAINING -- THIS YEAR. >> GREAT. >> --

>> RIGHT. SO TO THE ACTUAL REFLECTED IN BRINGING THEM UP TO WHERE THEY SHOULD HAVE BEEN --->> CORRECT. >> -- LAST YEAR. GREAT. >> AND BEEN FUNDED BY THE RESERVE THAT THE CITY HOLDS. >> RIGHT. GREAT. AND THEN THE STAFFING. I WAS LOOKING, IT LOOKS LIKE YOU -- YOU SAID YOU ADDED FOUR NET **POSITIONS**? BUT REFLECTED IN THE BUDGET BOOK, IT LOOKED LIKE 4 -- WHERE DO I HAVE IT? IT WAS 492? THERE WERE. >> THERE WERE SOME DOUBLE COUNTED POSITIONS FROM THE PRECEDING YEAR THAT WERE CARRIED FOR REASONS OF SWAPPING AND **REPURPOSING AND SO IN THE TRANSITION FROM FY 19 INTO FY-20** THAT DUPLICATION IS BEING **REMOVED SO IN EFFECT THE HEAD** COUNT REMAINS FLAT AND THEN WITH FY-20 WE ARE PLANNING TO ADD FOUR ADDITIONAL POSITIONS, ONE FOR, ONCE THE BUDGET IS APPROVED, INCLUDING CHILDREN AND TEEN LIBRARY SERVICE. >> GREAT. AND YOU MENTIONED EARLIER THE NEW CHIEF OF TECHNOLOGY AND THE STRATEGIC PARTNERSHIP. >> YES. THOSE BECOME FILLED POSITIONS AS WELL AS OPPOSED TO NET NEW POSITIONS. ALTHOUGH FOR THE YEAR PRECEDING ONE OF THOSE WAS AN ENTIRELY NEW POSITION ADDED TO THE -->> I GUESS MORE OF A CENTRAL LIBRARY QUESTION, I HAVE HEARD MORE AND MORE PEOPLE GETTING MARRIED AT THE FACILITY, AT THE CENTRAL LIBRARY. CAN YOU SPEAK A LITTLE TO WHAT YOU ARE SEEING, ANY TRENDS? IS IT PO1ITIVE? >> SO WE CONTINUE TO HAVE A VERY

STRONG EVENTS TEAM IN PARTNERSHIP WITH THE CATERED AFFAIR WHO IS THE CURRENT INCUMBENT OF THE CATERING CONTRACT. TO MARKET AND DRAW NOT JUST WEDDINGS BUT CORPORATE EVENTS AND OTHER PRIVATE EVENTS THAT ARE HELD AT THE LIBRARY, AFTER HOURS MOSTLY, AND MOSTLY ON WEEKS AFTER-HOURS. AND I THINK THE ONE TREND THAT WE ARE AWARE OF BETWEEN FY 19 AND 20 IS THAT WE DID A LARGER, LARGE NUMBER OF EVENTS BUT NOT **QUITE AS MANY AS TRULY LARGE** EVENTS .. TAKING FULL ADVANTAGE OF THE ENTIRE FACILITY. AND SO THAT IS ACTUALLY A NET POSITIVE TO US. ADDITIONALLY I WOULD DRAW YOUR ATTENTION TO ONE OF THE CAPITAL PROJECTS THAT WAS FUNDED LAST YEAR, BUT WE WILL BE FORMALLY COMMENCING. IN FACT WE HAVE FORMALLY COMMENCED IT WHICH IS A REVIEW OF THE PROGRAMMING AND **RESTORATION NEEDS OF THE** MCKENDALL BUILDING, 1985 BUILDING ON COPLEY SQUARE AND TAKING A DEEPER DIVE IN LOOKING AT THE BUILDING IN TERMS OF WHAT IT NEEDS IN TERMS OF **RESTORATION, INDEED IF THERE IS** WEAR AND TEAR THAT HASN'T BEEN ADDRESSED THROUGH NORMAL **OPERATIONS AS WELL AS OPPORTUNITIES TO PROGRAM SPACE** THAT IS NOT CURRENTLY IN SERVICE AND WE HOPE ULTIMATELY PROVIDING EXPERIENCE TO ACCESS OUR SPECIAL COLLECTIONS. THAT WOULD BE THE JOHNSON **RENOVATION EQUIVALENT, BUT IN A**

MORE HISTORIC AND PRESERVATION LENS, IF YOU WILL. >> GREAT. AND THEN SOMETHING MORE CLOSER TO MY HOME, GOOD TO SEE YOU, EMON, COULD YOU JUST GIVE ME THE LATEST UPDATE FOR THE PUBLIC 0 ASSUMPTION, CONSUMPTION **REGARDING THE LIBRARY, WE** APPROPRIATED MONEY FOR DESIGN IN THE FY 19 BUDGET WHICH WE ARE IN, CAN YOU GET US UP TO SPEED ON WHERE THAT PROCESS IS NOW? WE HAD OUR OWN CONVERSATION THIS WEEK ABOUT SELECTION AND GETTING **READY TO MOVE FORWARD SO --**>> SURE THING. THE -- THANK YOU. CAN YOU HEAR ME? THANK YOU. SO THE TOTAL PROJECT BUDGET FOR THE NATHANIEL PROJECT IS 12.6 MILLION. WE HAVE 20 -- WE HAVE \$100,000 **APPROPRIATED IN FY-20 AND THAT** WILL BE LARGELY FOR THE DESIGN PROCESS. SO THE CITY -- WELL THE LIBRARY ALONG WITH THE PUBLIC FACILITIES DEPARTMENT GOT TOGETHER AND COMPLETED DESIGNER SELECTION. AND THAT WILL KIND OF FOLLOW THE PROGRAM STUDY OR MAKE SURE THAT THE PROGRAM STUDY IS REFLECTED IN THE DESIGN AS WELL? >> THAT'S ABSOLUTELY CORRECT. SO THE PROGRAMMING STUDY SETS UP ALL OF THE CRITERIA FOR THE DESIGN AND THE DESIGN ESSENTIALLY, USING THAT AS A ROAD MAP TO DELIVER THE PROJECT AT THE COMMUNITY --

>> AND WE HAVE THE BENEFIT IN THIS CASE OF HAVING A VERY DETAILED PROGRAMMING STUDY THAT THERE WAS A LOT OF COMMUNITY ENGAGEMENT REGARDING, AND SO MY PERSONAL BELIEF IS THAT THAT ENDED WITH A VERY STRONG SENSE OF DIRECTION, SO AS THE NEW ARCHITECT ONCE APPROVED CAN MOVE FORWARD WITH THAT, THERE IS VERY LITTLE REINVENTING OF THE WHEEL OR STARTING FROM GROUND ZERO THAT NEEDS TO HAPPEN. >> RIGHT. >> IT HAS BEEN A COUPLE OF YEARS SO THERE WILL NEED TO BE SOME **REFRESH AND ASSURE ASSUMPTIONS** ARE THE SAME, BOTH IN TERMS OF WHAT WE THINK MAKES SENSE BUT ALSO IN TERMS OF WHAT THE COMMUNITY MAKES SENSE, BUT WE DO **BENEFITS IN THIS CASE FROM** HAVING A VERY STRONG PROGRAMMING STUDY THAT LED US TO WHERE WE ARE. >> WELL, GREAT. THANK YOU FOR ANSWERING MY QUESTIONS AND WE HAVE BEEN SINCE JOINED BY MY PREPARED FROM HYDE PARK, COUNCILOR TIMOTHY MCCARTHY AND MY FRIEND FROM DORCHESTER, COUNCILOR FRANK BAKER LET ME NOW RECOGNIZE COUNCILOR FLYNN. >> THANK YOU, COUNCILOR CIOMMO AND THANK YOU TO THE PANELISTS FOR BEING HERE. AND, DAVID, I HAVE A FEW FEW OUESTIONS. OUR MUTUAL FRIEND MARLENE FROM THE FRIENDS ON THE SOUTH END LIBRARY IS HERE AND WE TALK TO HER FREQUENTLY. SO I WILL GIVE A HIGH LEVEL AND THEN ASK DAMON TO COMMENT ON THE ACTUAL TIMELINE. SO AS I THINK OVER THE COURSE OF THE LAST YEAR, WE ALL MAY REMEMBER THERE WERE TWO TRACKS

APPROVED, ONE FOR INTERIOR **REFRESH AND IMPROVEMENTS AND** THAT WORK IS LARGELY FOCUSED ON PAINTING. CARPETING AND WHAT WE HAVE IN THE CASE OF THE SOUTH END THAT WE DON'T ALWAYS HAVE IS A VERY STRONG FRIENDS GROUP WITH THE ABILITY TO DO INDEPENDENT FUND RAISING SO IN THEIR CASE THEY BROUGHT ADDITIONAL FUNDS TO TO THE TABLE, SOME OF WHICH WE HOPE TO USE FOR SOME INTERNAL FURNITURE IN ADDITION TO THE CITY APPROPRIATED WORK AND THAT SHOULD BE HAPPENING AND WE CAN SPEAK TO THIS OVER THE NEXT SIX MONTH. AGAIN THE FRIENDS HAVE BEEN VERY INVOLVED IN THAT PROCESS AND CONTINUE TO PUSH US FORWARD -- A LITTLE BIT MORE SO I THINK WE WILL END UP WITH A VERY STRONG INTERIM SET OF IMPROVEMENTS THERE. THE OTHER AGREEMENT THAT WE HAD WITH THE FRIENDS, WITH YOURSELF, WITH OUR CITY COLLEAGUES WAS THAT THE NEXT LOGICAL STEP WAS TO DO A FULL PROGRAMMING STUDY FOR THE BRANCH IN THE SOUTH END, SO THAT WE KNOW WHAT ITS FUTURE **REQUIREMENTS TRULY ARE AND THAT** IS ONE OF THE PROGRAMMING STUDIES THAT IS SLATED TO COMMENCE IN THE UPCOMING FISCAL YEAR. THERE ARE A NUMBER OF PROGRAMMING STUDIES, AS YOU AND YOUR COLLEAGUES WILL NOTE, AND SO THERE MAY BE SOME **OPPORTUNITIES TO COMBINE SOME** EFFORTS AND WE WILL BE WORKING WITH OUR COLLEAGUES AT PROPERTY IN THE CONSTRUCTION MANAGEMENT FACILITIES DEPARTMENT TO SEE WHERE THERE ARE OPPORTUNITY TO TAKE ADVANTAGE OF THE ECONOMIES

OF SCALE AND MOVE MORE QUICKLY THAN WE WOULD NORMALLY BE ABLE TO DO.

THANK YOU, DAVID AND I AM ENCOURAGE BY YOUR COMMENTS. AS YOU KNOW SOUTH END LIBRARY PROVIDES EXCELLENT SERVICES TO SO MANY PEOPLE IN THE NEIGHBORHOOD, ESPECIALLY MANY OF OUR FRIENDS IN THE VILLAGE OF --AS WELL SO I AM PROUD THAT PROGRAMMING STUDY IS MOVING FORWARD. >> COULD I SHIFT A LITTLE BIT ON THE CHINATOWN LIBRARY? WE HAVEN'T HAD A LIBRARY IN THAT COMMUNITY IN 50 YEARS UNDER MAYOR WALSH WE HAVE AN EXCELLENT TEMPORARY LIBRARY. I KNOW WE ARE MOVING FORWARD ON POTENTIALLY HAVING A PERMANENT LIBRARY WHICH IS VERY ENCOURAGING SO I WANT TO SAY THANK YOU TO YOU. AND TO THE WALSH ADMINISTRATION. CAN YOU GIVE US A LITTLE BIT OF UPDATE ON WHAT THE LATEST IS? >> WE HAVE STAYED VERY CLOSE TO OUR COLLEAGUES AT BPD ATTACHMENT AND THE FRIENDS OF THE CHINATOWN LIBRARY IN TERMS OF THE DIFFERENT OPPORTUNITIES IN THE NEIGHBORHOOD. **BPDA, THIS IS SUCH A DENSE** NEIGHBORHOOD .. THAT THERE ARE VERY LIMITED NUMBER OF POSSIBLE SITES WHERE A PERMANENT HOME --A NEW HOME FOR THE CHINATOWN LIBRARY COULD BE. THE ACTIVE DEBATE, THE ACTIVE CONVERSATIONS RELATE TO THE PARCEL 12 LOCATION AND THIS IS A PROCESS THAT FALLS DIRECTLY UNDER THE BPDAS AUTHORITY AT THIS POINT BUT OUR CONVERSATIONS WITH THE DEVELOPER WITH THE BPDA AND WITH THE FRIENDS, THE **DEVELOPERS IN PARTNERSHIP -- IT** IS A PARTNERSHIP BETWEEN A COUPLE OF ENTITIES, INCLUDING THE ASIAN COMMUNITY DEVELOPMENT CORPORATION AND I AM VERY CONFIDENT THAT WE ARE ALL HEADED IN EXACTLY THE SAME DIRECTION AND THAT SUBJECT TO BPDA APPROVAL BECAUSE THEY HAVE THE AUTHORITY AT THIS STAGE OF THE PROCESS THAT WE WILL HAVE STRONG NEWS IN THE NOT-TOO-DISTANT FUTURE. >> THANK YOU.

I KNOW THAT IS ENCOURAGING AND THANK YOU FOR YOUR LEADERSHIP ON THAT IMPORTANT ISSUE. IT IS GOING TO BE A TREMENDOUS ASSET FOR THE COMMUNITY TO HAVE THE NEW LIBRARY IN CHINATOWN. >> SINCE 1953, I BELIEVE. >> AND YOU ARE HEADING INTO YEAR THREE OF THE TEMPORARY LOCATION AT THE CHINA TRADE CENTER, EVEN THOUGH IT IS ONLY A 15 SQUARE FOOT SPACE IT IS WELL SUCCESS AND GOOD ATTENDANCE. >> THE HEAD LIBRARIAN HAD A CHANCE TO MEET HER SEVERAL WEEKS AGO AND DOING AN OUTSTANDING JOB:THANK YOU. >> THE SOUTH BOSTON PUBLIC LIBRARY, I KNOW THEY ARE DOING THE COURTYARD OUTSIDE OVER, I HAD A CHANCE TO GO BY THERE LAST WEEK. I KNOW IT IS IN SOUTH BOSTON MOTHERS TODAY WERE ASKING ME **ABOUT A CHANGING -- A CHANGING** STATION FOR THEIR CHILDREN MAYBE IN THE, I GUESS MAYBE THE WOMEN'S ROOM THRSM IS ONE THERE BUT IF IT COULD BE A LITTLE LARGER, BUT ALSO OVERALL GOAL IS TO, AS WE ARE GOING TO DO ON THE SOUTH END AND CHINATOWN IS BUILDING A NEW, BUILD IS BUILD A NEW BUILDING IN SOUTH AND CHINATOWN AS WELL. ANY THOUGHTS OR COMMENTS ABOUT **BEING A. BUILDING A NEW LIBRARY** THAT WE CAN WORK TOGETHER AND WITH THE ADMINISTRATION? AND JUST IN THE SHORT-TERM IF WE CAN MAYBE ADDRESS THAT ISSUE 0 OF THE CHANGING STATION. FOR THE MOTHERS AND FATHERS. >> I WOULD BE HAPPY TO TAKE THAT UNDER CONSIDERATION. ALONG WITH MANY OTHER THINGS THAT WE NOW CONSIDER, YOU KNOW, JUST A STANDARD OFFERING THAT WE SHOULD HAVE IN ALL OF OUR LOCATIONS, WHERE THERE ARE **OPPORTUNITIES TO ENSURE THAT** THERE ARE CHANGING STATIONS IN MORE TAN ONE OF THE REST ROM FACILITIES, THAT MAKE SENSE

WHETHER HE CONTINUE TO DO THAT, AND WE WILL TAKE THAT UNDER CONSIDERATION AND WE WILL HAPPILY UPDATE YOU THERE. WITH RESPECT TO THE LONG-TERM POSSIBILITIES, YOU KNOW, WE ARE NOW IN YEAR 3 OF WHAT HAS BEEN THE STRONGEST AND LARGEST CAPITAL BUDGET COMMITMENT BY THE CITY AND BY THE MAYOR AND HOPEFULLY AGAIN THIS WILL BE THE CASE WITH YOUR APPROVAL IN FY-20. ALL RENOVATIONS ACROSS THE SYSTEM. AND SO ALL OF THOSE LOCATIONS THAT WE FLAGGED NEEDING SUBSTANTIAL WORK IN OUR PROCESS IN 20-- 2012 -- NOW HAVE A PROJECT. OF COURSE, TIME HAS MOVED ON SINCE THAT ORIGINAL STUDY WAS DONE AND THERE IS A NEXT LEVEL OF ASSESSMENT WORK WE NEED TO DO AND SO WE AGAIN WOULD HAPPILY WELCOME DIALOGUE ABOUT ANY OF THOSE LOCATIONS THAT DON'T YET HAVE A LONG-TERM PLAN BUT I WOULD NOTE THIS IS ALREADY A STRONG .. CAPITAL PLAN AND OUR BOWL IS TO EXECUTE THAT WHICH IS ALREADY APPROVED SUCCESSFULLY AS WE POSSIBLY CAN BUT IN THE MEANTIME WE ARE HAPPY TO HAVE FUTURE CONVERSATIONS ABOUT OTHER AREAS THAT HAVE NEEDS TOO. >> THANK YOU. >> COUNCILOR O'MALLEY. >> THANK YOU, MR. CHAIRMAN, AND GOOD MORNING, LADIES AND GENTLEMEN, THANK YOU FOR THE GREAT WORK YOU DO EACH AND EVERY DAY. LIKE MANY PEOPLE I WAS LUCKY ENOUGH TO HAVE GROWN UP IN THIS CITY AND GOING TO THE WEST ROXBURY BRANCH LIBRARY AS A KID. IT IS SOMETHING I LOOK FORWARD TO EVERY WEEK, AND I REALLY VALUE THE LIBRARY SYSTEM IN BOSTON AND I MEAN THIS IN ALL SINCERITY. I THINK THE SYSTEM IS BETTER RUN NOW THAN IT EVER HAS AND I WANT TO REALLY ACKNOWLEDGE MAYOR

WALSH'S COMMITMENT, YOUR LEADERSHIP, DAVID, YOUR INCREDIBLE TEAM, SOME REALLY GREAT THINGS ARE HAPPENING AND I APPRECIATE NOT ONLY THE RESOURCES, THE SUPPORT, THE BUDGET GROWING AS IT SHOULD, I AM HOPEFUL IT CAN GROW A LITTLE MORE WHEN WE ARE DONE WITH THIS PROCESS BUT YOU HAVE ALSO BEEN NIMBLE AND REEKED TO THE FACT PEOPLE USE LIBRARIES DIFFERENT NOW THAN WHEN MANY OF US FIRST WENT.

THAT IS VERY IMPORTANT. FIRST QUESTION IT IS MORE OF A REQUEST. I HAVE A NUMBER OF YOUNG PARENT IN MY DISTRICT, OBVIOUSLY, AND THEY REALLY LOVE THE PROGRAMMING THAT IS OFFERED IN BRANCH LIBRARIES DURING THE WEEK.

THERE IS OFTEN A BILINGUAL STORY HOUR, AT THE CONNOLLY BRANCH LIBRARY WHICH IS VERY POPULAR AND OTHER THINGS AT WEST ROXBURY.

THE OTHER ISSUES IS THE CENTRAL LIBRARY IS THE ONLY ONE THAT OFFERS PROGRAMMING ON SATURDAYS OR SUNDAYS.

PROBABLY BECAUSE OF A JUST THE WAY THE SHIFTS WORK, I ASSUME, BUT GIVEN THE FACT THAT SO MANY PARENTS WORK AND WANT TO BE ABLE TO TAKE ADVANTAGE OF THESE WONDERFUL OPPORTUNITIES, CAN WE OR HOW DO WE ABLE -- EVEN IF IT IS ONE SATURDAY OR ONE SUNDAY A WEEK, IN SOME OF THE BRANCH LIBRARIES IS THERE A WAY TO OFFER SAM OF THAT PROGRAMMING IN THE WEEKENDS?

>> NOT EVERY WEEK BUT AT LEAST MAYBE ONCE A MONTH?

>> MICHAEL, DO YOU WANT TO TAKE THAT? >> THANK YOU. YES. I BELIEVE THIS ISSUE CAME UP THROUGH SOME OF THE CONSTITUENTS AT THE JP BRANCH.

>> YES.

AND PRISCILLA FALL THE DIRECTOR OF THE BRANCHES HAS SPOKEN TO KP AND HAVE ALREADY BE IF UNSTARTING TO DO SOME PROGRAMMING ON SATURDAYS, I BELIEVE. IT IS A SCHEDULING ISSUE WITH STAFF. >> JP IS ONE OF THE BUSIEST, IS, IS THE BUSIEST BRANCH IN THE SYSTEM, IT IS DIFFICULT TO KEEP UP WITH THE PEOPLE COMING IN AND OUT OF THE DOOR BUT WE HAVE LIBRARIES THAT MOVE FROM BRANCH TO BRANCH. SO BY SCHEDULING AN EXTRA FLOATER ON THE DAYS THAT THE -- PROGRAMMING WE CAN ACCOMMODATE. SO WE PLAN TO DO THAT ALREADY. >> THAT'S GREAT. OKAY. WE WILL JUST ADD THAT ALL OF THE BRANCH LOCATIONS DO HAVE OPENING HOURS ON SATURDAY BUT NOT SUNDAYS. >> YES. >> AND SO WHERE THERE IS **OPPORTUNITY, WE ARE CONTINUING** TO TRY AND ADD SOME PROGRAMMING ON THE SATURDAY MORNINGS AT LEAST. >> THAT'S GREAT. >> WHERE THAT IS APPROPRIATE. YOU WILL SEE IN THE FY-20 PROPOSED BUDGET THAT THREE OF THE FOUR NEW POSITIONS PROPOSED ARE IN CHILDREN AND TEEN SERVICES AND SO EVEN IF THOSE ARE BASED AT CENTRAL IT ADDS MORE CAPACITY TO THAT LAYER OF OUR OFFERINGS ACROSS THE SYSTEM. AND WOULD FREE UP SOME OF THE FLOATERS POSSIBLY ON THE WEEKENDS. SO THAT IS CERTAINLY WHAT WE WOULD LOVE TO DO. IT IS KIND OF BEING VICTIMS 0 OF OUR OWN SUCCESS. >> YES. MR. CHAIRMAN, EVERY, I WISH EVERY BUDGET HEARING WENT SO SMOOTHLY. YOU ASK FOR SOMETHING AND YOU GET IT.

YOU GUYS ARE DOING WELL. CAN YOU TALK ABOUT DIEGO AND SQUARE BRANCH RENOVATIONS. I WILL PASS THAT BACK TO -->> SURE. SO ONE OF THE THINGS WE SHOULD PREFACE WITH ALL CAPITAL PROJECTS IN THE UPCOMING YEAR WE ARE GOING TO BE IN DISCUSSIONS WITH THE PUBLIC FACILITIES DEPARTMENT AND SO WE BOTH SHARE CAPACITY ISSUES FROM TIME TO TIME AND WE HAVE TO COORDINATE BOTH OF OUR SCHEDULES SO THERE ARE TIMES WHERE WE ARE READY AND THEY ARE NOT AND VICE VERSA. SO ED SON WE HAVE HAD SOME DISCUSSIONS THIS CAREER IN THE PUBLIC ASSETS CONVERSATIONS SO THAT HAS BEEN SORT OF PART OF AN ACTIVE DISCUSSION. IN TERMS OF NEXT YEAR, WE ARE GOING TO START A PROGRAMMING STUDY FOR -- AND SO WE DON'T HAVE THAT IN THE TIMELINE YET, JUST YET OF EXACTLY WHERE IT WILL FALL IN THE YEAR BUT LIKELY IT WILL BE THIS THE FALL OR EARLY WINTERTIME FRAME. >> OKAY.AND I KNOW THESE THINGS TAKE TIME AND SO INCREDIBLY GRATEFUL TO OUR PARTNERSHIP WITH THE JAMAICA PLAIN BRANCH. ONE THING I AM VERY PROUD TO HAVE PLAYED A LEADERSHIP ROLE IN THIS. THIS IS MORE OF A SUGGESTION GOING FORWARD IS THAT, YOU ARE GOING TO HAVE SORT OF -- BECAUSE MANY OF THE FACILITIES ARE OLD AND ARE IN DISREPAIR YOU ARE GOING TO HAVE SORT OF A **CLAMORING FOR EVERY -- WHEREVER** DISTRICT COUNCILOR IS GOING TO MAKE THE CASE FOR HIS OR HER BRANCH LIBRARIES. MAYBE IT WOULD MAKE SENSE GOING FORWARD, LOCK AT A 10. 20 YEAR PLAN, ALMOST SIMILAR TO BUILD BPS IN TERMS OF WHEN WE CAN EXPECT THINGS BECAUSE I DO THINK SOMETIMES PEOPLE EXPECTATIONS CAN'T BE MET AS WELL AS PERHAPS WE WOULD LIKE THEM TO.

SO I KNOW IT IS GOING TO HAPPEN, BUT I WANT TO SET EXPECTATIONS AT A REASONABLE SORT OF LEVEL WITH MY FOLKS. >> SURE. AND ONE OF THE THINGS I WANT TO ADD TO DAVID'S POINT EARLIER BECAUSE OF SOME OF THE CAPACITY **ISSUES WE ARE GOING TO BE** LOOKING THIS YEAR TO BUNDLE SOME OF THESE PROGRAMMING STUDIES, NOT THE DESIGN PROCESS BUT JUST THE PROGRAMMING -- THIS COULD BE A CANDIDATE WHERE WE ARE WORKING ON MULTIBRANCHES AT ONCE. >> GOOD. AND THEN BRIEFLY BEFORE MY TIME EX-FOR ROUND CAN YOU TALK A LITTLE BIT TO THAT END THERE HAS BEEN SOME TALKING AT LOOKING AT A MIXED USE DEVELOPMENT, SOME OF THE BRANCH RENOVATIONS I, I LOVE THE IDEA IF WE COULD GET TO NET ZERO CARBON EMISSIONS. COULD WE TALK ABOUT SORT OF THAT AND I MEAN IT IS MOSTLY MANY, SERVE THE MORE DOWNTOWN BRANCHES WE ARE WILL BEING AT THAT. >> YES. >> THIS HAS BEEN A VERY INTERESTED AND COMPELLING IDEA TO RESEARCH. WE HAVE LOOKED AT EXAMPLES BOTH FROM NEW YORK, CHICAGO AND OTHER PARTS OF THE COUNTRY WHERE THEY HAVE SOME CASES OF MIXED USE, IN SOME WAYS THE CENTRAL LIBRARY IS MIXED USE BECAUSE WE NOW HAVE THIS GBH STATION THROUGH THAT PARTNERSHIP AS WELL AS THE --AFFAIR ROOM RENTAL **OPPORTUNITIES.** SO WE ARE USED TO DOING MIXED USE AT SOME LEVEL BUT THE IDEA OF DOING LOW OR AFFORDABLE HOUSING IN CONJUNCTION WITH A LIBRARY IN A NEW SPACE AND SO THE FIVE LOCATIONS WHERE THIS IS FORMALLY ON THE TABLE FOR AT LEAST EXPLORATION, I THINK WAS COUNCILOR BAKER WHO WAS VERY FIRM ON THIS, TWO YEARS AGO THAT WE START LOOKING TIMOR FORMALLY, THE FIVE WHERE WE HAVE

IDENTIFIED THIS AS POSSIBLE, NOT THAT IT WILL DEFINITELY HAPPEN THERE BUT WE SHOULD EXPLORE IT, INCLUDES FIELDS CORNER WHICH IS CURRENTLY UNDERWAY AND THIS IS BEING DISCUSSED PUBLICLY AT THE TWO COMMUNITY MEETINGS WE HAVE HAD THERE SO FAR AND THE COMMUNITY SEEMED VERY OPEN TO IT.

OBVIOUSLY THE DEVIL WILL BE IN THE DETAILS AND WE WANT TO SEE MORE, BUT FIELD CORNER, ECHOLS SON SQUARE, THE WEST END .. CHINATOWN WILL PROBABLY ALL GOING WELL WILL REALLY BE THE BEST EXAMPLE OF MIXED USE ALTHOUGH I DON'T KNOW WHAT THE MIX OF HOUSING SPECIFICALLY WILL BE ON THAT DEVELOPMENT. AND THE FIFTH ONE IS ESCAPING

ME.

SO WE CAN GET BACK TO YOU ON THAT.

OF COURSE THAT IS MULTISITE RFP AND SO WHETHER THERE IS ACTUALLY HOUSING AND/OR A DIFFERENT USE IN COMBINATION WITH A LIBRARY ON THE SPECIFIC SITE WILL REMAIN TO BE SEEN BUT AS A MULTISITE DEVELOPMENT, THAT CERTAINLY WILL BE A MIXED USE PROCESS:GREAT. THANK YOU, DAVID, MICHAEL, ELLEN, FOR ALL OF YOUR GREAT WORK.

AND THANK YOU PARTICULARLY FOR THE INCREDIBLE FRIENDS OF -- WE ARE LUCKY TO HAVE SUCH DYNAMIC FRIENDS OF OUR BRANCH LIBRARIES. THERE HAS BEEN SOME GREAT CROSS COLLABORATION, AT THE BRANCH WE HAD FOLKS FROM, FOLKS FROM WEST ROXBURY AND COUNCILOR MCCARTHY'S DISTRICT COME AND HELP WALK THEM THROUGH THE PROCESS AND SEEING INCREDIBLE PROGRAMMING. GREAT AUTHOR TALKS AND IT IS REALLY --THEY HAVE BEEN THE UNSUPERVISING HEROES AND A GREAT PARTNERSHIP WITH ALL OF YOU. THANK YOU. >> AND WE HAVE BEEN JOINED BY

CITY COUNCIL PRESIDENT ANDREA CAMPBELL AND HER SON. >> THE CHAIR RECOGNIZES COUNCILOR ESSAIBI GEORGE. THANK YOU, CHAIR AND THANK YOU ALL FOR BEING HERE TODAY TO. TODAY AND ALL OF THE WORK YOU DO ACROSS OUR NEIGHBORHOODS AND PARTICULARLY IN THE DOWNTOWN BRANCH WHICH IS THE FLAGSHIP, ALTHOUGH I THINK EVERY NEIGHBORHOOD THINKS THEIR LIBRARY IS THE FLAGSHIP. THROUGH COURSE OF THE YEAR WE OFTEN TALK ABOUT THE IMPACT THAT OUR HOMELESS COMMUNITY HAS WITHIN OUR BRANCH LIBRARIES AND IN THE DOWNTOWN BRANCH AND THE WORK THAT -- AND THE OPPORTUNITY THAT THE LIBRARIES HAVE TO CONNECT INDIVIDUALS DEALING WITH HOMELESSNESS, DEALING WITH SUBSTANCE ABUSE DISORDERS, DEALING WITH MENTAL HEALTH DISORDERS. THERE ARE OPPORTUNITIES TO SUPPORT THEM, CAN WE TALK A LITTLE BIT ABOUT HOW WE HAVE CHANGED THE MODEL, HOW WE PROVIDE THOSE SERVICES AND SUPPORT THAT WORK AND IN OUR LIBRARIES? >> SURE. THANK YOU SO MUCH. THIS IS WORK THAT LIBRARIES AND LIBRARY STAFF HAVE BEEN DOING FOR MANY, MANY, MANY YEARS AND SO THE CURRENTLY. >> CURRENT CRISES THAT WE SEE FOR PATRONS AT RISK REALLY HAS TAKEN IT TO A MORE FORMAL STEP. OVER THE COURSE OF THE LAST YEAR, WE TOOK A VACANT LIBRARIAN POSITION AT THE CENTRAL LIBRARY AND MADE THAT PERSON A SPECIALIST IN HEALTH & HUMAN SERVICES, REALLY TO BE A **REFERENCE AND RESOURCE TO EITHER** INDIVIDUALS WHO ARE SUFFERING FROM A VARIETY OF CHALLENGES, SUCH AS YOU HAVE MENTIONED THEMSELVES, OR MAYBE HAVE A FAMILY MEMBER AND WANT TO KNOW HOW TO SUPPORT THEM BETTER.

ADDITIONALLY, THROUGH THE PARTNERSHIP WITH PINE STREET INN WE ADDED A FULL-TIME SOCIAL WORKER TO OUR STAFF. THAT PERSON IS FUNDED JOINTLY BY THE DEPARTMENT OF NEIGHBORHOOD DEVELOPMENT AND THE BOSTON PUBLIC LIBRARY OUT OF NONCITY FUNDS.

THAT PERSON IS A PINE STREET INN EMPLOYEE BUT DEDICATED TO THE CENTRAL LIBRARY AND SPENDS A LOT OF TIME BOTH INSIDE AND OUTSIDE OF THE LIBRARY JUST CONNECTING WITH INDIVIDUALS WHO WANT TO ENGAGE AND ARE READY FOR THAT CONVERSATION ABOUT WHAT IS THE SUPPORT THEY NEED OR WHAT ARE THE RESOURCES THEY NEED TO DEAL WITH THE ISSUES THEY ARE HAVING IN THEIR OWN LIVES. THAT IS A PROGRAM THAT WE BELIEVE HAS BEEN SUCCESSFUL AND YOU SEE FUNDING IN THE CITY BUDGET FOR FY-20 TO EXPAND THAT. WE WANT TO EXPAND THAT IN TWO

WAYS, NOT JUST SIMPLY ADD A SECOND PERSON TO THAT TEAM, WHICH WOULD THEN GIVE US CAPACITY TO OKAY AT THE BRANCHES THAT SEE A SLIGHTLY LARGER NUMBER OF INDIVIDUALS WITH THOSE KIND OF CHALLENGES IN THEIR LIVES.

BUT ADDITIONALLY, WE ARE HAPPY TO SHARE THAT WE WILL BE PARTNERING WITH THE SIMMONS --SCHOOL OF SOCIAL WORK AND SO WE WILL BENEFIT NOT ONLY FROM ADDITIONAL PERSON BUT HAVE THAT INDIVIDUAL SUPERVISE AND MENTOR SOME INTERNS FROM THE SOCIAL WORK PROGRAM AT SIMMONS COLLEGE. AND SO WE THINK THE COMBINATION TOGETHER AS WELL AS WITH TRAINING FOR EXISTING STAFF AND OUR SECURITY OFFICERS ON HOW TO DEAL WITH PATRONS WHO ARE EXPERIENCING DIFFICULTY WILL CONTINUE TO ALLOW US TO BE A STRONG RESOURCE FOR PEOPLE IN NEED. >> I APPRECIATE THAT AND, YOU

KNOW, IT IS FINDING THE RIGHT

BALANCE BETWEEN THE LIBRARY SERVICES THAT OUR RESIDENTS AND OUR VISITORS DESERVE BUT THEN ALSO MAKING SURE THAT OUR RESIDENTS WHO ARE DEALING WITH A CRISIS AT THE MOMENT ARE ALSO GETTING THE RESOURCES THAT THEY NEED. YOU HAD MENTIONED SOME INCREASES IN SECURITY. CAN YOU JUST TALK A LITTLE BIT ABOUT THAT, THE ADDITIONAL MEASURES THAT ARE IN PLACE AND THE INVESTMENT? >> DAMON CAN GIVE YOU DETAILS ON THAT BUT THIS IS SYSTEMWIDE. >> YES. SO IN TERMS OF THE INCREASING IN SECURITY COVERAGE, WE EXPECT TO **INCREASE AT THE FOLLOWING** LOCATIONS. AND THIS IS INCREASED HOURS OF OUR SECURITY GUARD. SO IT IS ECHOLS SON, HYDE PARK -- CORNER AND THEN FINALLY AT THE CENTRAL LIBRARY WE WANT TO **INCREASE SPECIFICALLY AT TECH** CENTRAL WHICH IS THE PUBLIC COMPUTER AREA, AND THEN ALSO THROUGHOUT THE CENTRAL LIBRARY. WHAT IS THAT DOLLAR AMOUNT? >> 250?>> 250,000. >> >> GREAT. THANK YOU. I WILL END THERE ON THAT NOTE. THANK YOU. >> THANK YOU. >> COUNCILOR ZAKIM. >> THAT IS UNPRECEDENTED. >> MY MIKE IS ALREADY ON. >> NEVER MIND. >> MY MIKE IS ALREADY ON. THANK YOU, COUNCILOR, THANK YOU, MR. CHAIRMAN, DAVID, YOUR TEAM, GOOD TO SEE YOU. I WILL BE FAIRLY BRIEF. I JUST WANT TO FIRST START OFF BY JUST APPLAUDING THE WORK BOTH FROM A STAFF AND SERVICE PERSPECTIVE AS WELL AS THE CAPITAL IMPROVEMENTS OF THE CENTRAL BRANCH WHICH IS

OBVIOUSLY SERVES EVERYONE IN THE CITY BUT AS MY NEIGHBORHOOD BRANCH, AS A PLACE I WAS TALKING EARLIER. BY SON LIKES TO GO AND HOW MUCH HE IS UNDERSTANDING IT AT FIVE MONTH BUT REALLY ENJOYS STORY AND GOING OVER THERE. SO THANK YOU FOR THAT. IT IS A REALLY A GEM FOR THE CITY, AND EVERYONE, PARTICULARLY IN LIGHT OF WHERE THE BACK BAY ASSOCIATION ANNUAL MEETING EARLIER THIS MORNING AND THEY ARE RECOGNIZING MANY CITY THE FROM PINE STREET. THE POLICE DEPARTMENT, YOU WERE PRESENTING THE AWARDS FOR THE OUTREACH WREFORTS THE HOMELESS POPULATION OF FOLKS WHO ARE EXPERIENCING HARDSHIP, WHETHER MENTAL HEALTH, ADDICTION, WHATEVER ISSUES CONGREGATE AROUND THE LIBRARY BECAUSE IT IS A SAFE SPACE. CENTRALLY LOCATED AND THE SERVICES -- OBVIOUSLY THERE IS MORE WE CAN BE DOING BUT I WANT TO THANK YOU AND YOUR TEAM FOR 0 THAT WORK. ONE QUESTION I HAVE ABOUT TWO OTHER BRANCHES THAT ARE IN MY DISTRICT, YOU KNOW, MISSION HILL, OBVIOUSLY WE WENT THROUGH, THE REROOFING; IS THAT RIGHT, AMON. >> THAT WAS RIGHT TERM, ENVELOPE. >> AND PEOPLE ARE JUST THRILLED, YOU KNOW, TO HAVE THAT BACK UP AND RUNNING. I THINK THAT PROJECT WORKED VERY WELL WITH TEMPORARY SERVICES IN THE NEIGHBORHOOD SO THANK YOU FOR THAT. AND I SEE ON THE CAPITAL -- CAN YOU SPEAK TO THAT. WHERE YOUR THINKING IS ON WHAT WORK IS BEING DONE. IF SOME OF THOSE BART SHIPS PROGRAMS, YOU KNOW, PUBLIC PRIVATE PARTNERSHIPS, USING THAT LAND, SO WE HAVE A BRANCH LIBRARY BUT PROGRAMS EXPANDING. PARTNERING WITH SOME SORT OF OTHER

DEVELOPMENT THERE, IF YOU SPEAK TO THAT. >> YES. AND WE ARE STILL AT THE VERY

EARLY STAGES FROM A PLANNING POINT OF VIEW ON THE LIBRARY AGENDA WITH RESPECT TO THE WEST END, BUT THE CITY'S HOUSING AND INNOVATION LAB DID A PROJECT OVER THE COURSE OF THE LAST YEAR AND THIS WAS ONE OF THE LOCATIONS WHERE THERE WAS BOTH DEVELOPER INTEREST AND STRONG COMMUNITY INTEREST IN TAKING THIS A STEP FURTHER TO SEE WHAT COULD HAPPEN ON THAT SITE WITH **RESPECT TO HAVING A RENOVATED** LIBRARY BUT BENEFITING FROM A DEVELOPMENT ON THAT SITE AS WELL, SO THE NEXT LOGICAL STEP GIVEN THAT LEVEL OF INTEREST IS FOR US TO ARTICULATE THROUGH THE PROGRAMMING COMMUNITY, WHAT WE SEE THE PERFORM BEING ON THAT LOCATION FOR THE NEXT FIVE, 10, 20 YEARS, AND THAT PROCESS AS IT DOES OUR OTHER LOCATIONS CAN THEN SEE WHAT THE OPPORTUNITY -->> WHAT IS THE FOOTPRINT OF THAT PARCEL?

I MEAN, I DON'T HAVE THAT. MY RECOLLECTION IS, IT IS LARGER THAN THE ACTUAL STRUCTURE. >> THERE IS PARKING BEHIND IT SO THE SITE IS MUCH LARGER THAN THE BRANCH ITSELF.

>> SO I WOULD JUST PUT THE HERE, CONTINUE TO TALK ABOUT THE DEVELOP IN OTHER WORDS THE AREA THAT AS FAR AS CAPITAL COSTS GO, I THINK WE WOULD SEE A LOT OF ABILITY FOR SOME OF THE COMMUNITY BENEFITS FOR SOME OF THE LARGE DEVELOPMENTS THERE, MASS GENERAL IS EMBARKING IN A **\$1 BILLION EXPANSION, ADJACENT** TO THIS SITE, AND, YOU KNOW, DOING THAT, OBVIOUSLY, A THOUGHTFUL PLANNING PROCESS, I KNOW HOW IMPORTANT IT IS TO A NEIGHBORHOOD AND WE WANT TO ENHANCE THE LIBRARY THERE, BUT IF WE HAD A LIBRARY ON THE FIRST COUPLE OF FLOORS OF, YOU KNOW, A

NEW APARTMENT BUILDING OR LAB SPACE OR OFFICE SPACE THAT WOULD **OBVIOUS INCREASE TAX BASE FOR** THE CITY. PROVIDE SIGNIFICANT CAPITAL AND EVEN ON GOING OPERATING SUPPORT FORTH FOR THAT LIBRARY I WANT TO MAKE SURE WE TAKE ADVANTAGE OF THAT **OPPORTUNITY AND CERTAINLY IT IS** AN AREA THAT EVEN IN OUR INFREQUENT AND HOPEFULLY FAR OFF ECONOMIC DOWNTURNS IT WILL STILL BE BUSTLING GIVEN MASS GENERAL. SOME OF THE OTHER COLLEGES, SOME OF THE OTHER HOSPITAL THERE IS. SO I THINK THAT IS REAL OPPORTUNITY, AND SO I HEAR FROM NEIGHBORS QUITE A BIT THAT TO MAKE SURE THE LIBRARY STAYS THERE BUT WE CAN LOOK AT SOME DEVELOPMENT AND LOOK AT PARTNERSHIPS THERE. THANK YOU. >> THANK YOU. COUNCILOR MCCARTHY. >> THANK YOU VERY MUCH. MR. CHAIR AND WELCOME TO THE BPL STAFF. AS COUNCILOR O'MALLEY STATED THIS IS USUALLY ONE OF THE EASIEST HEARINGS WE HAVE. I REALLY HAVE VERY LITTLE -->> AT LEAST IN RECENT YEARS. >> AT LEAST IN RECENT YEARS, YES. IT IS ALL GOOD. IN DISTRICT 5 WE HAVE MATTAPAN, A BRAND-NEW LIBRARY, FIRST I WANT TO ASK YOU FOR THE STAFF YOU HAVE THAT GUILE ON A DAILY BASIS, WHETHER COMMUNITY MEETINGS THERE OR 00 WITH GOING TO THE HYDE PARK, YOU KNOW, FOR BOOKS AND I AM AN AUDIO BOOK GUY MYSELF. I WISH IT WAS A IT WAS A BIGGER SELECTION BUT THAT IS A WHOLE OTHER ISSUE. BUT MATTAPAN WE GO TO MEETINGS THERE AS WELL AS THE HYDE PARK AND MATTAPAN IS A BRAND-NEW LIBRARY, THE STATE OF THE ART, AND IT IS BEAUTIFUL. **0 ROSLINDALE, WE WILL BE LOOKING**

FORWARD TO CONTINUE -- WELL, THAT WAS QUICK FOR ME. YES. THAT WAS AN EASY -- I AM LOOKING FORWARD TO CONTINUING THE PROCESS OF THE ROSLINDALE LIBRARY. I MEAN IT IS REALLY EXCITING AND HAVE SO MANY GREAT PEOPLE WORK TONG PROJECT. I PROBABLY WON'T BE ELECTED BY THE TIME WE PUT A SHOVEL IN THE GROUND OR DEFINITELY BEFORE A **RIBBON IS CUT BUT I AM GOING TO** SHOW UP ANYWAY FOR THE FREE COFFEE. THE HYDE PARK LIBRARY, JUST A COUPLE OF ISSUES I HAVE. I KNOW WE ARE DOING THE WATERPROOFING AND TO THE ANTI-MOLD STUFF DOWN IN THE BASEMENT WHICH IS ABSOLUTELY NEEDED. MY ONE CONCERN IS LAST YEAR I REQUESTED SOMEONE TAKE A LOOK AT THE FLOORS. WHEN YOU ENTER, YOU HAVE THE FRONT FOYER AND YOU COME THROUGH AND WHERE YOU CHECK YOUR BOOKS IN AND OUT YOU HAVE THE FIREPLACE IN THE OLD LIBRARY AND THEN THE NEW COMPUTER, LITTLE LAB THERE, THOSE FLOORS ARE THE ORIGINAL FLOORS, AND IT IS STARTING TO GET IN TOUGH SHAPE AND I ASK THIS -- I REQUESTED THIS LAST YEAR TO HAVE SOMEBODY LOOK AT IT AND NOW IT HAS GOTTEN ONE MORE YEAR AND I THINK IF YOU LET GO IT GO A COUPLE MORE YEARS YOU ULTIMATELY GOING TO NEED TO REPLACE THOSE FLOORS WHICH WOULD BE A SHAME. I HAVE A 140-YEAR-OLD HOUSE MYSELF WE HAD SPOTS WHEN WE FIRST BOUGHT THE HOUSE NEEDED TO REPAIR. WE TOOK THE WOOD OUT OF THE CLOSET SO WE COULD MAINTAIN THE OLD WOOD BUT IF YOU PULL UP SOME OF THE CARPETS WHICH WE DID LAST WEEK IN PREPARATION OF THIS MEETING YOU LITERALLY HAVE SOME ROTTED PLANKS AND YOU FEEL IT UNDER YOUR FEET.

IT REALLY NEEDS TO BE ADDRESSED. >> WE WILL CERTAIN I ARE TAKE A MORE CONSIDERED LOOK AT THAT. I RECENTLY WAS AT THE FRIENDS MEETING THERE, THEIR ANNUAL MEETING AND THAT IS ONE OF THE TOPIC THAT CAME UP DIRECTLY. >> YES. >> IT WAS AN ISSUE. >> IF SOMEONE WANTS TO MEET ME OUT THERE I WILL BRING THE COFFEE JUST TO GO OVER IT, BECAUSE I THINK IT COULD GO UNDER AN EMERGENCY REPAIR CATEGORY AND 0 NOT GO THROUGH THE WHOLE GAL THING AND I THINK IT IS TO THAT POINT YOU ARE EITHER GOING TO BE RIPPING UP THAT 34 AND PUTTING IN BRAND-NEW FLOORING WHICH WOULD BE PA SHAME, I THINK SO -->> THANK YOU. COUNCILOR BAKER. >> THANK YOU, MR. CHAIR, GOOD MORNING, TO YOU, DAVID, AND TO YOUR TEAM. 0 SO I HAVE A LOT GOING ON IN MY DISTRICT, ADAM CORNER, GETTING READY TO START CONSTRUCTION IN THE FALL OR -->> SUMMER. >> SUMMER? >> EVERYBODY IS EXCITED ABOUT THAT. >> FIELDS CORNER, CAN WE TALK A LITTLE BIT, JUST TOUCH ON FIELDS CORNER, IS IT A CAC THAT WE HAVE FORMED FOR JUST -- JUST SO I CAN EXPLAIN AND IT IS ACTUALLY IN COUNSELOR CAMPBELL'S DISTRICT BUT WE SHARE IT AND WE HAVE HAD A LOT OF PEOPLE CALLING, JUST TO RUN UP TO IT, WE DO A PROGRAMMING STUDY FIRST AND THEN CAN YOU LAY THAT OUT FOR ME, PLEASE? >> SURE. WITH ANY RENOVATION, THERE ARE THREE PHASES. THERE IS PROGRAMMING STUDIES, THERE IS DINE. AND THEN THERE IS CONSTRUCTION. OFTEN THERE IS A GAP BETWEEN THE PROGRAMMING STUDY AND DESIGN,

BUT WE GENERALLY REALLY LIKE TO GO STRAIGHT FROM DESIGN INTO CONSTRUCTION. THAT SEEMS TO BE OPTIMUM CONFIGURATION. >> DURING BOTH PROGRAMMING STUDY AND DURING DESIGN, WE HAVE A FORMALIZED COMMUNITY ENGAGE. PROCESS. THESE ARE TWO SEPARATE PROCESSES, ONE DURING THE --STUDY AND ONE DURING DESIGN. THEY AVERAGE THREE TO FIVE FULL ON COMMUNITY MEETINGS. WHILE WE DO DESIGNATE A COMMUNITY ADVISOR -- ADVISORY COMMITTEE. ALL OF THE MEETINGS -- THAT COMMITTEE DOES NOT MEET SEPARATELY THAN THE PUBLIC MEETINGS. THE PUBLIC MEETINGS ARE THE COMMUNITY ADVISORY COMMITTEE PROCESS. AND I THINK THERE WAS SOME CONFUSION WITH RESPECT TO THE FIELDS CORNER COMMUNITY EXPECTATIONS. I THINK AS YOU NOTED THIS IS A RATHER BUSY COMMUNITY FROM A NUMBER OF PROJECTS GOING ON AND I KNOW THE BPDA HAS A SLIGHTLY DIFFERENT APPROACH WHEN THEY RUN COMMUNITY PROCESS WHERE THERE ARE MORE DEDICATED COMMITTEES THAT HAVE SEPARATE MEETINGS FROM THE FORMAL COMMUNITY MEETINGS AND SO I THINK THAT IS REALLY THE SOURCE OF THE CONFUSION. THERE I THINK OVER THE LAST FEW WEEKS WE HAVE GONE AN EXTRA MILE TO CLARIFY HOW THAT WORKS AND ENSURE THAT ANYONE WHO WANTS TO BE A PART OF A PROCESS CAN KNOW WHEN THE MEETINGS ARE AND IS WELCOMED TO COME TO THE MEETINGS. WE HAVE HAD TWO AT FIELDS CORNER SO FAR AND THEY HAVE BEEN WELL ATTENDED. AND I THINK PEOPLE HAVE A LOT OF GREAT IDEAS AND, YOU KNOW, PROBABLY AS USUAL, WANT US TO MOVE FASTER BUT NONETHELESS THE COMMUNITY THERE IS VERY ENGAGED

AND VERY INTERESTED IN SEEING WHAT THE MIXED USE OPPORTUNITIES COULD TRULY BE. >> YES. SO JUST BRIEFLY EXPLAIN TO ME HOW THAT MAY WORK OUT SO THAT WOULD BE A PRIVATE DEVELOPER WILL COME IN, AND THIS IS -- MAY NOT EVEN HAPPEN, BUT HOW DO YOU -- IF WE ARE ABLE TO SPEAK ABOUT IT, HOW WOULD THAT SORT OF DEAL COME TOGETHER, PRIVATE DEVELOPER, BUILD THE --**EVERYTHING ABOUT THE PLATFORM --**>> THERE ARE A COUPLE OF DIFFERENT MODELS WE CAN USE BOTH DURING PROCUREMENT AND CONSTRUCTION AND THEN -- PARDON ME -- THE MODEL FOR WHAT THE END USE -- WHO OWNS THE PROPERTY, WHO LEASE IT IS PROPERTY, IS IT CONDO-IZED, A LOT OF DIFFERENT MODELS THAT CAN BE USED. THIS IS NEW AREA FOR US IN BOSTON, ESPECIALLY WITH RESPECT TO LIBRARIES. >> AND I APPRECIATE THE FACT YOU ARE TRYING TO RUN ON THE BALL HERE, THANK YOU. >> AND SO WITH RESPECT TO FIELDS CORNER, HOW I THINK THIS COULD UNFOLD IS AS WE GET FARTHER ALONG IN THE PROGRAMMING STUDY. WE, TOGETHER WITH THE COMMUNITY WILL BE DETERMINING WHAT IS THEIR OPENNESS TO ON THAT SITE. I THINK THE ARCHITECTS AT THE LAST MEETING SHOWED WHAT A THREE, FOUR, FIVE STORY MASSING BUILDING COULD LOOK LIKE, MASSING BUILDING COULD LOOK LIKE, THE IDEAL BEING, WHAT WE **REALLY WANT TO STICK TO IN** BOSTON FOR LIBRARIES IS, WHERE POSSIBLE, A SINGLE STORY LIBRARY THAT HAS A CLEAR PRESENCE ON THE STREET. THOSE ARE KIND OF OUR STARTING POINTS. NOW, YOU DON'T ALWAYS HAVE THE **OPPORTUNITY TO BUILD SAY IN EAST** BOSTON WHICH IS A BEAUTIFUL SITE AND SO THE MODELS OF JP OR DUDLEY WHERE THE MAJORITY OF

LIBRARIES ARE ON A SINGLE STORY BUT THERE IS A MEZZANINE OR THERE IS A SMALL BASEMENT FOR ANCILLARY SERVICE THOSE ARE MODELS WE CAN USE. SO ONE COULD ENVISION, EITHER SIMPLY RENOVATE, SIMPLE RENOVATION ON THE FIELDS CORNER SITE TO JUST BUILD A BETTER LIBRARY OR A MODEL THAT HAS SOMETHING ABOUT IT, AND THEN, YOU KNOW, ONCE WE COMPLETE THE PROGRAMMING STUDY WE DECIDE WHAT WHAT IS THE RIGHT GUY DO THIS NEXT. IS IT WHERE A DEVELOPER COMES TO THE TABLE AND OWNS THE WHOLE PROCESS OR WE DO IT JOINTLY OR -- SO THERE ARE DIFFERENT WAYS WE CAN DO THAT. SO 17 AT A TIME. WE WILL SEE WHAT THE APPETITE IS, WHAT THE PLAN LOOKS LIKE AND THEN FIGURE OUT HOW TO BRING IT ALTOGETHER. >> AND WE CLEARLY ARE RELYING ON EXPERTISE BOTH FROM THE BPDA AND FROM THE DEPARTMENT OF NEIGHBORHOOD DEVELOPMENT, FROM A HOUSING POINT OF VIEW. ECONOMIC DEVELOPMENT, FROM WHAT IS THE **BUSINESS APPETITE IN THE AREA,** AND SO IN CONJUNCTION WITH, OF COURSE, PROPERTY AND CONSTRUCTION MANAGEMENT, SO THIS REALLY A TEAM EFFORT WITH THE COMMUNITY. BUT RIGHT NOW, FOR FIELDS CORNER IT IS PROGRAMMING STUDY, WHAT ARE THE LIBRARY REQUIREMENTS AND WHAT ARE THE -->> AND WHAT IS THE OPENNESS TO WHAT TYPE OF MIXED USE FACILITY. >> THANK YOU. THANK YOU, MR. CHAIRMAN. >> COUNCILOR CAMPBELL BELL. >> THANK YOU, COUNCILOR CIOMMO AND THANK YOU. ALL FOR THE WORK YOU ARE DOING, DAVID, YOUR TEAM AS WELL, AND OF COURSE BEHIND ME AND THOSE ACTUALLY AT THE LIBRARIES DOING INCREDIBLE WORK. I DO HAVE MATTAPAN LIBRARY, FIELDS CORNER, COPLEY SQUARE, WE

DO A LOT OF COMMUNITY EVENTS AND PERHAPSING IN THESE SPACES AND THE STAFF ALWAYS MAKE IT EASY. JUST THE INSTITUTIONS THEMSELVES, I MEAN WHAT THEY ARE DOING ON THE GROUND IS WHAT THESE LIBRARIES ARE MEANT TO DO FOR COMMUNITY AND THEIR STAFF., YOU KNOW,, THIS CAN'T HAPPEN WITHOUT INCREDIBLE STAFF SO KNOW THE FOLKS ON THE GROUND ARE **REMARKABLE SO I JUST WANTED TO** THANK THEM AS WELL. I -- THANK YOU FOR THE QUESTIONS OF COUNCILOR BAKER AND YOUR SONSES WITH RESPECT TO FIELDS CORNER. WE ARE TAG TEAMING THAT, SO IT IS VERY HELPFUL. REALLY EXCITED TO SEE THE INVESTMENT IN A MILLS LIBRARY AS WELL. I DIDN'T MENTION THAT IS ALSO ONE IN MY DISTRICT THAT FOLKS USE FREQUENTLY, SO THAT IS FANTASTIC. I HAVE MORE QUESTIONS WITH RESPECT TO COG MAN SQUARE, EXCITED TO SEE INVESTMENT .. CURIOUS TO SEE WHAT THAT WILL COVER, AND WHAT THE VISION IS FOR COG MAN SQUARE, OBVIOUSLY A LOT MORE TO DO THERE AND THEN I HAVE SOME FOLLOW-UP SQUARES ON COG MAN. >> I AGREE WE ARE HAPPY TO SEE ACTUALLY AN INCREASE IN THE BUDGET FOR -- MILLS, SO EVEN THOUGH IT IS A MORE MODERN INTERIOR SET OF REFRESH WE ARE ABLE TO DO A LITTLE MORE THAN WHAT WE INITIALLY THOUGHT WE WOULD BE CONSTRAINED BY. SO WE AGREE THAT'S A LOCATION WE ARE ABLE TO DELIVER ON EXPECTATION THERE IS. COG MAN SQUARE IS NOW IN THE PROPOSED BUDGET FOR THE PROGRAMMING STUDY AND WE CERTAINLY HAVE BEEN TALKING ABOUT PROGRAMMING STUDIES THIS MORNING IN TERMS OF WHAT IT CAN COVER. YOU KNOW, AMON ALSO SUGGESTED THAT BECAUSE THERE ARE A NUMBER OF PROGRAMMING STUDIES ON DECK FOR FY-20, WE WANT TO SEE ARE THERE ECONOMIES OF SCALE WHERE WE CAN DO MULTIPLE AT ONCE. AGAIN. WITHOUT SHORTCHANGING THE INDIVIDUAL NEEDS OF A NEIGHBORHOOD OR THE COMMUNITY PROCESS, THAT WOULD BE A NONSTARTER. AND SO WE HAVE, I THINK, FELT THAT, YOU KNOW, OF THE BRANCHES THAT WERE IN THE CAPITAL PLAN BUT SHOULD BE UP NEXT, COG MAN SQUARE WAS OBVIOUSLY IN GREATER NEED THAN WAS ORIGINALLY **IDENTIFIED IN I THINK 2000.** 2012, COUNCILOR MCCARTHY'S FLOORING ISSUE AT HYDE PARK NOTWITHSTANDING. MEXICO F AGAIN, WITH COG MAN SQUARE WE WILL START WITH, WELL, WHAT IS THE CHANGING NEIGHBORHOOD LIKE IN COG MAN SQUARE, WHAT THE UNIQUE NEEDS OF THAT ENVIRONMENT. IN THE THAT IS QUITE A SUBSTANTIAL SITE ALSO. AND SO I THINK WE CAN GO THROUGH ALL OF THE USUAL ASSESSMENTS ABOUT WHAT WOULD BE THE RIGHT VISION TO HAVE FOR CODMAN SQUARE LIBRARY. >> AND JUST HOW .. ON AVERAGE, HOW LONG WOULD A PROGRAMMING STUDY GO? >> PROGRAMMING STUDIES USUALLY TAKE A FULL YEAR BY THE TIME ---BECAUSE WE DO BRING ON AN ARCHITECT TO LEAD THAT PROCESS WITH OUR COLLEAGUES AT PUBLIC FACILITIES DEPARTMENT. AND THEN, YOU KNOW, DESIGN IS USUALLY A YEAR TO 18 MONTHS AND CONSTRUCTION CAN BE AROUND THE 18 MONTH AS WELL. AND THERE IS OFTEN A GAP AS WE HAVE NOTED EARLIER, PARTICULARLY WITH RESPECT TO -- THERE IS INDEED OFTEN A GAP BETWEEN PROGRAMMING STUDY AND GOING TO DESIGN. >> AND THEN IF THIS WERE TO GO THROUGH THE BUDGET, WHEN MIGHT THIS PROGRAMMING STUDY ACTUALLY

START?

>> SO WE WOULD BE AUTHORIZED TO START NO EARLIER THAN JULY 1, AND ONCE THE BUDGET IS APPROVED. WE SIT TOWN WITH PROPERTY AND CONSTRUCTION MANAGEMENT, PLAN OUT ALL OF THE PROJECTS THAT HAVE ACTIVITY PLANNED FOR FY-20. WE OBVIOUSLY HAVE TO START WITH THE ONES THAT ARE IN FLIGHT AS IN THOSE SUCH AS DUDLEY, ADAMS, ROSLINDALE THAT ARE EITHER GOING IN CONSTRUCTION OR INTO CONSTRUCTION, AND THEN SCHEDULE -- SCHEDULE THE PROGRAMMING STUDIES BASED UPON ALL OF OUR CAPACITY.

JUST QUICKLY I AM LOOKING AT, THERE IS A RESIDENT, I AM GOING BLANK IN HER NAME THAT E-MAILED THIS MORNING ABOUT CODMAN AND I TOLD HER THERE IS SOME STUFF IN THE PIPELINE.

APPRECIATE IT. VERY HELPFUL. I KNOW YOU HAVE VERY COMMITTED **RESIDENTS AND NEIGHBORS THAT** LIVE -- THAT DO INCREDIBLE WORK IN TERMS OF MAINTENANCE AND CLEANLINESS. >> THERE ARE SOME OF THE FRIENDS GROUPS THAT HAVE CHOSEN TO PLAY A ROLE IN HELPING BEAUTIFY SEVERAL OF THE LOCATIONS. >> WE'RE TRYING TO THINK HOW WE CAN COORDINATE BETTER. THANK YOU. GUYS. THANKS VERY MUCH. >> BEFORE I GO FOR A SECOND ROUND, MARLENE, YOU WANT TO **TESTIFY**? I DON'T KNOW IF DAVID, YOU SIGNED UP. [INAUDIBLE] >> OKAY.I JUST WANT TO POINT OUT THAT IN THE LAST 12 YEARS I'VE BEEN COMING HERE, THERE'S BEEN SOME CONTENTIOUS MEETINGS WITH ME AT

THE CENTER. I'M HAPPY TO REPORT THIS LAST YEAR HAS BEEN POSITIVE IN TERMS OF HOW WE WORK WITH BPL AND DAVID LEONARD AND HIS PROJECT TEAM. WE'RE VERY EXCITED ABOUT THE UPCOMING REFRESH IN THE LIBRARY. AS DAVID POINTED OUT. THERE WAS AN ALLOCATION BY THE CITY AND THE FRIENDS RAISED ALMOST \$100,000 IN PRIVATE FUNDS TO ADD TO THIS CAPITAL IMPROVEMENT, WHICH I THINK IS THE FIRST TIME THE BRANCH EVER RAISED MONEY FOR CAPITAL IMPROVEMENTS. I ALSO WANT TO SAY THAT PART **OF -- PART OF THE IMPROVEMENTS** ALSO INCLUDE PARK. THIS LIBRARY HAS A PARK THAT IS OWNED BY THE BPL. AND BECAUSE IT'S A PARK, IT'S MANAGED BY THE PARKS DEPARTMENT. WHILE IT CAN BE GREAT TO HAVE TWO AGENCIES MANAGE THE SAME PROPERTY. IT FELL BETWEEN THE CRACKS. WHEN I CAME IN, IT WAS A NEEDLE PARK. AS A RESULT, FUND-RAISING AND ACTIVE BOARD INVOLVEMENT OF THE FRIENDS HAS CHANGED OVER THE YEARS. LAST YEAR THE PARK WAS ACTUALLY **REBUILT AND REDESIGNED AND** REBUILT. SO IT IS NOW A PLACE THAT IS OPEN AND TRANSPARENT. IT HAS A WONDERFUL PATIO PAVEMENT AREA WHERE WE CAN HAVE CONCERTS AND EVENTS. IRRIGATION FOR LIBRARY PARK. HE TELLS ME THAT AS OF THIS MOMENT, IT ALL LOOKS VERY GOOD. SO IT'S A GOOD TESTIMONY. I WANT TO THANK YOU VERY MUCH. I WANT TO BPL TEAM FOR HAVING WORKED WITH US. SO ENTHUSIASTICALLY. THANK YOU. >> THAN YOU. >> WE'RE JUST LOOKING AT LINE ITEM -- THE 440,000 INCREASE, 444 IN LINE 52900. IT'S UNDER MISCELLANEOUS AND MATERIALS. JUST WANT TO -- CONTRACTED SERVICES. >> THAT IS PRIMARILY THE MONEY FOR THE NEW -- THE INCREASE IN THE SECURITY CONTRACT. AND THEN SOME OTHER SMALLER CONTRACTS THAT CAME UP THIS YEAR. >> GREAT. AND YOU MENTIONED SEVERAL OF THE LIBRARIES THAT YOU'RE INCREASING THE HOURS. THAT'S DUE TO THAT. OKAY. COUNCILLOR FLYNN. >> THANK YOU, COUNCILLOR CIOMMO. THANKS TO THE STAFF. I KNOW COUNCILLOR ZAKIM ALREADY MENTIONED THE WEST END LIBRARY, ALTHOUGH THAT SO NOT IN MY DISTRICT, IT'S A SHORT WALK AWAY. SO I WOULD SUPPORT COUNCILLOR ZAKIM AND WORKING CLOSELY WITH YOU ON THE FUTURE OF THE WEST END LIBRARY. I KNOW IT SERVES A LOT OF PEOPLE IN MY DISTRICT. DAVID, CAN YOU GIVE A BRIEF UPDATE ON THE LIBRARY ON THE NORTH END? ITS NOT IN MY DISTRICT BUT A SHORT WALK AWAY. A LOT OF MY CONSTITUENTS FROM THE DOWNTOWN AREA DO USE THE NORTH END LIBRARY. >> I'LL DEFER TO AMEN ON THIS. >> SURE.

SO ALTHOUGH WE'VE DONE SOME MINOR OPERATIONS AND MAINTENANCE-TYPE ENHANCEMENTS, THE NORTH END PROJECT HAS BEEN IN THE CAPITAL PLAN AS LONG AS I'VE BEEN HERE. THAT'S SIX YEARS. THIS IS THE FIRST YEAR THAT I'VE ALSO INCLUDED AS CASH FLOW FOR PROGRAMMING STUDY. WE EXPECT TO KICKOFF PROGRAMMING IN THIS UPCOMING FISCAL YEAR. AS WE DISCUSSED EARLIER, WE ARE LOOKING TO POTENTIALLY INCLUDE THIS ALONG WITH SOME OF THE OTHER PROGRAMMING STUDIES TO SEE IF WE CAN BUNDLE THAT EFFORT. THANK YOU. I KNOW YOU'RE WORKING CLOSELY WITH COUNCILLOR EDWARDS AS WELL. SO WE APPRECIATE YOUR HARD WORK. THEN MY FINAL QUESTION, CAN YOU GIVE SOME INFORMATION, DAVID, ON THE OUTREACH WE'RE DOING ON ELL **ISSUES TO REACH COMMUNITIES THAT** MAY NOT SPEAK ENGLISH, WHAT TYPE OF SERVICES YOU'RE PROVIDING AND VARIOUS LIBRARIES? >> I'LL ASK BOTH MICHAEL FROM A SERVICES POINT OF VIEW AND LAURA FROM A COLLECTIONS POINT OF VIEW TO TALK ABOUT THAT. >> WE DO HAVE A LITERACY SERVICES DEPARTMENT FOR ADULT ENGLISH LANGUAGE LEARNING. WE WERE FORTUNATE ENOUGH THIS LAST YEAR TO REPURPOSE VACANT POSITIONS TO HIGHER ESL TRAINER. SO WE'VE BEEN ABLE TO INCREASE WHAT WE'VE PROVIDED ACROSS THE SYSTEM IN BASIC ENGLISH AND SOME EXPANSION OF CREATIVE WRITING CLASSES FOR NON-ENGLISH LANGUAGE SPEAKERS. WE'RE ALSO PART OF -- I'VE BEEN GOING TO THE MEETINGS WITH THE NEW LANGUAGE AND ACCESS ABILITY DEPARTMENT OF THE CITY. THERE'S BEEN FUNDING EARMARKED FOR VARIOUS USES. WE'RE USING THAT FOR A LOT OF TRANSLATION SERVICES TO TRANSLATION THE POLICIES AND OTHER DOCUMENTS.

WE HAVE SEVERAL DOCUMENTS ALREADY TRANSLATED LIKE THE LIBRARY CARD REGISTRATION. WE WANT TO EXPAND THAT TO HAVE MORE MATERIAL EXPANDED. AND WE'RE LOOKING TO PROVIDE **ON-THE-SPOT TRANSLATION OF** PEOPLE COMING IN. THERE'S A LANGUAGE LINE THAT WE'RE TALKING ADVANTAGE OF. IF SOMEONE COMES IN PEOPLING OF A LANGUAGE OTHER THAN ENGLISH, WE CAN HAVE THEM CALL ON A DESK PHONE AND HAVE A TRANSLATOR FOR US. >> FROM THE COLLECTION SIDE, WE'RE CONTINUALLY LOOKING AT VARIOUS LANGUAGE NEEDS IN THE COMMUNITY, WHETHER IT'S LEARNING A LANGUAGE OR HAVING MATERIALS IN DIFFERENT LANGUAGE OTHER THAN ENGLISH. WE CHECK IN WITH THE STAFF AT THE OTHER BRANCHES TO SEE WHAT DEMANDS THEY'RE SEEING FROM THE COMMUNITIES AND SET UP **RELATIONSHIPS WITH LOCAL BOOK** STORES AND VENDORS THAT ARE SPECIFIC TO COMMUNITIES TO ADD MATERIALS TO THE COLLECTION. IN THE LAST YEAR, WE ALSO ENHANCED OUR ONLINE CATALOG SO IT CAN BE TRANSLATED TO ENGLISH AND CHINESE SO THAT PATRONS CAN LOOK FOR MATERIALS IN DIFFERENT LANGUAGES. >> WE CURRENTLY COMMUNICATES ON SOCIAL MEDIA IN LANGUAGES OTHER THAN ENGLISH? >> WE CAN CHECK THAT AS GUIDANCE WHERE WE -- THAT'S AN AREA THAT WE CAN DO BETTER. >> OKAY.YEAH, THAT'S AN ISSUE THAT HAS BEEN IMPORTANT TO ME. THAT TELLS US SOMETHING THAT --DEMAND FOR INCREASE TO DIGITAL MATERIAL MAY BE INCREASING, I DON'T BELIEVE THAT THE USE OF THE PRINTED MATERIAL WILL EVER GO AWAY ENTIRELY. >> CERTAINLY NOT. WHAT WAS THE MOST REQUESTED BOOK THIS YEAR? >> WE'RE ON TRIVIA NOW AT THIS POINT. >> I THINK IT WAS "BECOMING". >> I LIKE IT. >> COUNCILLOR ESSAIBI-GEORGE? >> I PROMISE TO YOU THAT EVERY

MINUTE IS SAVED. AND WE TOUCHED ON IT IN THE FIRST ROUND. AS YOU KNOW, I DO A LOT OF WORK AROUND HOMELESS. LAST YEAR WE TALKED ABOUT KIOSKS **BEING ADDED INTO -- INSTALLED IN** SOME LIBRARIES IF NOT ALL OF THEM FOR PROPER NEEDLE DISPOSAL. HAVE WE DONE THAT? WHERE ARE WE THAT? >> I CAN TAKE THAT. >> THERE'S SHARPS LOCATIONS IN ALL OF THE REST ROOMS IN THE CENTRAL LIBRARIES. >> WHAT ABOUT BRANCHES? >> IN THE BRANCH LIBRARIES, WE HAVE THEM AT EVERY BRANCH LIBRARY. >> AND ARE THEY REGULAR KIOSKS OR JUST DISPOSAL BUDGETS? >> THEY'RE ATTACHED TO THE WALL. THEY'RE PROBABLY THE SIZE OF A LITTLE BIT SMALLER THAN A NOTEBOOK. >> ATTACHED TO THE WALL. WHEN YOU SAY CONTAINER, TRYING TO VISUALIZE. WHEN YOU SAY CONTAINER, ALL OF THE PUBLIC REST ROOMS IN ALL OF THE PUBLIC LIBRARIES? >> THAT'S CORRECT. >> WHAT IS THE UTILITY RATE. ARE WE EMPTYING THEM WEEKLY OR --->> VARIES BY LOCATION. SO BECAUSE THE PROGRAM WAS NEW LAST YEAR, WE'RE STILL WORKING ON SORT OF THE METRICS. THERE'S SOME LOCATIONS WE **INITIALIZED -- WE INITIATED THE** PROGRAM WHERE WE WOULD SIGN UP TO PICK THEM UP JUST ONCE A YEAR OR TWICE A YEAR DEPENDING ON THE LOCATION. SO THE CENTRAL LIBRARY HAS BEEN THE MOST FREQUENTLY EMPTIED. IT'S NOT WEEKLY. IT'S EVERY COUPLE MONTHS. THE OTHER PROBLEM DISTORTING OUR METRICS, WE'VE HAD PEOPLE TAMPER WITH THEM FROM TIME TO TIME. SO WE'VE BEEN GETTING FALSE POSITIVES.

>> I'M SORRY. FALSE POSITIVES? >> LIKE IT'S FULL WHEN IT'S NOT. >> ALL RIGHT. >> WE SEND SOMEONE OUT TO EMPTY IT BUT IT WOULDN'T BE EMPTY. SOMEBODY TAMPERED WITH IT. >> WHAT IS THE BUDGET FOR THE NEEDLE DISPOSAL FOR THAT WHOLE -- DO WE HAVE -->> SO WE ARE WORKING WITH A PRIVATE CONTRACTOR TO DO THAT. THEY SUPPLIED ALL OF THE BOXES AND THEY WOULD SUPPLY THE SERVICES FOR PICKING THEM UP. I DON'T KNOW IF WE HAVE THE FIGURE. IT'S LESS THAN 10,000. I CAN TELL YOU THAT. >> I WOULD BE CURIOUS OFF LINE TO RECEIVE THE INFORMATION ON HOW MANY REST ROOMS OR KIOSKS WE HAVE, THE DISPOSAL BUCKETS, THE FREQUENCY OF DISPOSAL AND THE COST OF THAT. I'M A BIG ADVOCATE OF PROVIDING NEEDLE DISPOSALS IN PUBLIC SPACES LIKE REST ROOMS. PRIVATE BUSINESSES ARE DOING IT. AIRPORTS ARE DOING IT. WE WANT PROPER DISPOSAL. WE DON'T WANT THEM IN THE WASTE. >> AND WE'RE LOOKING AT IMPROVEMENTS WITH THE RENOVATION PROJECTS TO HAVE MORE BUILT IN SO THEY LOOK BETTER AND IT'S NOT JUST A BOX ON THE WALL LIKE A TRASH RECEPTACLE. >> THANK YOU. LAST YEAR WE ALSO TALKED ABOUT VOLUNTARY NARCAN TRAINING. AGAIN, I REALIZE WE'RE IN A LIBRARY HEARING, BUT THIS IS OUR NEW REALITY. UNFORTUNATELY THE OVERDOSES ARE HIGH IN OUR CITY. CAN WE TALK ABOUT NARCAN TRAINING AND HOW THAT HAS DONE OVER THE LAST YEAR? >> SURE. WE'VE DONE SEVERAL ROUNDS OF NARCAN TRAINING FOR STAFF. WE DO THAT PERIODICALLY. I THINK WE'RE LOOKING AT DOING

THAT ABOUT ONCE A YEAR NOW. A SERIES OF TRAININGS THAT PEOPLE CAN ATTEND. SOME BRANCHES HAVE DONE SOME TRAININGS THAT THE PUBLIC --THAT ANYONE CAN ATTEND. OUR STAFF TRAINER IS LOOKING INTO HAVING NARCAN AVAILABLE AT EVERY LOCATION. JUST THEY CAN BE REPLENISHED WHEN WE RUN OUT. >> THANK YOU FOR THAT. AGAIN, BECAUSE THE WORK THAT IS **EXPECTED OF THE -- THE** CHALLENGES THAT WE'RE FACING IN **OUR LIBRARIES REQUIRES US, BUT** WE'VE ALSO IN THE PACKED TALKED -- THIS IS RELATED TO THE SOCIAL WORK EFFORTS IN OUR LIBRARIES. CAN YOU TALK ABOUT ANY TRAININGS AROUND DEESCALATION, MENTAL HEALTH, FIRST AID, YOU KNOW, ACTIVE --->> THAT'S THE MAIN FOCUS OF MOST OF OUR TRAININGS IN THE LAST YEAR. FOR THE GENERAL STAFF, WE'RE JUST DOING A SECOND ROUND OF DEESCALATION TRAINING. I WENT TO IT LAST WEEK. WE HAD GOOD ATTENDANCE FOR THOSE TRAININGS. WE ALSO DID THE CONFLICT ACTIVE BYSTANDER TRAININGS. >> FOR STAFF OR PUBLIC? >> STAFF. WE'VE WORKED WITH SIMMONS UNIVERSITY AS DAVID MENTIONED, THE COLLEGE OF INFORMATION AND SCIENCES AND SOCIAL WORK WHERE THEY CAME AND DID FOCUS GROUPS WITH STAFF TO SEE THE COMMON ISSUES THEY'RE FACING. THEY'RE NOW ROLLING OUT TRAININGS BASED ON WHAT THEY LEARNED FROM THE STAFF. THE ONE THING THAT I WANT TO MENTION, WE ALSO HAVE THE COACHES IN SEVERAL LOCATIONS. WE HAVE I BELIEVE FIVE LOCATIONS. IT JUST CAME BACK INTO MY MIND. I DON'T HAVE A LOT OF DETAILS

AROUND THAT. THAT WAS INITIATED AT THE BEGINNING OF THE YEAR. >> MY BELL RANG BUT I WANT TO GO OVER -- IF THE CHAIR WILL INDULGE ME. I KNOW YOU HAVE A WORKING GROUP OF LIBRARY EMPLOYEES THAT ARE FIGURING OUT THE BEST WAY TO **RESPOND TO INCIDENTS IN GENERAL** CHANGES IN WHAT SERVICES YOU NEED TO PROVIDE. >> YES. THE COMMUNITY -- THEY HAVEN'T MET FOR A WHEEL. THEY'VE BEEN FOCUSING ON EXTERNAL PARTNERS WE'VE BEEN WORKING WITH. THE WOMAN THAT -- SINCE THE CREATION OF THE HEALTH AND HUMAN SERVICES SPECIALIST, SHE'S BEEN TAKING CARE OF A LOT OF THESE ISSUES. THAT COMMITTEE DOES EXIST. I'LL RECOMMEND HAVING THEM COME BACK TOGETHER TO SEE HOW THINGS ARE GOING. >> THANK YOU. THANK YOU, CHAIR. >> THANK YOU. **COUNCILLOR BAKER?** >> THANK YOU, MR. CHAIR. CAN YOU MENTIONED THE PARODY SERVICES AGAIN? WHAT ARE THEY? >> SO IT'S CALLED POLICE ASSISTED ADDICTION AND RECOVERY INITIATIVE. THEY ARE -- CAME THROUGH THE POLICE DEPARTMENTS. I BELIEVE THERE'S FIVE BRANCHES WHERE THEY HAVE PUBLISHED APPOINTMENTS THROUGH THE WEEK WHERE THERE IS A PERRY COACH ASSIGNED TO THAT BRANCH. PEOPLE MAKE APPOINTMENTS THERE DEALING WITH RECOVERY AND ADDICTION ISSUES. THEY MADE AN APPOINTMENT. >> THAT'S THROUGH THE >> YES. >> THANKS. DAVID? >> THEY ARE PEOPLE THAT ARE IN

RECOVERY THEMSELVES AND HAVE REACHED TO POINT WHERE THEY'RE ABLE TO THEN GIVE BACK TO THE COMMUNITY. >> LIKE A RECOVERY COACH? WHO ARE THEY MEETING WITH? ARE THEY MEETING WITH PEOPLE THAT THEY KNOW AND ARE ALREADY **HELPING**? HOW DOES THAT -- HOW IS THAT **CONNECTION --**>> THAT IS THE PLAN CERTAINLY TO HAVE THESE INDIVIDUALS BE AT A KNOWN LOCATION. OTHERS THAT ARE. YOU KNOW. ABOUT TO MAYBE -- ALL READY TO HAVE THE ADVICE OR INFORMATION, BE A CONNECTION, BE A RESOURCE FOR THEM. WE NEED TO GET AN UPDATE ON HOW THE PROGRAM IS GOING. WE'RE ABOUT HALFWAY THROUGH WHAT WAS PLANNED TO BE THE PILOT FACE OF THIS. >> GOOD. SOUNDS GOOD. CAN WE TALK A LITTLE BIT ABOUT WHAT -- THE LIBRARY'S **RESPONSIBILITY, YOUR DEPARTMENT** WILL BE IN THE CORNER BRANCH LIKE MOVING FORWARD -- I KNOW IT'S PUBLIC FACILITIES. WHAT WOULD THE VISION BE? WE HAVE AN OPPORTUNITY THERE. I'M SO EXCITED FOR -- WE'RE ABLE TO TIE THE STRAND IN. CAN YOU TALK ABOUT THAT, DAVID? WHAT YOUR VISION MAY BE IF -->> SO WE -- I MEAN, THE EXISTING CORNER BRANCH HAS NEEDED A NEW HOME FOR QUITE SOME TIME. IT DOESN'T MEET THE ACCESS ABILITY STANDARDS OR EVEN BASIC STANDARDS FOR GOOD LIBRARY SERVICE TODAY. ALTHOUGH THE STAFF THERE DO AN **INCREDIBLE JOB AND THE LOCATION** IS WELL-LOVED BY THE COMMUNITY. NONE OF THAT IS IN DISPUTE. SO THE OPPORTUNITY TO BE PART OF MORE OF A NEIGHBORHOOD **REIMAGINING PROCESS HAS BEEN** INCREDIBLE. WE'VE BEEN PRESENT THROUGHOUT

THE 2030 PLANNING PROCESS AND THE WORKING ADVISORY GROUP, THAT PROCESS IS BEING LEAD BY JOHN BARROS. I THINK ONE OF THE KEY DELIVERABLES OF THAT PROCESS IS TO THINK OF THIS REDEVELOPMENT OR THIS REIMAGINATION AS ANCHORING A NEW ARTS AND CULTURE DISTRICT. WE'RE JOINED IN THE AUDIENCE BY THE CHIEF OF ARTS AND CULTURE. THIS PROVIDES US AN OPPORTUNITY TO HAVE OUR TWO AREAS TO COLLABORATE ON THE GROUND AS A TRUE PIECE AND EQUALLY AS A KEY ANCHOR PIECE FROM A PHYSICS AND CULTURAL POINT OF VIEW. WE THOUGHT OF HAVING THE LIBRARY, YOU KNOW, AS IN THAT CASE, ITS SPECIAL CHARACTERISTIC, HAVE SOMETHING TO DO WITH THE ARTS AND CULTURE SECTOR. AND AS WE SEE THE NEW R.P. PROCESS GO FORWARD, WE ENGAGE WITH WHAT WILL BE AN ABBREVIATED PROGRAMMING STUDY. MORE OF A PROGRAMMING UPDATE TO DEFINE WHAT THOSE NEEDS WILL BE. YOU KNOW, THERE'S A COUPLE OF DIFFERENT SITES THAT ARE POSSIBLE FOR WHERE THE LIBRARY WILL BE. WE CAN PUT IT ALL TOGETHER WITH WHAT -->> DO WE HAVE A SENSE OF WHAT WE'RE LOOKING FOR AND WHAT YOU'RE LOOKING FOR IN SOUARE FOOTAGE UP THERE? >> WE DO. I CAN GET BACK TO YOU ON WHAT THE ACTUAL DOCUMENT CALLS FOR. >> SO THE BANK OF AMERICA **BUILDING IS NOT BIG ENOUGH?** >> NOT AS IS. >> YEAH. MAYBE THERE'S AN OPPORTUNITY TO AUGMENT THAT FACADE OR THAT **BUILDING AND HAVE THAT --**>> THAT'S ONE OF TWO OR THREE POSSIBLE LOCATIONS IN THE OVERALL DEVELOPMENT THAT WOULD WORK FOR OUR LIBRARY.

>> FABULOUS OPPORTUNITY FOR US IN BOSTON. AND I LOOK FORWARD TO IT. WITH YOU TALK ABOUT THE CIVIC **ENGAGEMENTS AREA?** WHAT IS IT? WHO IS COMING? >> SO WE'RE JUST REACHING THE END OF THE SECOND YEAR OF THIS PROGRAM. AND THE -- ONE OF MY PERSONAL HIGHLIGHTS WAS JUST THE ABILITY TO INTERVIEW DAVID HOGG, ONE OF THE PARKLAND SURVIVORS. WE'LL BE DOING ONE IN THE SUMMER, WHICH IS A NEW BOOK ON CHASING THE MOON, WHICH TALKS ABOUT THE APOLLO STORY. A STRONG PIECE OF THAT THAT TALKS ABOUT WHAT WAS HAPPENING ON THE CIVIL RIGHTS FRONT DURING THAT PERIOD OF AMERICAN HISTORY. THESE ARE TWO ENTIRELY DIFFERENT TOPICS BUT ARE ENGAGING IN ONE CASE GUN CONTROL ADVOCACY AND IN THE OTHER CASE THE CIVIL RIGHTS **ISSUES AND THE CONTEXT OF GOING** TO THE MOON. >> WILL YOU MAKE SURE THAT WE HAVE COMMUNICATION ON THAT SERIES? I'D LIKE TO SIT IN ON THAT. WILL YOU TALK ABOUT THE GALA? >> GALA. >> WHATEVER WAY YOU SAY IT. >> CERTAINLY. THE UPDATE -- SO THE PUBLIC RPF SPEAKS UP TO 20,000 SQUARE FEET AS BEING DEDICATED. WE DON'T KNOW WHAT IS SHARED SPACE VERSUS DEDICATED SPACE **VERSUS -- WE HAVE TO BE CAUTIOUS** OF THAT. WE THINK THAT SOMEWHERE IN THE 12,000 TO 15,000 SQUARE FOOT RANGE IS WHERE THE SWEET SPOT OF A TYPICAL BRANCH LIBRARY COULD BE. WE HAVE LOCATIONS FROM 1,500 SQUARE FEET RIGHT NOW IN CHINATOWN TO DUDLEY, WHICH IS 27,000 SQUARE FEET. GOING BACK TO THE GALA. SO WE'VE SPENT THE LAST TWO

YEARS EFFECTIVELY STRATEGIZING, PLANNING A RELAUNCH OF OUR PRIVATE FUND-RAISING EFFORTS. THE FOUNDATION WENT ON HIATUS TWO YEARS AGO SO THAT WE COULD WORK OUT WHAT THE NEW STRATEGY WOULD BE WORKING WITH OUR AFFILIATE PARTNERS. WE'LL RELAUNCH AS THE FUNDS FOR THE BOSTON LIBRARY COMES IN THE COMING WEEKS. THE NEW EXECUTIVE DIRECTOR IS ON BOARD AND HAS STARTED. THE SIGNATURE TO LAUNCH THIS ASIDE FROM A PRECEDENT THAT WE'LL DO BETWEEN NOW AND THEN SO ON JUNE 7, FRIDAY JUNE 7, WILL BE THE LIBRARY'S INAUGURAL AGAIN LA. I GUESS WE SHOULD WORK OUT BY JUNE 7 WHAT THE RIGHT PRONUNCIATION SHOULD BE. >> AND THE FUNDING GOES FOR **OPERATION**? >> YES. THE GOAL IS AFTER THE COSTS ARE PAID FOR THAT THOSE FUNDS WILL BE AVAILABLE TO THE BOSTON PUBLIC LIBRARY FOR THE ENHANCEMENT OF SERVICES. YOU KNOW, WE DO AN AMAZING JOB WITH THE RESOURCES FROM THE CITY OF BOSTON AND HOPEFULLY YOU'LL APPROVE THE MAYOR'S PROPOSED BUDGET FOR FY-20. WE DO HAVE STATE ALLOCATIONS THAT WE TRY HARD TO ENSURE STAY IN PLACE YEAR OVER YEAR. ALL OF THAT TOOK HITS IN 2001 AND 2009. THE PRIVATE FUND-RAISING HAS NOT IN THE RECENT DECAYED BEEN WHERE IT CAN BE. WE'RE ON THE VERGE OF HAVING A STRONG, HIGH-LEVEL FUND-RAISING PLAN THAT WILL BRING ADDITIONAL FUNDS TO THE TABLE. FROM INDIVIDUALS. FROM CORPORATIONS, PEOPLE OF WEALTH. THE LEADERS IN THE PHILANTHROPIC COMMUNITY HAVE BEEN VERY ENCOURAGING OVER THE COST OF THE LAST YEAR. WE'LL HAVE SOME ANNOUNCEMENTS ON THAT FRONT IN COMING WEEKS AS WELL. WE BELIEVE WE'RE REALLY STRONGLY SET UP FOR SUCCESS. AND WE'LL BE MANAGING THROUGH ELLEN'S TEAM AND HER GREAT WORK AROUND ENSURING THAT THOSE DOLLARS, ONCE THEY COME THROUGH THE FUND, ENHANCE WHERE THE MOST URGENT AREAS OF NEED ARE, WHETHER THAT IS IN STAFFING OR PROGRAMMING. SO WE'RE REALLY EXCITED ABOUT WHAT THE FUTURE HOLDS ON THAT FRONT. >> THANK YOU. >> THANK YOU. I JUST WANTED TO -->> COULD I ADD THAT WHILE THAT'S THE HIGHER LEVEL FUND-RAISING, THAT IN NO WAY DIMINISHES THE SMALLER GROUPS DO AT THE GRASS ROOTS LEVEL. OUR VISION IS TO HAVE GREATER COORDINATION AMONG ALL OF THE FUND-RAISING EFFORTS THAT ARE GOING ON. >> THANK YOU. JUST WANTED TO TALK A LITTLE BIT ABOUT EXTERNAL FUNDING. LOOKING BACK TO FY-17. WE'RE BACK WHERE WE WERE. WE HAD FLUCTUATIONS DOWNWARDS IN 18 AND 19, BACK UP TO WHERE 17 LEVELS WERE. I WANT TO KNOW ABOUT THE STATE AID AND WHERE THE FUNDS ARE COMING FROM AND IF YOU CAN PROVIDE US AT ANOTHER TIME THE **HISTORICAL GOING BACK TO FY-18** AND THE CURRENT SOURCES OF THE **EXTERNAL FUNDS**? >> SURE. QUICKLY ON WHERE WE ARE FOR NEXT YEAR, IF YOU LOOK INTO FY-17, WORE A LITTLE OVER 9 MILLION. PROJECTING WE'LL BE AT THE SAME IN 20. FY-17 WAS COMING OFF INVENTORIES AND THE MOLD OUTBREAK. IN 18 AND 19 WITHOUT THE FUND IN PLACE, WE HAD PUSHED SOME OUR SALARY COSTS TO THE CITY. THE CITY ALLOWED TO US DO THAT.

OUR SPENDING WILL GO UP BECAUSE THE FUND IS COMING BACK ON AND WE'VE SET ASIDE -- WE DIDN'T HAVE A CHIEF TECHNOLOGY OFFICER. WE USED ENTERPRISE FUNDS FOR A LOT OF I.T. COSTS. WE PUT THE FUNDS ASIDE. NOW HE'S COMING ON, WE HAVE MONEY FOR HIM TO SPEND. WE ASSUME THAT WILL HAPPEN. AS YOU KNOW, THE CITY BUDGET DOESN'T INCLUDE FINDS TO REPLACE FUTURE. WE'VE TRIED TO STOCKPILE MONEY FROM ENTERPRISE AND PUT \$100.000 AWAY TO REPLACE FURNITURE. THAT'S THE THREE BIG THINGS WE EXPECT. >> WITH RESPECT TO STATE FUNDING THE LAST TWO TO THREE YEARS, WE'VE SEEN MODEST INCREASES. AGAIN, THAT IS NOWHERE NEAR THE LEVEL THAT IT WAS SEVERAL YEARS AGO. THE BOSTON PUBLIC LIBRARY DOES SERVE AS A LIBRARY FOR THE COMMONWEALTH. THE PARTICULAR PROGRAM UNDER THAT FUNDING IS TO ASSIST LIBRARIES AND CULTURAL INSTITUTIONS THROUGHOUT THE STATE WITH BRINGING THEIR COLLECTIONS ONLINE. WE DO SUPPORT THE PORTAL THAT PROVIDES ACCESS. DIGITALCOMMONWEALTH.ORG. THE TRAJECTORY THE STATE IS ON FOR THIS COMING YEAR DOES SUGGEST THERE COULD BE MORE THAN A SLIGHTLY MODEST INCREASE IN THAT FUNDING IN THE UPCOMING YEAR. WE'RE NOT DONE THERE YET. >> WE'RE AT ABOUT \$3 MILLION OF STATE FUNDING. LOOK BACK IN THE EARLY 2000s, IT WAS OVER \$10 MILLION. >> WOW. DOESN'T SURPRISE ME. SO THERE WAS OTHER -- WAS IT LIBRARY OF LAST RECOURSE? >> YEAH. MICHAEL CAN TALK TO THAT. THAT BECAME THE LIBRARY FOR THE

COMMONWEALTH AS WE MOVE MORE INTO THE DIGITAL AGE. >> GOT YOU. SO AGAIN. YOU WERE CITING WHAT NUMBERS? ABOUT 2010 OR -->> THE STATE AID? THE STATE FUND SOMETHING BACK IN THE EARLY 2000s IS WHEN IT STARTED GOING DOWN. NOW WE'RE AT 3 MILLION. >> 3 MILLION. WENT THROUGH THE TOUGH TIMES AROUND FY-10 AND 11, 9, 10 AND 11. >> THE HIGH LEVELS WERE BACK IN THE EARLY 2000s AND NEVER RECOUPED THAT. >> A FEW OF US WERE HERE DURING THOSE HORRIBLE YEARS WHEN WE WERE CUTTING STAFF, CUTTING --ALMOST ATTEMPTED TO CLOSE LIBRARIES. NOW WE'RE BACK. BUT IT'S NOT -- HATE TO SAY THIS, BUT IT'S NOT BECAUSE OF ANY LARGESSE FROM THE STATE. IT'S RESOURCES. >> AND I'D SAY THE ENTERPRISE MONEY, TOO. THE PRIVATE EVENT HAS BEEN A FAIRLY ROBUST -->> YEAH. IF YOU CAN SEND ME ONE LINE WITH THE HISTORICAL. I GUESS THERE'S COMMONWEALTH AID AND STATE AIDE TO LIBRARIES. ARE THEY UNDER DIFFERENT NAMES? YOU CAN DO A NET STATE AID STATEMENT, THAT WOULD BE HELPFUL. THANK YOU. COUNCILLOR ESSAIBI-GEORGE? >> COUNCILLOR FLYNN? >> I'M SORRY. THANK YOU. JUST TWO POINTS MAYBE. I KNOW WE MENTIONED THE OUT REACH ON ELL AND DISABILITIES. I THINK ABOUT IN MY DISTRICT IN SOUTH BOSTON, IF YOU'RE LIVING AT OLD COLONY HOMES AND THE BAKER DIRECT, WHAT TYPE OF OUTREACH ARE YOU DOING TO **REPS -- RESIDENTS IN BHA.**

MIGHT BE GEOGRAPHIC LOCATION TO THE LIBRARY. MIGHT BE DIFFICULT FOR PEOPLE TO GET THERE, PUBLIC TRANSPORTATION-WISE. IF THAT'S THE CASE. ARE YOU BRINGING SERVICES TO THEM AND **THEIR RESIDENTS?** >> EACH BRANCH IS TARGETED ON TASKED -- MICHAEL CAN TALK TO THIS -- WE ALSO HAVE THE MOBILE UNIT THAT TRAVELS TO LOCATIONS ACROSS THE CITY. WHICH I BELIEVE WE'RE ABOUT TO ADD A SECOND ONE. >> YEAH, WE'VE REALLY BEEN TAKING OUTREACH MORE SERIOUSLY. OUR YOUTH SERVICES HAVE ALWAYS DONE A REALLY GOOD JOB WITH THAT, BETWEEN SCHOOLS, THEY WORK WITH THE DEPARTMENT OF YOUTH SERVICES FOR INCARCERATED TEENS. WITH THE ADDITION OF THE HEALTH AND HUMAN SERVICES SPECIALISTS. WE'VE FOCUSED ON HOMELESS SHELTERS AND OTHER AREAS WHERE WE CAN PROVIDE SERVICES IN OTHER LOCATIONS. SO MAKING NOTE OF THE VHAs AND THINGS LIKE THAT, I'LL MAKE SURE THAT IS ON THE LIST OF AREAS WE'RE LOOKING AT. AS DAVID MENTIONED, WE'RE ASKING FOR A LIST OF THE ORGANIZATIONS THAT THEY'RE DOING OUTREACH TO TO HAVE A COMPREHENSIVE IDEA. >> AND THE DEVELOPMENT IN BHA. HAS UNITY DAY. THE SUMMERTIME. IT'S A COOKOUT. PEOPLE COME TOGETHER. NONPROFITS, SOCIAL SERVICES. COULD THE LIBRARY SYSTEM BE PART OF THAT AS WELL? >> YES. >> AND IF YOU WANT TO TOUCH BASE WITH BILL. AND I JUST WANT TO -- I HAD AN **OPPORTUNITY -- WE'RE GETTING** EXCELLENT HELP FROM KIM JANEY. WE SHARED THE DISTRICT. AARON, JOHN SANTIAGO, FRANK BAKER AS WELL AS THE AT LARGE COUNCIL. NOT ONLY IS IT THE CITY

OFFICIALS BUT LATE AND LEGISLATIVE AS WELL. I WANTED TO PASS THAT ALONG. THANK YOU. >> COUNCILLOR ESSAIBI-GEORGE. >> NOW IT'S MY TURN. THANK YOU. SO I RECEIVED A QUESTION FROM A CONSTITUENT IN PREPARATION FOR TODAY'S HEARING. IT WAS ABOUT THE ENTERPRISE FUND. CAN YOU TALK ABOUT WHAT THAT IS? WHAT -- WHERE THAT MONEY COMES FROM AND WHAT IT'S USED FOR. >> THE ENTERPRISE MONEY IS FOR PRIVATE EVENTS AT CENTRAL LIBRARY. WE BRING IN A LITTLE OVER \$2 MILLION RECENTLY AND WE PAY ALL THE ASSOCIATED COSTS OUT OF IT. IT INCLUDES A FOUR-PERSON STAFF, **INCLUDES OVERTIME FOR** CUSTODIANS, SECURITY, WE HAVE TO HAVE HVAC PEOPLE ON SITE IN CASE SOMETHING HAPPENS. AFTER THAT, THE MONIES CONTINUE IN TO OUR COFFERS. WE USE THEM FOR COLLECTIONS **BUDGETS, FOR ADDITIONAL MONEY** FOR COLLECTIONS. WE USE IT FOR I.T. SPENDING. A WHOLE HOST OF ITEMS ACROSS THE LIBRARY. AS I MENTIONED, WE'RE PUTTING MONEY ASIDE TO HELP REPLACE FURNITURE THAT COMES FROM THE ENTERPRISE FUND. SO RIGHT NOW IT'S THE MAJOR SOURCE ASIDE FROM CITY BUDGET FOR DISCRETIONARY PURCHASES. >> AGAIN. WHICH FALLS UNDER THE PURVIEW OF THE BOARD OF TRUSTEES FROM A BUDGETING AND APPROVAL PROCESS. >> AND THIS FUND GOES THROUGH THE BOARD? >> YES. >> BASED ON MY QUESTIONS FROM EARLIER, THE EARLIER ROUND, I WANT TO THANK YOU FOR ALL THE WORK THAT YOU DO AND YOUR STAFF ACROSS THE ENTIRE SYSTEM DO. BECAUSE IT IS MORE THAN JUST THE

BOOKS ON THE SHELVES. THE WEALTH HAS CHANGED IN HOW WE'RE GETTING INFORMATION, SO THE TECHNOLOGY, THE AUDIO BOOKS, THE WAY THAT LIBRARY STAFF INTERACTS WITH ITS GUESTS AND ALSO SOME OF THE SOCIAL ISSUE THAT'S YOUR LIBRARY STAFF IS **RESPONDING TO AND RESPONSIBLE** FOR IN SO MANY WAYS. I WANT TO THANK THEM THROUGH YOU. THE SYSTEM REALLY HAS HAD TO CHANGE AND ADAPTED AND BEEN VERY PROFESSIONAL. IT'S MODIFYING THE WAY THAT THEY DELIVER THEIR SERVICES TO RESIDENTS. THANK YOU. >> THANK YOU, CHAIR. >> THANK YOU. >> ANYTHING ELSE? AT THIS POINT DAVID, DID YOU WANT TO TESTIFY? >> THANK YOU, MR. CHAIRMAN. I'M DAVID FROM HYDE PARK. I'D LIKE TO THANK THE LIBRARY STAFF FOR EVERYTHING THAT THEY DO. I KNOW THAT THERE'S BEEN A LOT OF DISCUSSION ABOUT THE BRANCH PROJECTS THAT ARE GOING ON RIGHT NOW. THEY HAVE A LOT OF BALLS IN THE AIR. I'M NOT QUITE SURE HOW THEY DO IT ALL. BUT I WILL SAY THEY ARE DOING A GREAT JOB. I KNOW I'VE ADDRESSED WHAT I'M ABOUT TO SAY BEFORE. I CONTINUE TO BE CONCERNED ABOUT THE COMMERCIALIZATION OF THE CENTRAL LIBRARY. WHEN WE STARTED THIS PROJECT A FEW YEARS AGO, I WAS ALL IN FAVOR OF RENTING OUT SPACES FOR EVENTS. WEDDINGS. ET CETERA FOR AFTER HOURS. THEN WE INITIATED A CAFE, WHICH GREW INTO A RESTAURANT, WHICH IS NOW GROWN INTO ANOTHER CAFE. THE GBH RADIO STUDIO, WHICH IS A GREAT IDEA AND NOW WE EXPANDED

OUT TO THE SIDEWALK ON THE STREET SIDE AND SERVING BEER AND WINE. I THINK WHEN THIS STARTED. I COMMENTED TO THIS COMMITTEE WHEN THESE PROPOSALS WERE BEING OFFERED THAT PERHAPS WE MIGHT BUILD A LAP POOL IN THE HALL AND SERVE DRINKS THERE, TOO. I SEE THE NEED FOR ADDITIONAL **REVENUE, BUT THE EXPANDING** COMMERCIAL FOOTPRINT IN OUR FLAGSHIP LIBRARY CONTINUES TO BE VERY DISTURBING. BACK IN 1848 WHEN OUR LIBRARY WAS FOUNDED. THE STATE AND THE CITY MADE A CONTRACT WITH THE PEOPLE OF BOSTON TO HAVE A PUBLICLY-FUNDED MUNICIPAL LIBRARY. I KNOW WE'RE IN A DIFFERENT AGE NOW. I KNOW THAT WE ARE IN A DIFFERENT FINANCIAL CLIMATE. BUT I ASK YOU TO CONTINUE TO LOOK AT THE FOOTPRINT IN OUR LIBRARY, ESPECIALLY NOW THAT YOU ARE DISCUSSING MIXED USE IN OUR BRANCHES, TOO. THERE'S GOT TO BE A LINE DRAWN SOMEWHERE. SO FAR ALL I'VE SEEN IS EXPANSION OF COMMERCIAL USE OF OUR LIBRARY. IT CONTINUES TO DISTURB ME. THANK YOU. >> THANK YOU. I WANT TO THANK YOU, YOUR TEAM, ALL THE FOLKS IN THE FIELD WHO DO SUCH INCREDIBLE WORK EVERY DAY SERVICING OUR CONSTITUENTS IN THE NEIGHBORHOOD. I WANT TO -- I LOOK FORWARD TO WEDNESDAY'S MEETING WHEN THE TRUSTEES I BELIEVE WILL VOTE ON THE POTENTIAL COMMUNITY ROOM AT THE HALSTON LIBRARY. I WANT TO THANK MY COLLEAGUES THAT SUPPORTED THAT RESOLUTION ON MY END, ON THE COUNCIL END AND I BELIEVE THE MAYOR WROTE A LETTER OF SUPPORT. SHE'S GOING TO BE 90 IN SEPTEMBER.

I THINK AMEN KNOWS THAT WHEN YOU TALK ABOUT FRIENDS OF THE LIBRARY, SHE'S THE ICON OF FRIENDS OF THE LIBRARY. SHE'S BEEN DOING IT FOR DECADE. IT IS HER LOVE AND PASSION. I WANT TO THANK AMEN FOR COMING OUT TO THE LIBRARY AND WALKING THE GROUNDS WITH US AND TAKING CARE OF THOSE ISSUES. RATHER SLOWLY. I KNOW IT'S NOT YOUR FAULT. THERE'S A LOT OF PEOPLE OUT THERE. I WHAT TO SAY HOW GRATEFUL I AM. IT'S BEEN TUMULTUOUS SOMETIMES. WE'VE ALMOST LOST SOME BRANCHES. I WANT TO THANK YOU FOR KEEPING THINGS ON TRACK. >> FOR THE RECORD, THAT MEETING OF THE TRUSTEES IS TOMORROW. >> OKAY.GREAT. LOOK FORWARD TO IT. THANK YOU. >> AND HOPEFULLY WE'LL ALL BE THERE FOR THE UNVEILING OR WHATEVER THE CEREMONY WILL BE. >> THANK YOU. >> THIS HEARING IS ADJOURNED.
