COMPENSATION AND OTHER COST **ITEMS INCLUDE THE STANDARD 2%** WAGE INCREASE EFFECTIVE IN JULY OF EACH YEAR OF THE CONTRACT, HAZARDOUS DUTY DIFFERENTIAL INCREASES OF 1% IN 2018, 2019 AND 2020. LONGEVITY PAYMENT INCREASES, CLASSIFICATION INCREASES FOR CERTAIN SUPERVISORS AND INCREASING THE NUMBER OF PERSONAL DAYS FROM 1 TO 2 PER YEAR AND ESTABLISHMENT OF PAID PARENTAL LEAVE CONSISTENT WITH THE COUNSEL'S 2014 ORDINANCE. THE WAGE INCREASE PATTERN, COMPENSATION AND

LANGUAGE ITEMS ARE CONSISTENT WITH PREVIOUSLY APPROVED AGREEMENTS. OTHER COST ITEMS AND POLICY MODIFICATIONS MEANT TO INCREASE THE DEPARTMENT FISH SENT AND ACCESS ABILITY. >> ANY OBJECTIONS? >> PROBLEM. MADAM CLERK, IF YOU COULD ADD COUNCILLOR ESSAIBI-GEORGE. THANK YOU. COUNCILLOR O'MALLEY? >> THANK YOU. I RISE TODAY TO BRING OUR ATTENTION TO AN EPIDEMIC SWEEPING OUR SCHOOLS. **BOSTON HAS SEC -- SUCCESSFULLY REDUCED NICOTINE ADDICTION.** AS CHAIR OF THE COMMITTEE OF HEALTHY WOMEN AND FAMILY COMMUNITIES, I'M PROUD THE PUBLIC COMMISSION HAS DONE TO HELP OUR RESIDENTS QUIT SMOKING. OUR NICOTINE PATCH GIVE AWAY, THE HELPLINE, WORKING WITH BHA TO OFFER SUPPORT AND SMOKING CESSATION PRODUCTS AND TECHNIQUES. I'M A FORMER SMOKER. I KNOW HOW DIFFICULT IT IS TO OUIT. I KNOW E CIGARETTES HAVE SPREAD AMONG YOUNG PEOPLE FAST OR THAN OUR CULTURE AND GOVERNMENT CAN ADAPT. E CIGARETTES ADVERTISED BY COMPANIES LIKE JUUL CAN A WAY TO **REPLACE THE HABIT WITH LESS** DANGEROUS VAPING HAS TURNED THE EFFORTS ON ITS HEAD. OVERNIGHT. JUULING IS A WIDESPREAD ADDICTION. ONE IN FIVE STUDENTS ARE USING **E-CIGARETTES.** THE NUMBER OF MIDDLE SCHOOLERS TRYING IS IT GROWING AT AN ALARMING RATE. 8% OF HIGH SCHOOL SENIORS HAVE TRIED IT ONCE. 3% OF ADULTS USE THESE E CIGARETTES AND SHOWS IT MORE POPULAR FOR HIGH SCHOOLERS THAT WANT TO VAPE THAN THOSE THAT WANT TO OUIT SMOKING. THE NUMBER DOUBLED LAST YEAR. THE LARGEST ONE-YEAR INCREASE FOR YOUTH ADDICTIVE SUBSTANCES IN OVER FOUR DECADES. E SUBSTANCES ARE MORE DANGEROUS THAN MANY OF OUR YOUNG PEOPLE

REALIZE. VAPING MIGHT BE SAFER THAN SMOKING CIGARETTES BUT STILL HAS MANY OF THE NEGATIVE EFFECTS OF NECK TEEN INCLUDING THE HEART, BRAIN AND LUNGS. THIS IS AN EPIDEMIC AMONG OUR YOUTH. ASK ANY HIGH SCHOOLER, TEACHER, PARENTS, ANY PERSON THAT HAS SEEN THESE ALARMING AND GROWING TRENDS. THROUGH MONUMENTAL EFFORT TARGETED BY THE BIG TOBACCO COMPANIES. GOVERNMENT MADE SMOKING UNCOOL AND STOPPED A NEW GENERATION. BUT JUUL THE NEW COOL. **IT'S NOW A DIFFERENT PRODUCTS** WITH DIFFERENT CULTURAL ASSOCIATIONS AND DELIVERING THE SAME AMOUNT OF NICOTINE. SO WHAT WE CAN DO ABOUT IT? WELL. AS THE FDA IS WORKING TO EVALUATE E CIGARETTE EFFECT EFFECTS BY 2021, THEY HAVE CRACKED DOWN ON SOME UNDERAGED SALES OF CANDY FLAVORED E-CIGARETTES THAT ARE POPULAR AMONG TEENS SO MANY HIGH SCHOOL STUDENTS ARE ADDICTED AND WE NEED FURTHER ACTION. HALF OF UNDERAGE USERS USE THE FLAVORS THAT STILL REMAIN LEGAL ON THE FDA'S CRACKDOWN. ONLINE SALES HAVE INCREASED DRAMATICALLY. WHILE WE HAVE SEEN SOME EFFORTS AMONG SELLING THESE IN CORNER STORES, WE'RE SEEING ROBUST NUMBER IN ONLINE SALES. ITS SAFE TO SAY THE POPULARITY OF E CIGARETTES IS A PUBLIC HEALTH CRISIS AND WE NEED TO TAKE ACTION. MANY FLAVORS HAVE BEEN BANNED THAT ARE ATTRACTIVE TO UNDERAGE USERS. THERE'S PLAY INVESTORS LIKE MANGO, FRUIT OR CREAM FLAVORED. ONE IMPORTANT STEP TO CONSIDER, ENFORCING AN AGE RESTRICTION ON NICOTINE IS NOT FOOL PROOF WHEN HIGH SCHOOLERS ARE ALREADY

ADDICTED AND WILL FIND OTHER WAYS TO PROCURE THE PRODUCT IF IT'S AVAILABLE IN STORES. SOME MUNICIPALITIES ARE CONSIDERING A BAN UNTIL THE FDA EVALUATING THEIR PUBLIC IMPACTS. WE SHOULD LOOK AT A VARIETY OF PRODUCTS. IT'S HARMING OUR YOUNG PEOPLE. THIS EMPHASISES THE IMPORTANCE

THIS EMPHASISES THE IMPORTANCE OF SOCIAL AND EMOTIONAL SUPPORT IN OUR SCHOOLS.

EVERY YOUNG PERSON SHOULD HAVE SOMEONE TO TALK TO IF THEY WANT TO QUIT AS WELL AS THE SUPPORTS TO BECOME AN EX-VAPOR OR JUULOR. I ASK FOR YOUR SUPPORT TO GATHER DATA AND CONSIDER WHAT FURTHER STEPS WE CAN TAKE.

IT'S VIABLE THAT WE DO THIS PRESERVE THE HEALTH OF THE NEXT GENERATION OF THE CITY OF BOSTON.

I'D LIKE TO THANK MY OFFICE WHO PUT TOGETHER THIS IN FAIRLY SHORT ORDER WITH GREAT RESEARCH. WE HAVE AN OPPORTUNITY AND A DUTY TO GET TO WORK. LET'S MAKE IT HAPPEN. THANK YOU, MADAM PRESIDENT. COUNCILLOR ESSAIBI-GEORGE. >> THANK YOU, MADAM CHAIR. I WANT TO THANK COUNCILLOR O'MALLEY FOR HIS LEADERSHIP AND CALLING ATTENTION TO THE RISING USE OF E CIGARETTES AND VAPES. I'M PROUD TO PARTNER AS A **CO-SPONSOR TO BEGIN A SERIOUS** CONVERSATION ABOUT RESTRICTING ACCESS TOBACCO PRODUCTS MARKETED TO UNDERAGE STUDENTS. MONITORING CIGARETTE USE IS A DAILY STRUGGLE FOR ME AND MY COLLEAGUES WHILE I WAS A TEACHER. BUT NOW IT'S WORSE BECAUSE THESE PRODUCTS ARE HARDER TO HIDE. AS A PARENT OF TEENS, I'M SO

MUCH MORE AWARE OF THE ATTRACTIVENESS OF THESE DEVICES. I'VE SEEN THEM, THEY'RE CUTE, THEY CAN BE DECORATED. COME IN SPARKLY CASES. THEY'RE VERY ATTRACTIVE FOR YOUNG PEOPLE TO NOT JUST WANT TO USE BUT COLLECT AND SHARE. WHAT MAKES THIS PRODUCT A PUBLIC CRISIS IS THESE PRODUCTS HAVE A GREATER CONCENTRATION OF NICOTINE AND ARE MORE ADDICTIVE THAN TRADITIONAL CIGARETTES. THE RISING POPULARITY OF FLAVORED CIGARETTES PROVES THAT THEY'RE TARGETING ADOLESCENT POPULATIONS. AS THE INDUSTRY CONTINUES TO GROW, IT'S IMPORTANT TO MAKE SURE THE PRODUCTS ARE SOLD FOR THEIR STATED PURPOSE, WHICH IS TO HELP ADULTS QUIT THEIR ADDICTIONS TO CIGARETTES. WE NEED TO MAKE SURE THAT WE GET TO THIS WORK QUICKLY. AS I TALKED TO MY TEACHER FRIENDS AND PARENTS, TEENS AND YOUNG TEENS AND OLDER TEENS. COUNCILLOR JANEY, YOU HAVE THE FLOOR. >> THANK YOU. I'D LIKE TO SUSPEND RULE 12 AND ADD YOU AS A ORIGINAL CO-SPONSOR. >> ANY OBJECTION? >> MADAM CLERK, IF YOU COULD ADD ME AS A THIRD CO-SPONSOR. THANK YOU. >> I WANT TO THANK YOU FOR YOUR PARTNERSHIP AND COUNCILLOR O'MALLEY FOR YOUR PARTNERSHIP AND LEADERSHIP, THIS IS A **REFILE, SOMETHING THAT** COUNCILLOR O'MALLEY AND I DID LAST YEAR TO COMBAT THE UPTICK THAT WE SEE WITH SUMMER VIOLENCE IN THE CITY. IT'S IMPORTANT THAT WE GET ON THIS WORK RIGHT AWAY. FIRST, I WANT TO COMMEND MANY OF THE COMMUNITY BASED ORGANIZATIONS AND GROUPS, THE ANTI-VIOLENCE ACTIVISTS, THE PEACE ACTIVISTS AND THE CITY AGENCIES IN BOSTON THAT WORK THE TIRELESSLY TO ENSURE THAT OUR COMMUNITIES ARE SAFE FOR ALL AND MEANINGFUL AND ENGAGING **OPPORTUNITIES FOR OUR YOUNG** PEOPLE. THE EFFORTSES FROM LAST SUMMER **RESULTED IN A DECREASE IN THE** NUMBER OF HOMICIDES COMPARING 2017 TO 18 AND DEFINING SUMMER AS JUNE, JULY AND AUGUST. SO WE SAW A DECREASE OVERALL IN THE CITY OF BOSTON AS WELL AS IN MY OWN DISTRICTS. SO IF WE LOOK AT B-2, WHICH IS IN ROXBURY, THAT COVERS MUCH OF ROXBURY AND THE NUMBER OF HOMICIDES BETWEEN JUNE AND AUGUST FELL FROM 10 TO 5 FOR THAT DIRECT.

CITYWIDE, THEY FELL FROM 22 TO 14. THIS PAST WEEKEND, I JOINED TWO SEPARATE PEACE WALKS. **ON FRIDAY AFTERNOON**, 12th BAPTIST CHURCH RESUMED THEIR PEACE WALKS THROUGHOUT THE COMMUNITY OF ROXBURY JOINED BY MANY POLICE OFFICERS. THIS WAS THE FIRST ONE OF THE SEASON AND THAT WAS WONDERFUL. THAT WAS FRIDAY AFTERNOON. SUN DID IT AGAIN. MANY OF YOU WERE THERE FOR THE PEACE WALK, THE WALK FOR PEACE AT THE LEWIS D. BROWN INSTITUTE. WALKING FROM FIELDS CORNER ALL THE WAY TO CITY HALL. VERY IMPORTANT PEACE WALKS. THEY HELP BUILT TRUST IN THE COMMUNITY, RAISE AWARENESS AROUND THE ISSUES AND CREATE A STRONG SENSE OF COMMUNITY. THOSE ARE IMPORTANT. BETWEEN THE TWO WALKS ON IN THE MIDDLE OF THEM ON THE BEAUTIFUL FIRST NICE DAY OR ONE OF THE FIRST NICE DAYS THAT WE'VE SEEN, THERE UNFORTUNATELY WAS A SHOOTING IN MY OWN NEIGHBORHOOD AND WE KNOW REGARDLESS OF WHETHER THERE'S A FATAL SHOOTING OR NONFATAL SHOOTING, IT'S A TRAUMATIC EVENT FOR PEOPLE THAT EXPERIENCE THIS. WHETHER IT'S THE SOUNDS OF THE GUN SHOTS THEMSELVES OR THE SIRENS OR THE SITE OF POLICE TAPE OR THE LITTLE CONES. WE'VE GOT TO DO BETTER TO MAKE SURE THAT WE ARE ADDRESSING THE ROUTE CAUSE OF VIOLENCE, WHICH FOR ME IS VERY MUCH ROOTED IN TRAUMA. SO AS WE TRY TO DO A BETTER JOB OF CARING FOR OUR WHOLE COMMUNITY, MAKING SURE WE HAVE THE TRAUMA SUPPORT SERVICES THAT ARE NEEDED THAT IS VERY IMPORTANT IF WE'RE GOING TO BREAK THE CYCLE OF VIOLENCE IN OUR COMMUNITY. **BEYOND STRENGTHENING TRAUMA, RESPONSE AND SUPPORT SERVICES,**

WE NEED TO DO MUCH NOR IN TERMS OF THE COMMISSION OPPORTUNITIES FOR PEOPLE IN OUR COMMUNITY AS WELL AS MAKING SURE THAT THEY'RE GETTING THE CASE THAT THEY NEED IN OUR SCHOOLS. OFTENTIMES WE TALK ABOUT VIOLENCE AND SUMMER VIOLENCE BEING A YOUTH ISSUE. WE KNOW THAT MANY OF THE VICTIMS OF VIOLENCE, INCLUDING THOSE THAT MAY BE ALLEGED PERPETRATORS ARE NOT NECESSARILY YOUNG PEOPLE. THESE ARE PEOPLE IN THEIR 30s OR 40s OFTENTIMES. WE HAVE TO MAKE SURE THAT THERE'S SUPPORT AVAILABLE FOR THEM AS WELL. WE KNOW LAST MONTH UNFORTUNATELY, ELEANOR MALONEY WAS SHOT IN MATTAPAN. THERE'S OTHER VICTIMS AS WELL AS LEDGED PERPETRATORS THAT ARE MUCH OLDER THAN THE YOUTH. SO WE NEED TO DO A LOT MORE TO ENSURE THAT OUR YOUNG PEOPLE AS WELL AS OLDER ADULTS ARE GETTING THE SUPPORT AND SERVICES, THAT YEAR BREAKING THE CIRCLE OF VIOLENCE AND WE'RE BEING PROACTIVE ABOUT IT. WE KNOW WE'LL SEE AN UPTICK IN THE SUMMER. FORTUNATELY WE'VE SEEN A DECLINE FROM 17 TO 18 AND WE NEED TO MAKE SURE THAT WE CONTINUE THAT FOR SUMMER 2019. THANK YOU AGAIN FOR YOUR PARTNERSHIP, COUNCILLOR O'MALLEY. I'M HOPING THAT YES CAN HAVE AN EXPEDITED HEARING SO WE CAN BE PROACTIVE AND GETTING STRATEGIES IN PLACE AND WORKING WITH NOT ONLY THE CITY AGENCIES BUT MANY OF THE ACTIVISTS AND ADVOCACY ORGANIZATIONS IN THE COMMUNITY. I JUST WANTED TO NOTE -- I WANTED TO ACKNOWLEDGE THE PASSING OF ANOTHER GIANT IN EAST BOSTON. EVAN MOLASH WAS PART OF A GROUP OF WOMEN THAN PASSED AWAY MOTHER'S DAY. SURROUNDED BY FAMILY. HE WAS NOT ONLY A GIANT BUT A SECOND MOTHER TO A LOT OF THE ACTIVISTS COMING UP IN EAST BOSTON. SHE HELPED DEFINE THE EAST BOSTON TEACHERS AND PARENTS THAT CARE ABOUT EDUCATION. A LIFE-LONG GIRL SCOUT AND TRAINED A GENERATION OF SCOUTS. SHE WAS A FORCE TO BE RECKONED WITH, FIGHTING FOR HER COMMUNITY WHEN WOMEN DIDN'T HAVE A VOICE. WEREN'T ALLOWED TO HAVE A VOICE FOR HER GENERATION. SHE IS SOMEONE THAT IS ONE OF THE FIRST PEOPLE THAT WHEN I RAN

IN 2016 AND INVITED ME IN HER HOME AND GAVE ME A EDUCATION AND EAST BOSTON AND WHAT SHE'S DONE AND WHAT PEOPLE HAVE DONE TO PRESERVE THE CHARACTER OF THE NEIGHBORHOOD. HE WILL BE HEAVILY MISSED. HER HOUSE IS ON THE CORNER OF PUTNAM STREET. WE WILL ALWAYS CONSIDER THAT EVELYN'S CORNER. SHE LEAVES BEHIND FIVE KIDS WHO ARE ALSO STEWARDS AND PART OF OUR COMMUNITY. I WANTED TO ACKNOWLEDGE HER PASSING. I WENT TO THE WAKE. PEOPLE CAME OUT FROM ALL GENERATIONS. IT'S JUST, AS I MENTIONED BEFORE, THE GREAT OAKS ARE FALLING AND SHE'S ONE THAT WE WILL MISS. >> THANK YOU. COUNCILLOR EDWARDS. ANYONE ELSE HAVE ANY ANNOUNCEMENTS?
