The Boston City Council's Committee on Healthy Women, Families and Communities will hold a public hearing on **Wednesday, August 28, 2019 at 11:15 a.m.** in the Iannella Chamber, Boston City Hall, Fifth Floor.

The subjects of the hearing are:

- 0666 Message and order authorizing the City of Boston to accept and expend the amount of Two Hundred Sixty-Two Thousand Seven Hundred Sixty-Three Dollars (\$262,763.00) in the form of a grant for the 2019 Senior Companion Program, awarded by the Corporation for National and Community Service, to be administered by the Elderly Commission.**
- 0667 Message and order authorizing the City of Boston to accept and expend the amount of One Hundred Thirty Thousand Two Hundred Fifty-Three Dollars (\$130,253.00) in the form of a grant for the Retired Senior Volunteer Program (RSVP), awarded by the Corporation for National and Community Service, to be administered by the Elderly Commission.**
