TO THE CITY COUNCIL

Dear Councilors:

I transmit for your approval a citizen petition entitled “Petition for Renaming Dudley Square to Nubian Square” (the “Petition”) for the placement of a local nonbinding public opinion advisory question on the ballot of the next regular municipal election, which will occur on November 5, 2019. The Petition, which includes the signatures of at least ten registered voters of the City of Boston (the “City”), has been examined by the Board of Election Commissioners and has been deemed sufficient.

Pursuant to G.L.c. 53, §18A, a nonbinding public opinion question may be placed on the ballot for a regular municipal election by vote of the City Council with the approval of the Mayor; a proposal to place such question may be presented to the governing body thereof on a petition signed by at least ten registered voters of the City.
